




### 4.1.3 TEST PROCEDURES

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150kHz to 30MHz was searched. Emission levels under (Limit 20dB) was not recorded.






- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic camber. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

# 4.7.2 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 1MHz with suitable frequency span including 100 MHz bandwidth from band edge. The band edges was measured and recorded.

## 4.7.3 EUT OPERATING CONDITION

The software provided by client to enable the EUT under transmission condition continuously at specific channel frequencies individually.

# 4.7.4 TEST RESULTS

For signals in the restricted bands above and below the 5.15 to 5.35GHz allocated band a measurement was made of the amplitude of the spurious emissions with respect to the intentional signals. The relative amplitude, in dBc, was applied to the average and peak filed strength of the intentional signal made on the OATS to calculate the field strength of the unintentional signals.

The spectrum plots (Peak RBW=VBW=1MHz; Average RBW=1MHz, VBW=10Hz) are attached on the following pages.

Channel 1 (5180MHz)

The band edge emission plot on the page 50 shows 41.38dBc between carrier maximum power and local maximum emission in restrict band. The emission of carrier strength list in the test result of channel 1 is 104.56dBuV/m (Peak), so the maximum field strength in restrict band is 104.56-41.38=63.18dBuV/m which is under 74dBuV/m limit.

The band edge emission plot on the page 50 shows 46.72dBc between carrier maximum power and local maximum emission in restrict band. The emission of carrier strength list in the test result of channel 1 is 94.71dBuV/m (Average), so the maximum field strength in restrict band is 94.71-46.72=47.99dBuV/m which is under 54dBuV/m limit.


#### Channel 8 (5320MHz)

The band edge emission plot on the page 51 shows 45.27dBc between carrier maximum power and local maximum emission in restrict band. The emission of carrier strength list in the test result of channel 8 is 108.03dBuV/m (Peak), so the maximum field strength in restrict band is 108.03-45.27=62.76dBuV/m which is under 74dBuV/m limit.


The band edge emission plot on the page 52 shows 48.78dBc between carrier maximum power and local maximum emission in restrict band. The emission of carrier strength list in the test result of channel 8 is 97.28dBuV/m (Average), so the maximum field strength in restrict band is 97.28-48.78=48.50dBuV/m which is under 54dBuV/m limit.





And according to FCC 47 CFR Section 15.407(a), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.


# 4.8.2 ANTENNA CONNECTED CONSTRUCTION


## CONDUCTED EMISSION TEST
