



The sample was placed 0.8m above the ground plane on the OATS *. Measurements in both horizontal and vertical polarities were performed. 


Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (19.125msec) never exceeds a series of 6 long (1msec) and 10 short (375µsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 6x1msec+10x375µsec per 19.125msec=50.9% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.


