"Q-Hub" Models G819LMB and MYQ-G0303-SP are identical to "A-Hub" Models G821LMB, MYQ-G0301, MYQ-G0301C, MYQ-G0301A, MYQ-G0301-D and MYQ-G0301LA except Models G821LMB and MYQ-G0303-SP do not contain an LED light. Otherwise, they are electrically identical.

There are no other modifications to the host device.
