# 2 Test Configuration of Equipment Under Test

a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: radiation emission (1GHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, the measured emission level of the EUT was maximized by rotating the EUT on a turntable, adjusting the orientation of the EUT and EUT antenna in three orthogonal axis (X: flat, Y: portrait, Z: landscape), and adjusting the measurement antenna orientation, following C63.10 exploratory test procedures and only the worst case emissions were reported in this report.



### 3.1 Maximum Conducted Output Power Measurement

#### 3.1.1 Limit of Maximum Conducted Output Power

For the band 5.725–5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W.


#### 3.1.3 Test Procedures

The testing follows Method PM-G of FCC KDB 789033 D02 General UNII Test Procedures New Rules v02r01.

Method PM-G (Measurement using a gated RF average power meter):

- 1. Measurement is performed using a wideband RF power meter.
- 2. The EUT is configured to transmit at its maximum power control level.
- 3. Measure the average power of the transmitter.
- 4. Since the measurement is made only during the ON time of the transmitter, no duty cycle correction factor is required.

#### 3.2.1 Limit of Unwanted Emissions

(1) For transmitters operating in the 5.725-5.85 GHz band:

15.407(b)(4)(i) All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.

  - RBW = 1 MHz
  - VBW ≥ 3 MHz
  - Detector = Peak

- (2) Procedures for Average Unwanted Emissions Measurements Above 1000 MHz
  - a) RBW = 1 MHz
  - b) VBW  $\geq$  [3 × RBW].
  - c) Detector = RMS (power averaging), if [span / (# of points in sweep)] ≤ RBW / 2. Satisfying this condition can require increasing the number of points in the sweep or reducing the span. If the condition is not satisfied, then the detector mode shall be set to peak.
  - d) Averaging type = power (i.e., rms) (As an alternative, the detector and averaging type may be set for linear voltage averaging. Some instruments require linear display mode to use linear voltage averaging. Log or dB averaging shall not be used.)
  - e) Sweep time = auto.
  - f) Perform a trace average of at least 100 traces if the transmission is continuous. If the transmission is not continuous, then the number of traces shall be increased by a factor of 1 / D, where D is the duty cycle. For example, with 50% duty cycle, at least 200 traces shall be averaged. g) If tests are performed with the EUT transmitting at a duty cycle less than 98%, then a correction factor shall be added to the measurement results prior to comparing with the emission limit, to compute the emission level that would have been measured had the test been performed at 100% duty cycle. The correction factor is computed as follows:


- i. If power averaging (rms) mode was used in the preceding step <u>e)</u>, then the correction factor is [10 log (1 / *D*)], where *D* is the duty cycle. For example, if the transmit duty cycle was 50%, then 3 dB shall be added to the measured emission levels.
- ii. If a specific emission is demonstrated to be continuous (100% duty cycle) rather than turning ON and OFF with the transmit cycle, then no duty cycle correction is required for that emission.
- 2. The EUT is placed on a turntable 1.5 meter for frequency above 1 GHz respectively above ground.
- 3. The EUT is set 3 meters away from the receiving antenna which is mounted on the top of a variable height antenna tower.
- 4. The antenna is a broadband antenna and its height is adjusted between one meter and four meters above ground to find the maximum value of the field strength for both horizontal polarization and vertical polarization of the antenna.
- 5. For each suspected emission, the EUT is arranged to its worst case and then adjust the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading.
- 6. Radiated testing above 1 GHz is performed by adjusting the antenna tower from 1 m to 4 m and by rotating the turn table from 0 degree to 360 degrees to find the peak maximum hold reading for scanning all frequencies.

When there is no suspected emission found and the harmonic emission level is with at least 6 dB margin against average limit line, the position is marked as "-".




