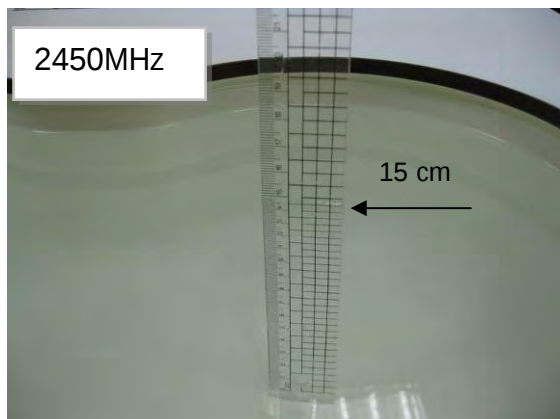

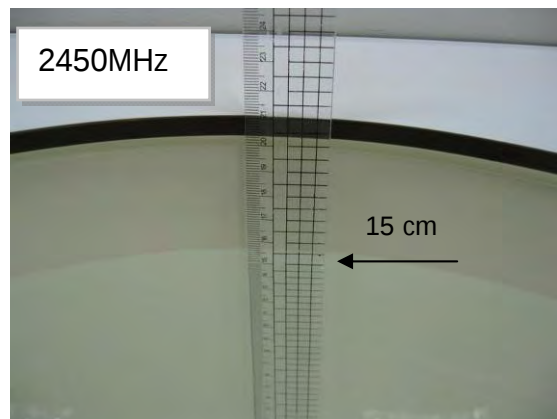

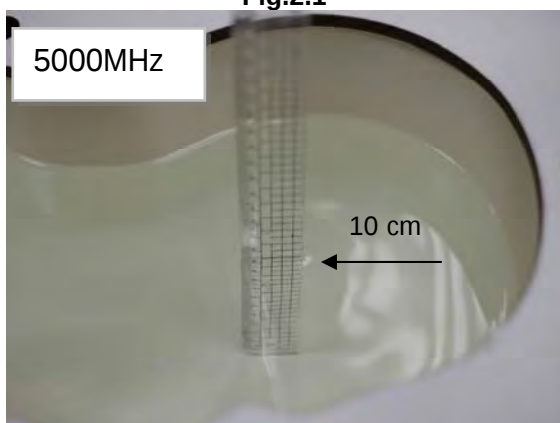

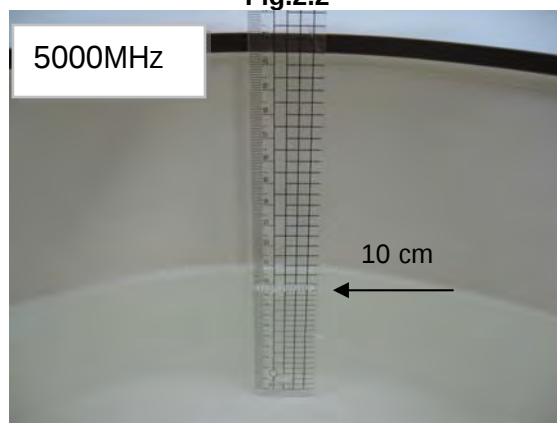

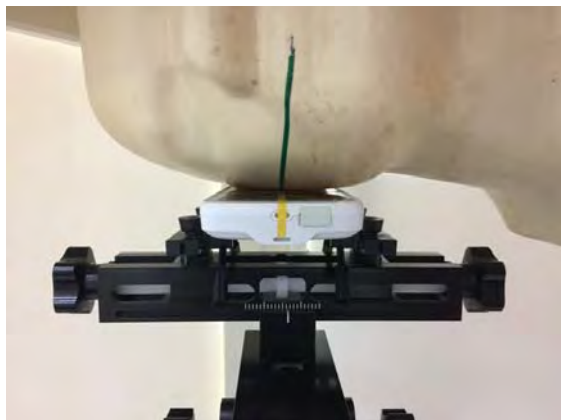


Fig.3 Right Head Section / Cheek-Touch Position

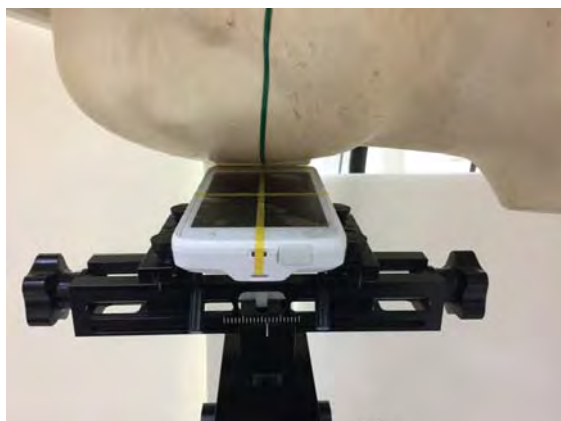
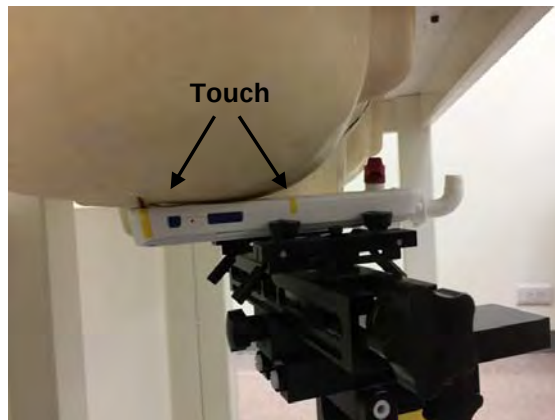
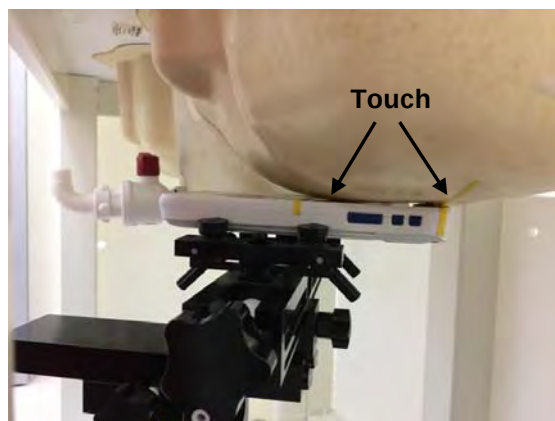


Fig.4 Right Head Section / Ear-Tilt Position(15°)

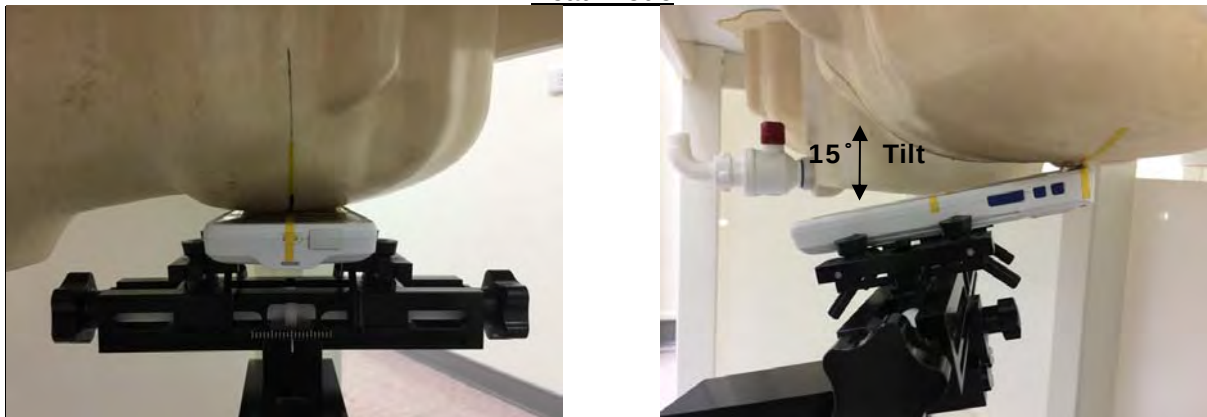

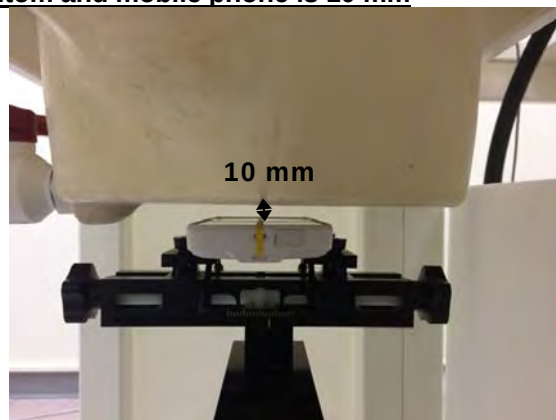


Fig.7 EUT Front side to flat phantom

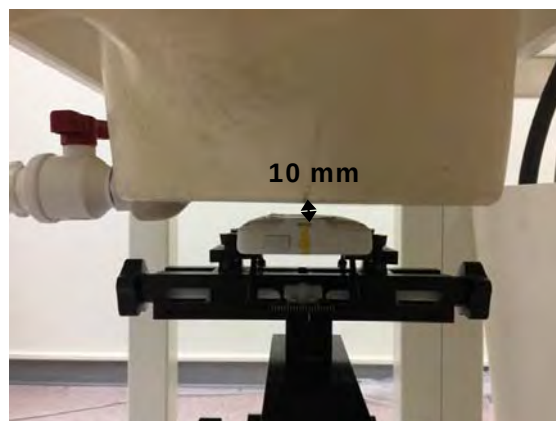


Fig.8 EUT Back side to flat phantom

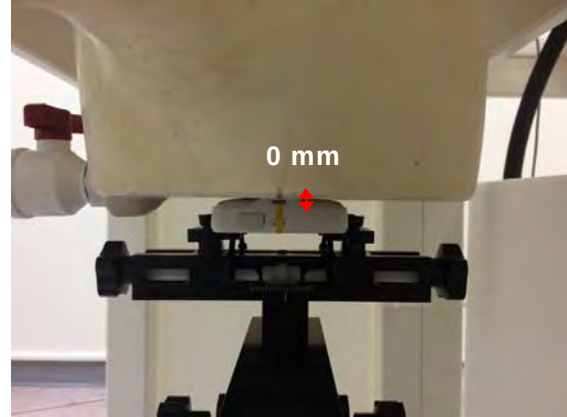


Fig.10 EUT Front side to flat phantom

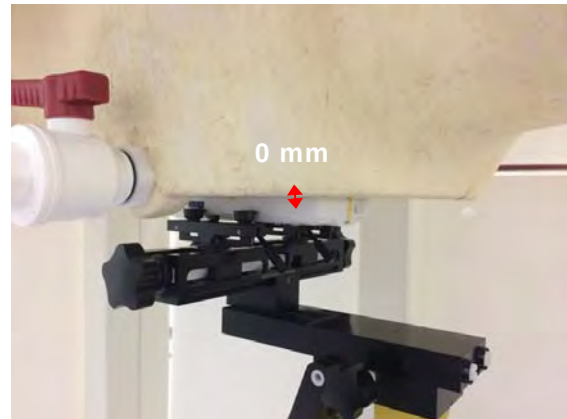
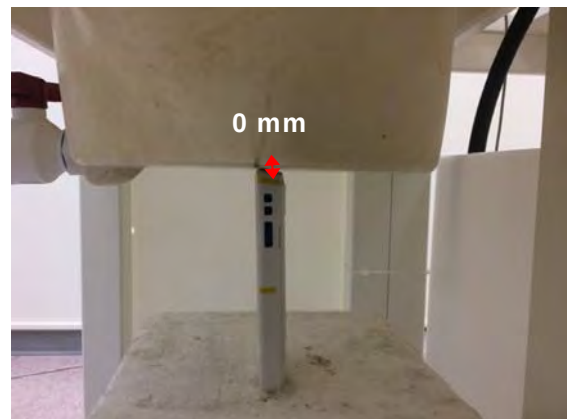


Fig.11 EUT Top side to flat phantom

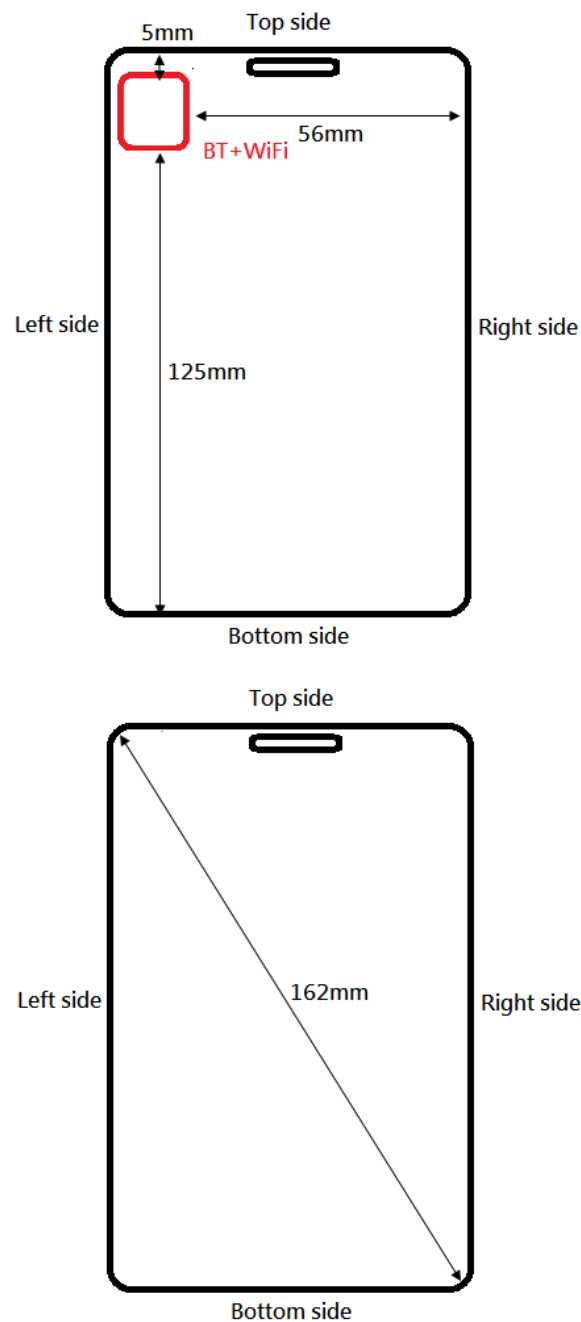


Fig.15 Antenna location and dimensional size
