W649a is a highly integrated Wi-Fi 11ax module that complies with IEEE 802.11ax and backward compatible with IEEE 802.11a/n/ac standard, offering feature-rich wireless connectivity at high standard, and delivering reliable, cost-effective throughput from an extended distance. This module is based on MT7915AN and MT7975AN; six antenna ports are available for flexible use of external antennas for the appliances in consideration.


