

Fig.1 Photograph of the SAR measurement System




Fig.2 Photograph of the Tissue Simulant liquid depth 15cm for Flat position




Fig.4 Front side of the EUT is paralleled with flat phantom, and spacing between EUT and Phantom is 4 mm.




Fig. 10 Left side view of device




Fig.11.Data Cable
