2 RF EXPOSURE

2.1 Standard Applicable:

$\{[\text{Power allowed at numeric threshold for 50 mm in step a)}] + [(\text{test separation distance} - 50 \text{ mm}) \cdot 10]\}$ mW
for > 1500 MHz and ≤ 6 GHz

*f (GHz) is the RF channel transmit frequency in GHz
Power and distance are rounded to the nearest mW and mm before calculation*

2.2 Measurement Result:

Step 1

Measured Values Necessary for Calculations

Bluetooth max power: 11.57dBm = 14.355 mW

Power allowed at numeric threshold for 50 mm in step a is 97 mW, as shown below:

$$\sqrt{f(\text{GHz})} \cdot 2.48 / 3 \cdot 50\text{mm} = 97\text{mW}$$

This value (rounded to the nearest mW for the next calculation) is used in part b (subsection 2)

As shown below to calculate the maximum power allowed:

$$97\text{mW} + [(65\text{mm} - 50 \text{ mm}) \cdot 10] = 247 \text{ mW}$$

The SAR exclusion condition is fulfilled because the output power of 14.355mW for the Bluetooth is less than the calculated threshold of 247mW, and so SAR test exclusion criteria are met, and evaluation is not required for this transmitter.
