


Fig.1 Photograph of the SAR measurement system






Limb - distance between flat phantom and EUT is 0 mm




Photograph 1. Limb, Front Surface, 0mm






Photograph 5. Limb, Top Edge, 0mm




Photograph 9. Limb, Right Edge, 0mm


