





#### Body - distance between flat phantom and EUT is 5 mm







Fig.3 EUT Front side to flat phantom






Fig.4 EUT Back side to flat phantom






Fig.5 EUT Top side to flat phantom



### Body - distance between flat phantom and EUT is 5 mm






Fig.6 EUT Bottom side to flat phantom






Fig.7 EUT Right side to flat phantom






Fig.8 EUT Top-Right side to flat phantom






Fig.9 EUT Right-Bottom side to flat phantom




Fig.10 EUT front view (include WLAN/BT antennal location and surface definition)
