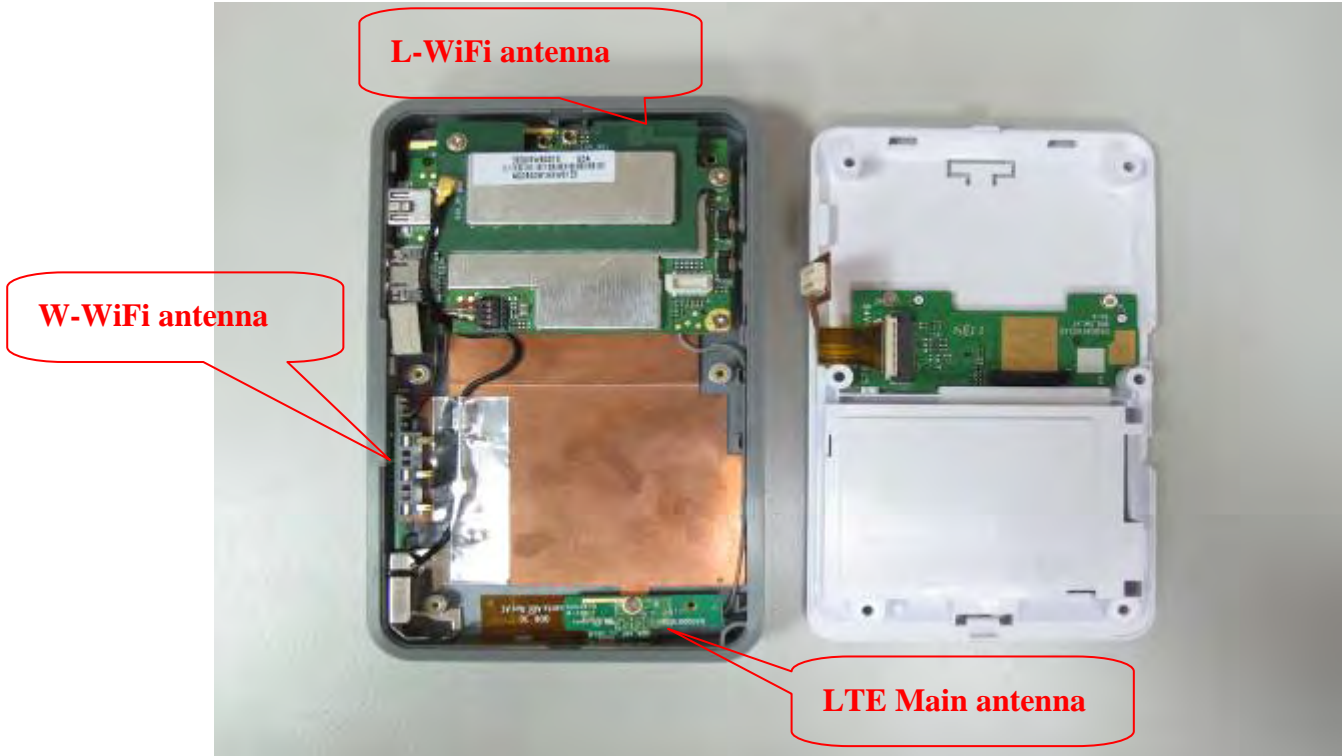


*Open View of EUT - 2*

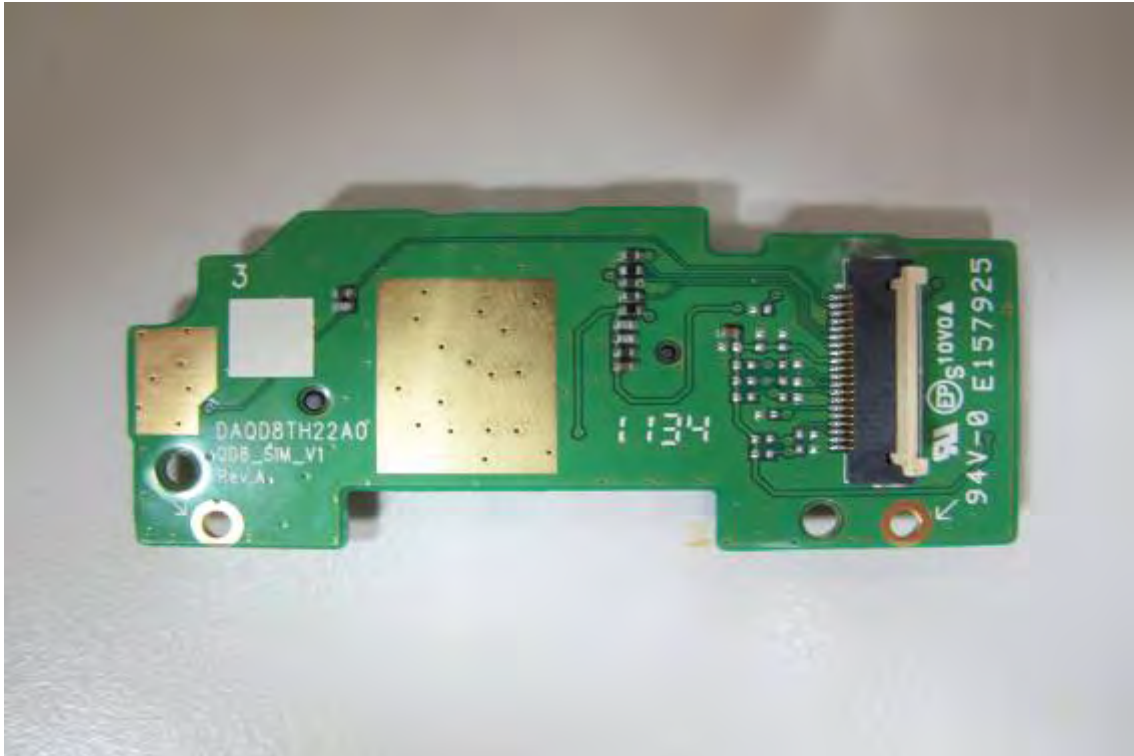


*Open View of Dock - 2*

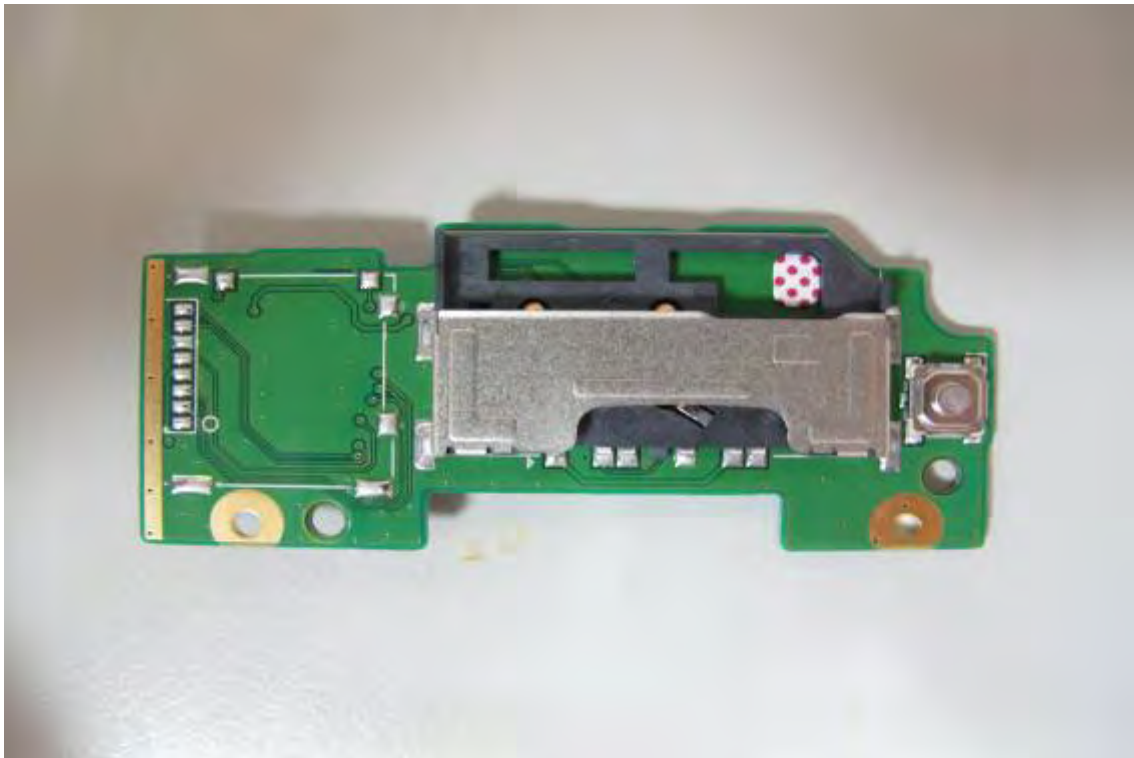

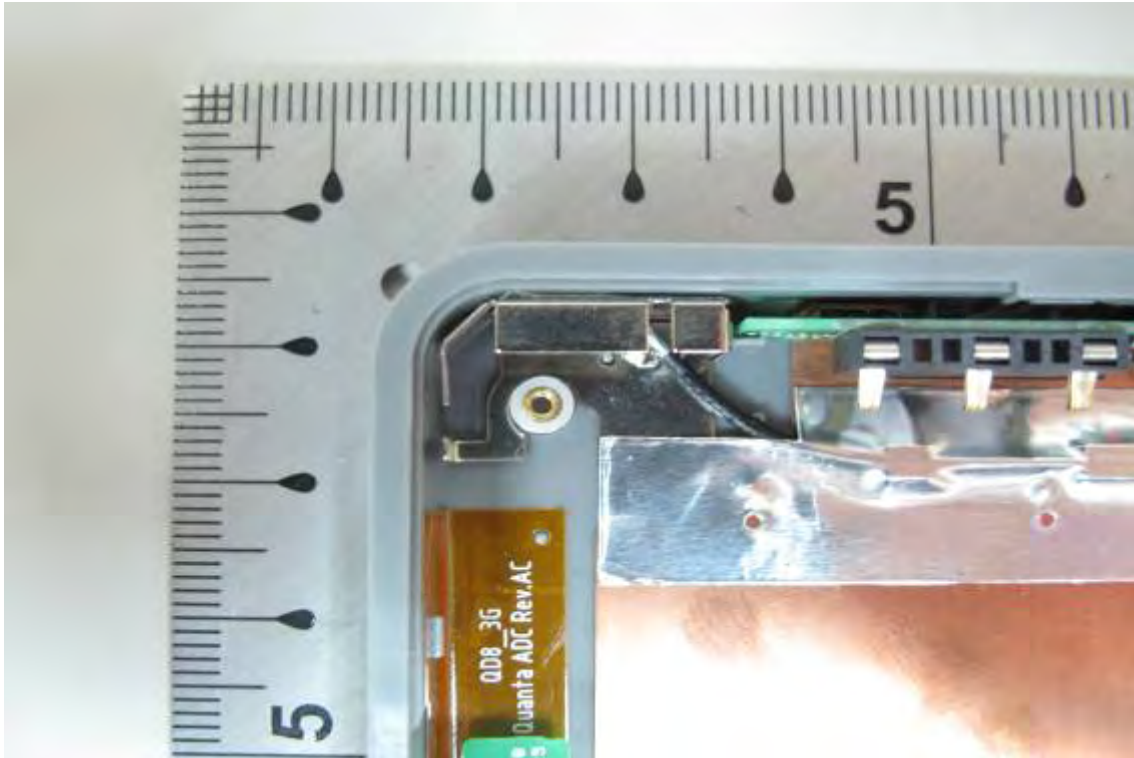


*Internal View of EUT – 6*

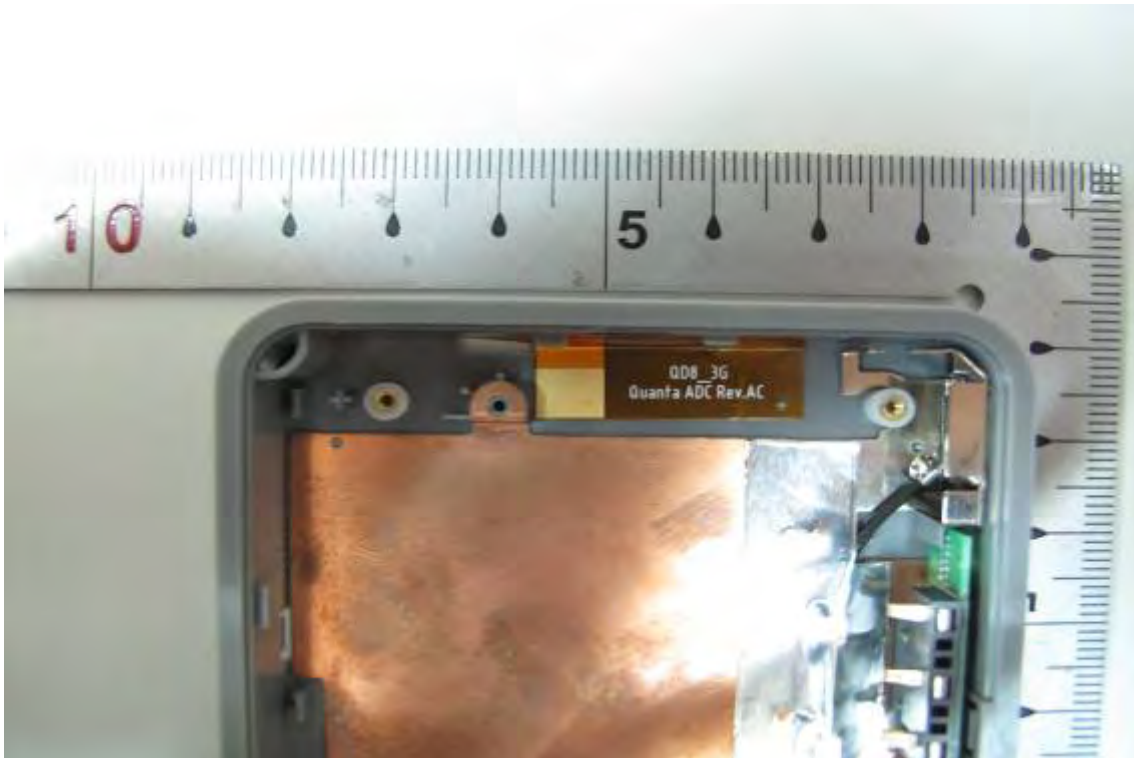

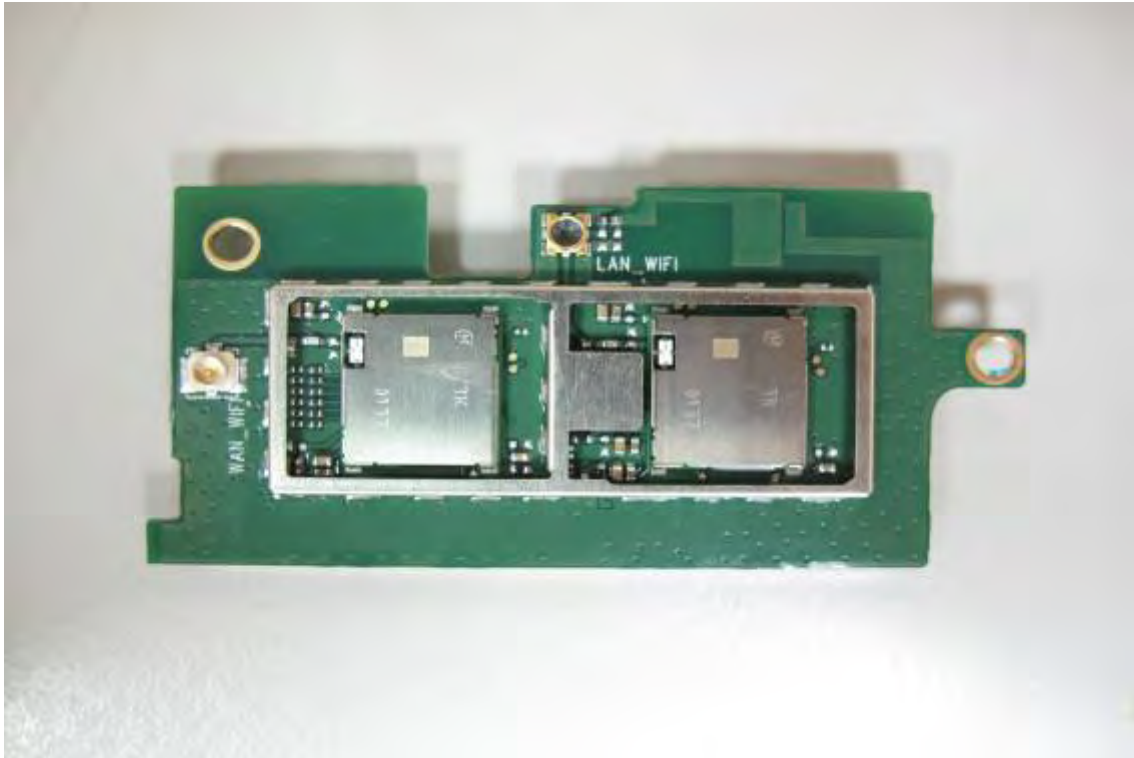

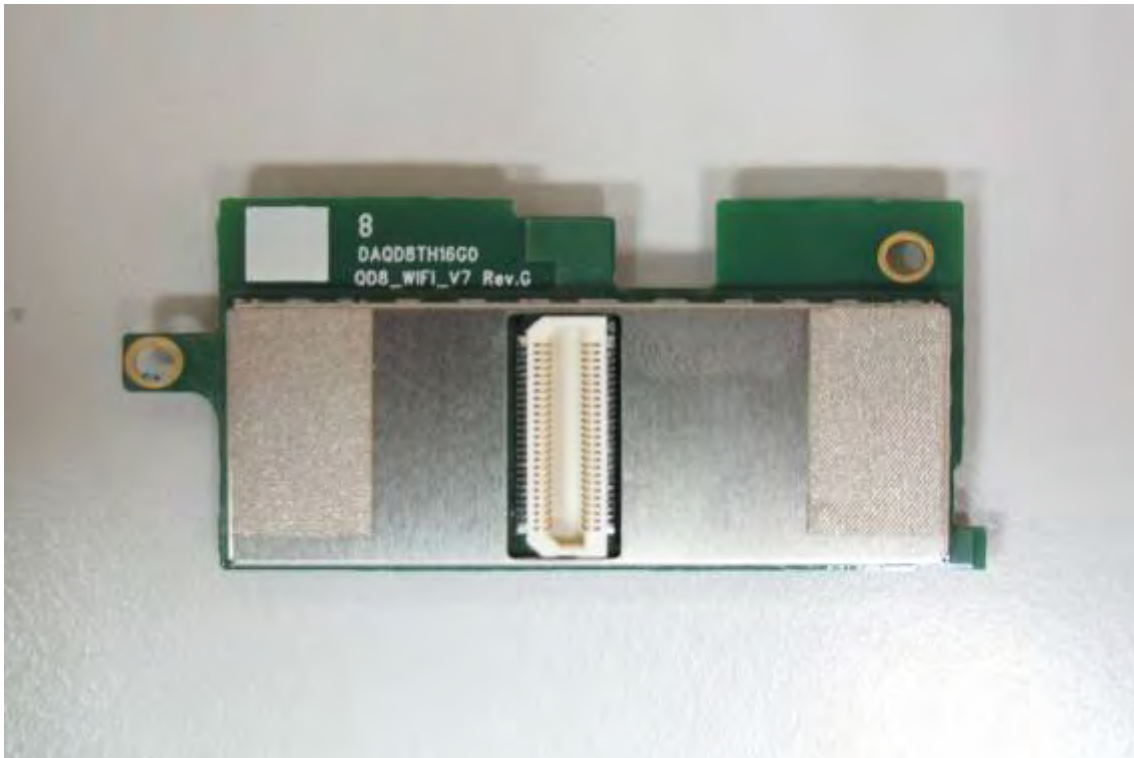

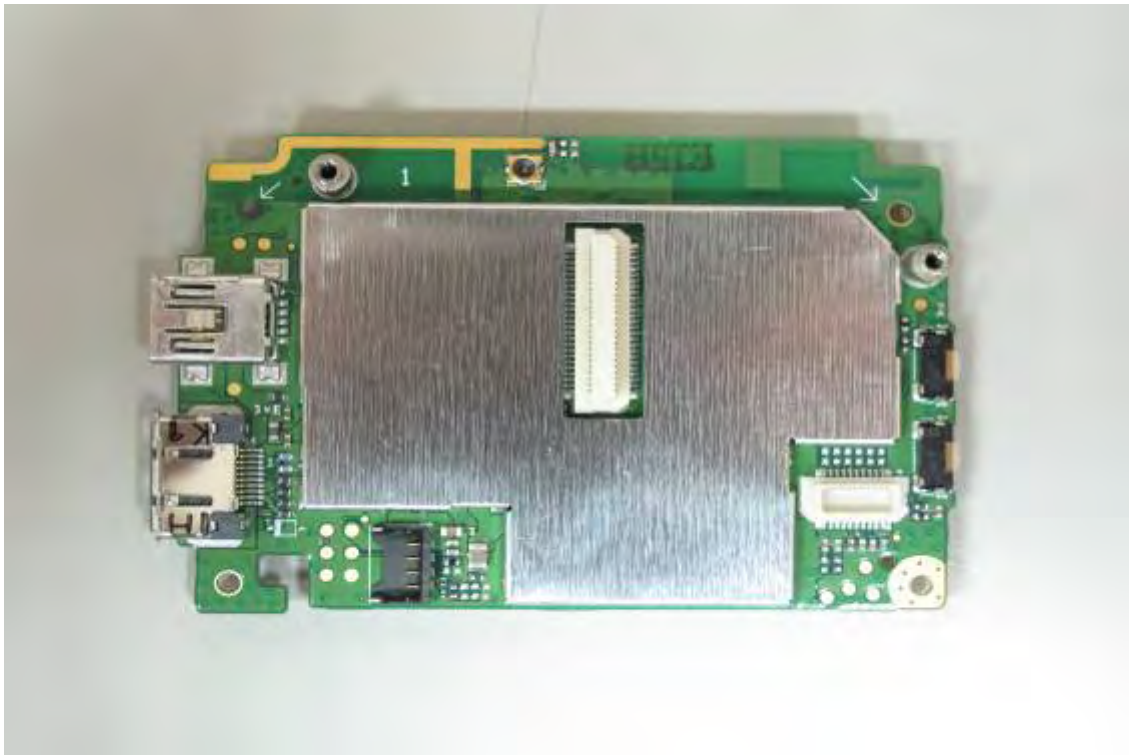

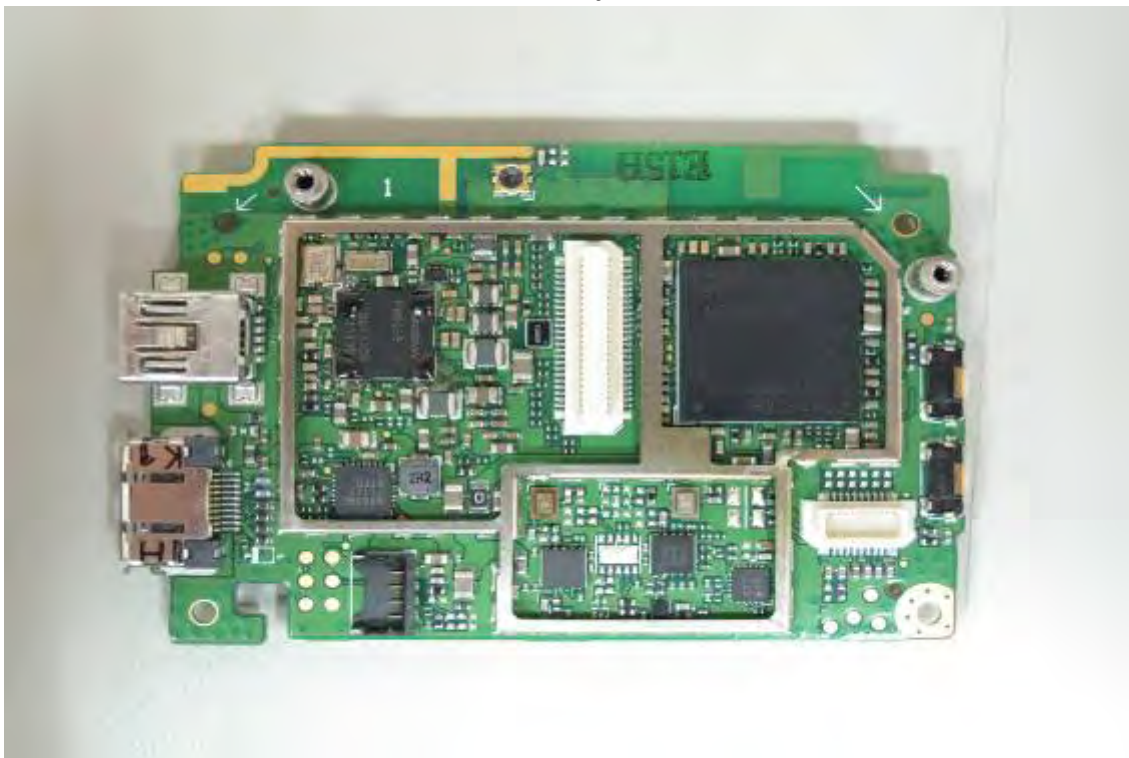
