## 2 SYSTEM TEST CONFIGURATION

### 2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

### 2.2 EUT Exercise

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

### 2.3 Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plan. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz. The CISPR Quasi-Peak and Average detector mode is employed according to §15.207. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table. For emissions testing at or below 1 GHz, the table height shall be 0.8 m above the reference ground plan. For emission measurements above 1 GHz, the table height shall be 1.5 m. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.

### 2.4 Measurement Results Explanation Example

#### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuation factor between EUT conducted port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly EUT RF output level.

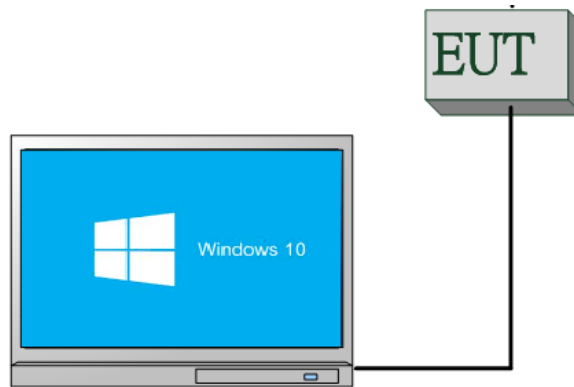

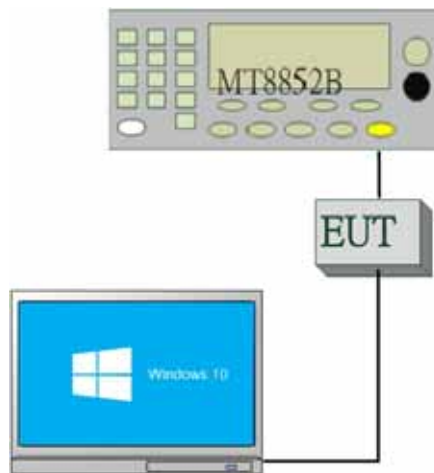

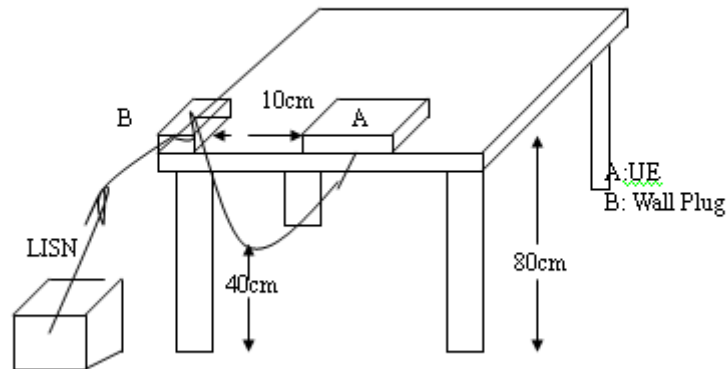

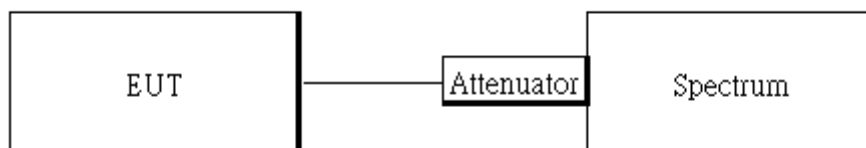
### 9.1 Standard Applicable

## 9.4 Measurement Procedure

### Conducted Band Edge:

1. Place the EUT on the table and set it in transmitting mode.
2. The testing follows FCC Public Notice DA 00-705 Measurement Guidelines.
3. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
4. Set center frequency of spectrum analyzer = operating frequency.
5. Set the spectrum analyzer as RBW=100 kHz, VBW=300 kHz, Sweep = auto
6. Mark Peak, 2.3999GHz and 2.4836GHz and record the max. level.
7. Repeat above procedures until all frequency measured were complete.

### Conducted Spurious Emission:

1. To connect Antenna Port of EUT to Spectrum.
2. The testing follows FCC Public Notice DA 00-705 Measurement Guidelines.
3. Set RBW = 100 kHz & VBW = 300 kHz, Detector =Peak, Sweep = Auto
4. Allow trace to fully stabilize.
5. Use the peak marker function to determine the maximum power level in any 100 kHz band segment within the fundamental EBW.
6. Repeat above procedures until all default test channel measured were complete.

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain and Duty Cycle Correction Factor (if any) from the measured reading. The basic equation with a sample calculation is as follows:

Ch High 3GHz – 26.5GHz (BR Mode)

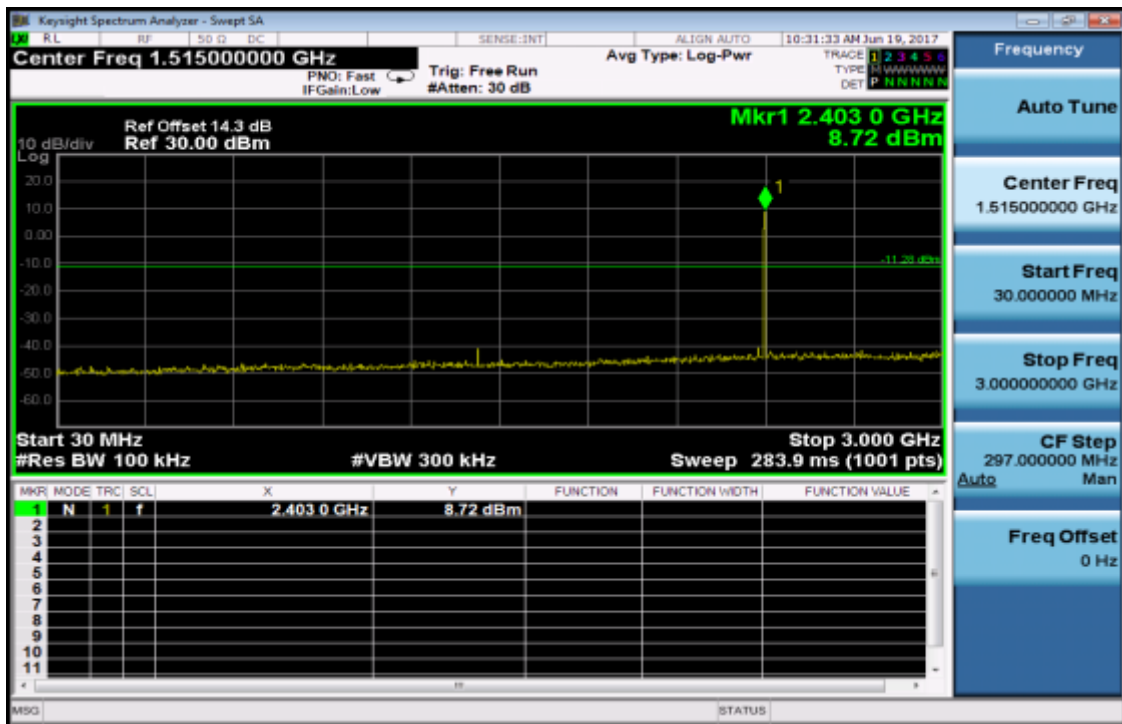

## 10 RADIATED BANDEDGE AND SPURIOUS EMISSION MEASUREMENT

### 10.1 Standard Applicable

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. In addition, radiated emissions which fall in the restricted bands, must also comply with the §15.209 & RSS-Gen §8.10 Table 6 limit.

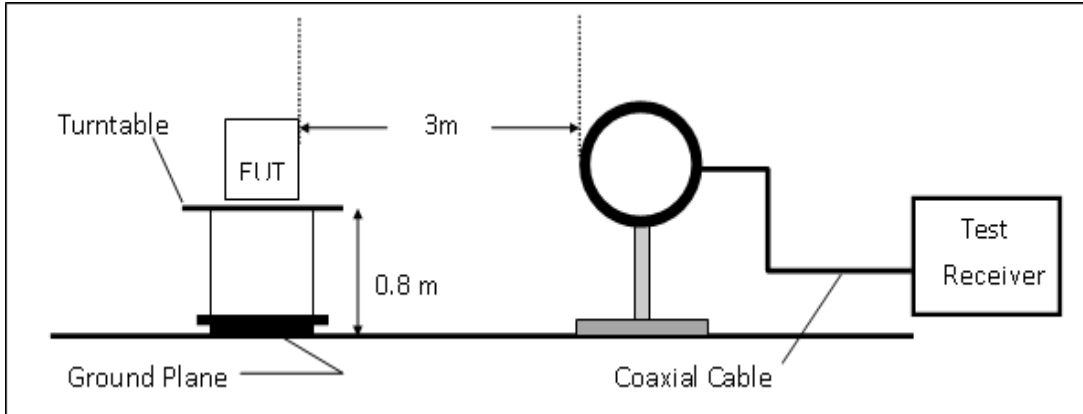

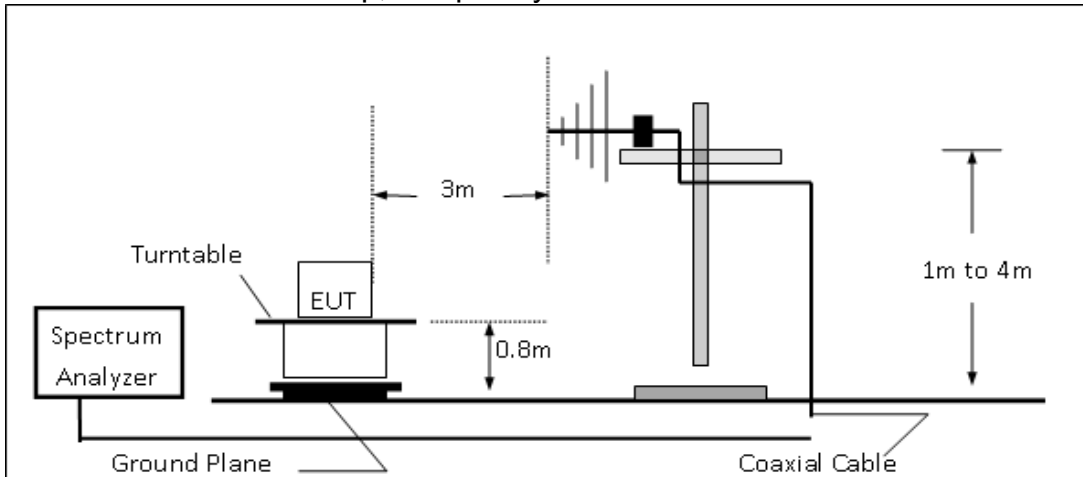

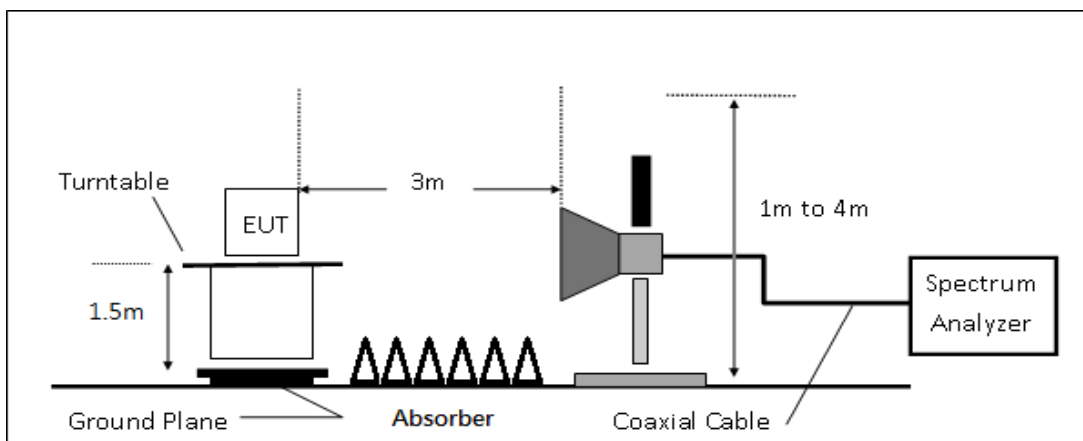
(A) Radiated Emission Test Set-UP Frequency Below 30MHz.

## 10.4 Measurement Procedure

### Radiated Emission

1. The testing follows FCC Public Notice DA 00-705 Measurement Guidelines.
2. The EUT was placed on a turn table with 0.8m for frequency < 1GHz and 0.8m for frequency > 1GHz above ground plan.
3. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
4. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
5. Use the follow spectrum analyzer setting:
  - (1) Span = wide enough to fully capture the emission being measured
  - (2) RBW = 1 MHz for  $f \geq 1$  GHz, 100 kHz for  $f < 1$  GHz, VBW  $\geq$  RBW, Sweep = auto, Detector function = peak, Trace = max hold
  - (3) For average measurement: use duty cycle correction factor method per 15.35(c)  
 Duty Cycle = On time/100 milliseconds  

$$\text{On time} = N1 * L1 = N2 * L2 + \dots + N(n-1) * LN(n-1) + N(n) * L(n)$$
 Where N1 is number of type 1 pulses, L1 is length of type 1 pulses, etc.  
 Average Emission Level = Peak Emission Level + 20\*log (duty Cycle)
6. When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.
7. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
8. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
9. Repeat above procedures until all frequency of the interest measured were complete.
