



15 RF EXPOSURE

15.1 Standard Applicable

According to §1.1307(b)(1), systems operating under the provisions of this section shall be operated in a manner that ensure that the public is not exposed to radio frequency energy level in excess of the Commission's guideline.

This is a Portable device with its physical nature to be used nearby, the distance between radiating structure and human is less than 20cm.

As per KDB 447498 D01 4.3.1, The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)] · $[\sqrt{f(GHz)}] \le 3.0$ for 1-g Head & Body SAR and ≤ 7.5 for 10-g extremity Hand SAR, where

> f (GHz) is the RF channel transmit frequency in GHz Power and distance are rounded to the nearest mW and mm before calculation

15.2 Measurement Result:

Step 1:

This is a portable device and the max. output power including tune-up tolerance is 1.549 (mW), lower than the threshold given and derived as formula given above, where

= $[(1.549 / 5)] \times [\sqrt{2.480/18.75}] = 0.026 \text{ W/kg}$

10g WIFI SAR estimated = [(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]·[√f(GHz)/x] W/kg

= $[(31.261 / 5)] \times [\sqrt{2.462/18.75}] = 0.523 \text{ W/kg}$
