



#### 1. GENERAL INFORMATION

# 1.1 Product Description

The Quanta Computer Inc.. Model: ZI2 (referred to as the EUT in this report) is a Notebook with WLAN + Bluetooth module.

The EUT is compliance with IEEE 802.11 b and Bluetooth Standard.

A major Bluetooth Module technical descriptions of EUT is described as following:

- A). Operation Frequency: 2402 MHz 2483 MHz, 79 channels
- B). Rated output power: 4 dBm (Peak)
- C). Modulation type: Frequency Hopping Sequence Spread Spectrum (FHSS)
- D). Antenna Designation: Metal Antenna, 0.64dBi, Non-User Replaceable (Fixed)

A major WLAN technical descriptions of EUT is described as following:

- A). Operation Frequency: 2.412GHz 2.462GHz, 11 channels
- B). Transmit Power: 14 dBm (Peak)
- C). Modulation type: Direct Sequence Spread Spectrum, (CCK; DQPSK; DBPSK; DFSK)
- D). Transition Speed: 1/2/5.5/11Mbps
- E). Antenna Designation: PIFA Antenna; -0.16dBi, Non-User Embedded, two provided. TX and RX diversity.

Power Supply: Input: AC 100-240V 50-60Hz 1.5A; Output: DC +19V, 3.95A

# 1.2 Related Submittal(s) / Grant (s)

This submittal(s) (test report) is intended for FCC ID: <u>HFSZI2WM3B2100BT</u> filing to comply with Section 15.247 of the FCC Part 15, Subpart C Rules. The composite system (digital device) is compliance with Subpart B is authorized under a DoC procedure.

#### 1.3 Test Methodology

Both conducted and radiated testing was performed according to the procedures in ANSI C63.4 (1992). Radiated testing was performed at an antenna to EUT distance 3 meters..



# 1.4 Test Facility

The open area test site and conducted measurement facility used to collect the radiated data is located on the address of C&C Laboratory, Co., Ltd. No. 81-1, 210 Lane, Pa-de 2<sup>nd</sup> Road, Lu-Chu Hsiang, Taoyuan, Taiwan, R.O.C.. The Open Area Test Sites and the Line Conducted labs are constructed and calibrated to meet the FCC requirements in documents ANSI C63.4: 2001 and CISPR 22/EN 55022 requirements.

#### 2. SYSTEM TEST CONFIGURATION

#### 2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 2.2 EUT Exercise

The EUT (Transmitter) was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements.

#### 2.3 Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4-2001. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak detector mode.


#### 2.3.2 Radiated Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4-2001.

## 4. DESCRIPTION OF TEST MODES

The EUT (Notebook with WLAN + Bluetooth module) has been tested under operating condition.

Test program used to control the EUT for staying in continuous transmitting mode is programmed.

The co-location test modes were defended as below for radiated spurious emission test and reported.

- 1. WLAN Channel Low + BT Channel Low
- 2. WLAN Channel Low + BT Channel Mid.
- 3. WLAN Channel Low + BT Channel High

WLAN module Channel low (2412MHz) · mid (2437MHz) and high (2462MHz) with 11Mbps highest data rate are chosen for others test items.

Peak Output Power was tested for both Antenna ports J5 and J6. The port J5 is higher than J6. The other test items of worst case at Antenna port A.



#### 5. SPURIOUS EMISSION TEST

#### 5.1 Standard Applicable

According to § 15.247(c), all other emissions outside these bands shall not exceed the general radiated emission limits specified in § 15.209(a). And according to § 15.33(a)(1), for an intentional radiator operates below 10GHz, the frequency range of measurements: to the tenth harmonic of the highest fundamental frequency or to 40GHz, whichever is lower.

#### 5.2 EUT Setup

- 1. The radiated emission tests were performed in the 3 meter open-test site, using the setup in accordance with the ANSI C63.4-2001.
- 2. The EUT was put in the front of the test table. The host PC system was placed on the center of the back edge on the test table. The peripherals like modem, monitor, printer, K/B, and mouse were placed on the side of the host PC system. The rear of the EUT and peripherals were placed flushed with the rear of the tabletop.
- 3. The keyboard was placed directly in the front of the monitor, flushed with the front tabletop. The mouse was placed next to the Keyboard, flushed with the back of keyboard.
- 4. The spacing between the peripherals was 10 centimeters.
- 5. External I/O cables were draped along the edge of the test table and bundle when necessary.
- 6. The host PC system was connected with 110Vac/60Hz power source.


#### **5.3** Measurement Procedure

- 1. The EUT was placed on a turn table which is 0.8m above ground plane.
- 2. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
- 4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 6. Repeat above procedures until all frequency measured were complete.



#### **Field Strength Calculation**

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain and Duty Cycle Correction Factor(if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CL - AG$$








# **Conducted Spurious Emission Measurement Result**







#### 6.2. EUT Setup

- The conducted emission tests were performed in the test site, using the setup in accordance with the ANSI C63.4-1992.
- 2. The EUT was plug-in the host PC via USB port. The host PC system was placed on the center of the back edge on the test table. 






Fig. 4: Measurement setup for testing on Antenna connector






# 6dB Band Width Test Data CH-LOW


## 6dB Band Width Test Data CH-MID



### 9. 100KHz BANDWIDTH OF BAND EDGES MEASUREMENT

# 9.1 Standard Applicable

According to § 15.247(c), in any 100 KHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100KHz bandwidth within the band that contains the highest level of the desired power, In addition, radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in15.209(a).

## 9.2 Measurement Procedure

- 1. Place the EUT on the table and set it in transmitting mode.
- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
- 3. Set center frequency of spectrum analyzer = operating frequency.
- 4. Set the spectrum analyzer as RBW, VBW=100KHz, Center Freq. 2.39GHz, 2.4835GHz, Span=100MHz, Sweep = auto.
- 5. Mark Peak ,2.4GHz and 2.4835GHz and record the max. level.
- 6. Repeat above procedures until all frequency measured were complete.






# **Out of Band Test Data CH-LOW**

# 10. Peak Power Spectral Density

# 10.1 Standard Applicable

According to § 15.247(d), for direct sequence systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3kHz band during any time interval of continuous transmission.

## 10.2 Measurement Procedure

- 1. Place the EUT on the table and set it in transmitting mode.
- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
- 3. Set the spectrum analyzer as RBW = 3KHz, VBW = 3KHz, Span = 300KHz, Sweep=100s
- 4. Record the max. reading.
- 5. Repeat above procedures until all frequency measured were complete.






# **Power Density Test Data CH-LOW**


# **Power Density Test Data CH-MID**

# 11. ANTENNA REQUIREMENT

# 11.1 Standard Applicable

For intentional device, according to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than furnished by the responsible party shall be used with the device.

And according to § 15.247(4)(i), if transmitting antennas of directional gain greater than 6dBi are used the power shall be reduced by the amount in 1dB that the directional gain of the antenna exceeds 6 dBi.

#### 11.2 Antenna Connected Construction

The directional gain of antenna used for transmitting is -0.16 dBi, and the user designs the antenna connector with permanent attachment and no consideration of replacement. Please see EUT photo for details.



# 12. RF Exposure
