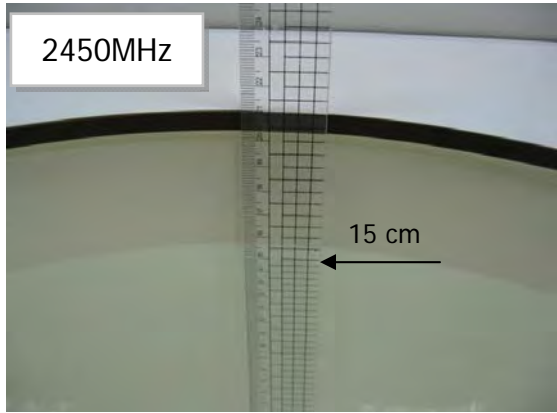


Fig.1 Photograph of the SAR measurement system

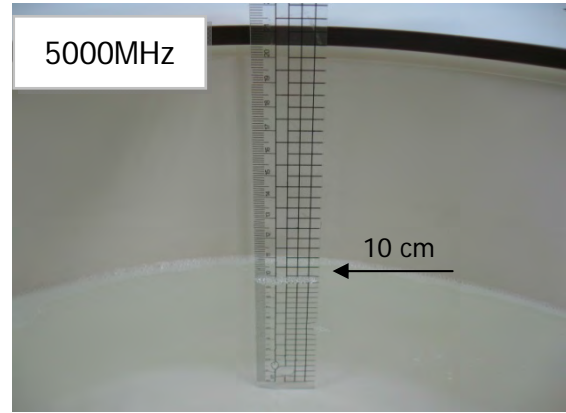

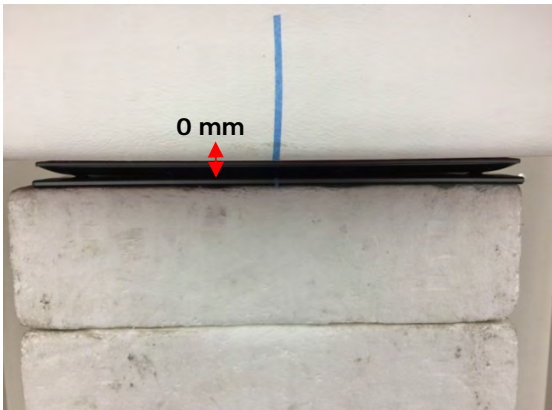

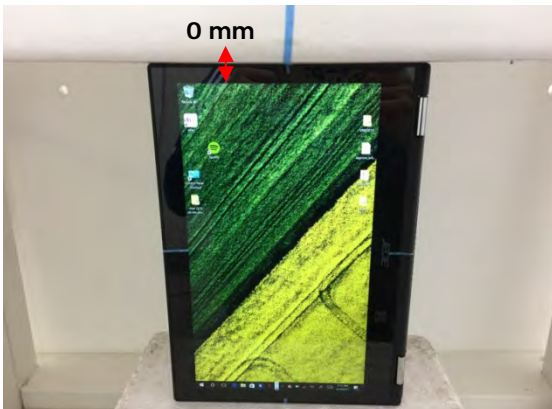

**Fig.4 EUT Back side to flat phantom**

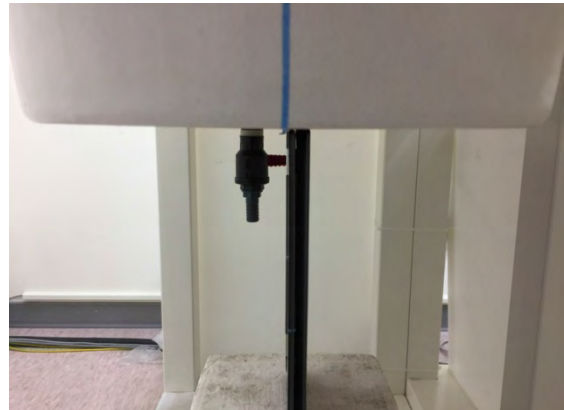
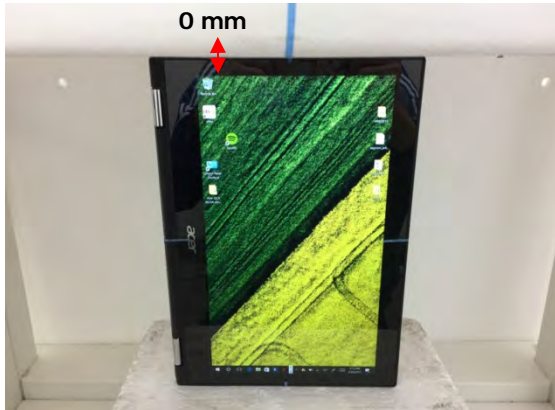


**Fig.5 EUT Right side to flat phantom**

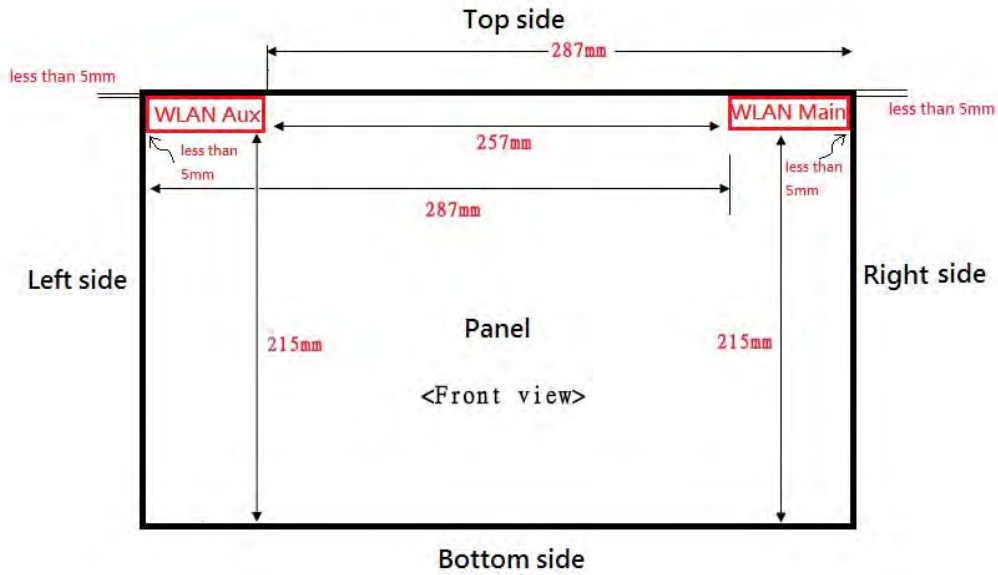


Fig.11 Antenna location of EUT (tablet mode)

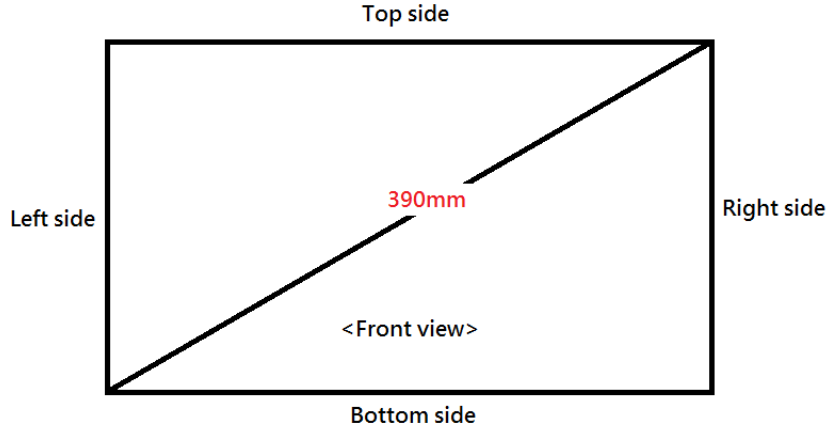


Fig.12 Diagonal size of EUT (tablet mode)

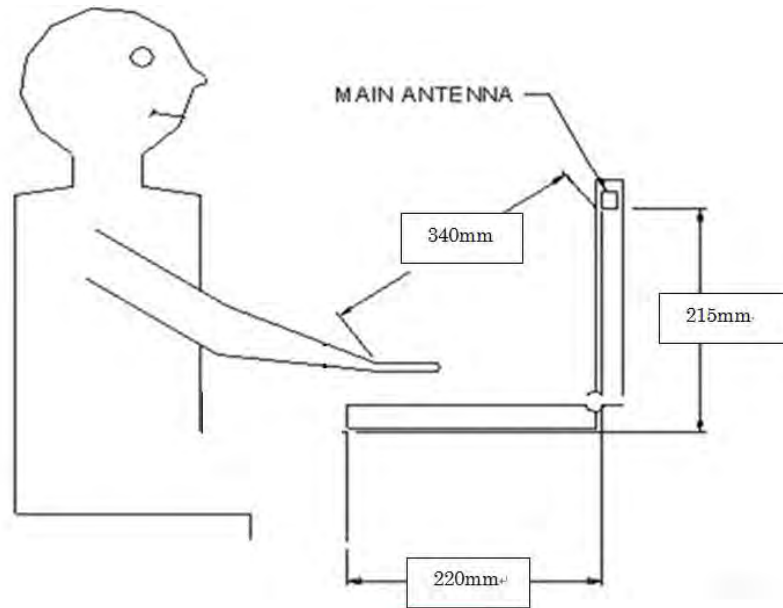


Fig.13 Antenna location of EUT (laptop mode)

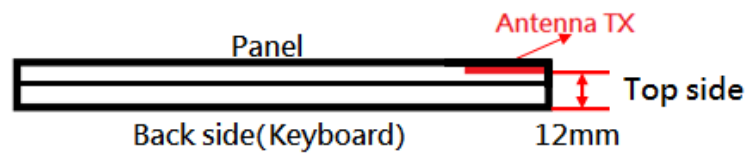


Fig.14 Antenna location of EUT (cross section view of tablet mode)

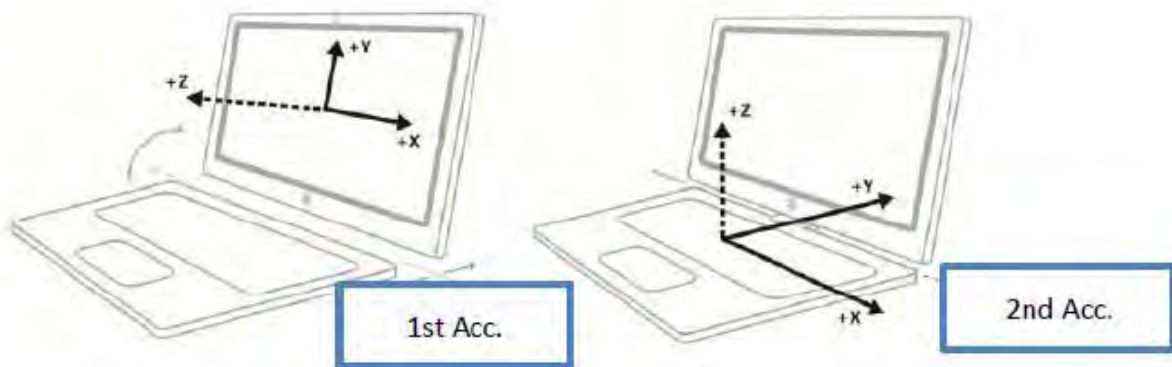


Fig.15 G-sensor location definition
