The tests documented in this report were performed in accordance with IC RSS-247, IC RSS-Gen and ANSI C63.10:2013.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

The tests documented in this report were performed in accordance with IC RSS-247, IC RSS-Gen, IC RSS-102, and ANSI C63.10: 2013.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

According to the requirements in ANSI C63.10: 2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 1.5 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in ANSI C63.10: 2013.

3.5 DESCRIPTION OF TEST MODES

The EUT (model: A6003) comes with two types of power adapter (model: PA-1100-25 / ADP-10HW A) for sale. After the preliminary test, the power adapter ADP-10HW A was found to emit the worst emissions and therefore had been tested under operating condition.

Software used to control the EUT for staying in continuous transmitting and receiving mode was programmed.

After verification, all tests carried out are with the worst-case test modes as shown below except radiated spurious emission below 1GHz and power line conducted emissions below 30MHz, which worst case was in normal link mode and receiving radiated spurious emission above 1GHz, which worst case was in CH Mid mode only.

IEEE 802.11b mode:

Channel Low (2412MHz), Channel Mid (2437MHz) and Channel High (2462MHz) with 1Mbps data rate were chosen for full testing.

IEEE 802.11g mode:

Channel Low (2412MHz), Channel Mid (2437MHz) and Channel High (2462MHz) with 6Mbps data rate were chosen for full testing.

IEEE 802.11n HT 20 MHz mode:

Channel Low (2412MHz), Channel Mid (2437MHz) and Channel High (2462MHz) with 6.5Mbps data rate were chosen for full testing.

IEEE 802.11n HT 40 MHz mode:

Channel Low (2422MHz), Channel Mid (2437MHz) and Channel High (2452MHz) with 13.5Mbps data rate were chosen for full testing.

The field strength of spurious emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis). The worst emission was found in lie-down position (X axis) and the worst case was recorded.

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, ridged waveguide, horn and/or Loop. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

5.3 LABORATORY ACCREDITATIONS AND LISTING

The test facilities used to perform radiated and conducted emissions tests are accredited by American Association for Laboratory Accreditation Program for the specific scope accreditation under Lab Code: 0824-01 to perform Electromagnetic Interference tests according to FCC Part 15 and CISPR 22 requirements. 












IEEE 802.11n HT 40 MHz mode


7.5 BAND EDGES MEASUREMENT



According to §15.207(a) & RSS-Gen §7.2.4, except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 μ H/50 ohms line impedance stabilization network (LISN). 


