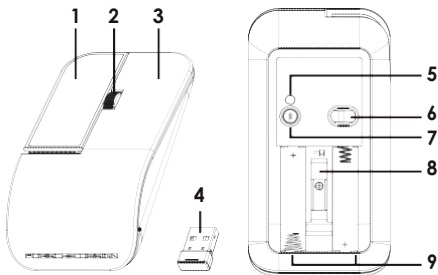

1. Left button
2. Scroll wheel (3D)

Turn the mouse on

1. Open the battery compartment cover at the back of the mouse.
2. Install 2 AAA batteries into the battery compartments.
3. Replace the cover.
4. The mouse is automatically ON.

WARNING

Make sure that the positive and negative ends are positioned correctly as labeled on the battery compartment.

Connect your mouse

- Using the Nano USB receiver

Plug the Nano USB receiver into your computer's USB Type-A port. Now you are ready to use the mouse.

NOTE

It's Plug & Play connectivity, no drivers required. Make sure the distance between your computer and mouse is within 10 meters.

- Pairing your mouse with Bluetooth
1. Press and hold the Bluetooth button at the back of your mouse for 2 seconds to switch to Bluetooth mode and start the initial pairing process. Press and hold the Bluetooth button for 5 seconds will start the pairing process again (or pairing with new device).
 2. The LED starts to flash blue indicating that the mouse is in Bluetooth mode and ready to pair.
 3. Start the Bluetooth pairing wizard on your computer and follow the instructions.

NOTE

- Once your mouse is paired successfully, you do not need to pair it again when using the mouse next time.
- If the pairing is unsuccessful, your mouse will enter Sleep mode after flashing blue about 3 minutes. Please repeat step 1-3 above to restart the pairing process.

Mode switch

Press the Bluetooth button for 2 seconds to toggle your mouse between Wireless and Bluetooth mode. LED flashes blue for 3 seconds indicating that the mouse is in Bluetooth mode. LED flashes red for 3 seconds indicating mouse is in Wireless mode.

DPI switch

You can cycle through the DPI options by repeatedly pressing Bluetooth button for 1 second. There are three available options for selection: 800/1600/3200.

Low battery notification

When the battery level is low, the flashing red will stay on if the mouse is in use. After stopping using the mouse, the LED flashes red for 10 seconds and then off.

NOTE

The mouse will maintain a low current consumption when entering Sleep mode. It is recommended to remove batteries if the mouse will not be used for an extended period.

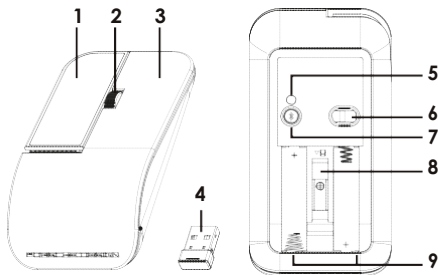

1. 左鍵

開啟滑鼠電源

1. 打開滑鼠背面的電池槽蓋。
2. 將 2 顆 AAA 電池裝入電池槽。
3. 重新裝回電池蓋。
4. 滑鼠便會自動開啟。

警告

請依照電池槽上所標示的正負極，將電池正確放入。

與滑鼠連線

- 使用微型 USB 接收器

將微型 USB 接收器插入電腦的 USB Type-A 連接埠，即可開始使用滑鼠。

注意

此滑鼠為隨插即用，無須安裝驅動程式。請確認電腦和滑鼠間的距離在 10 公尺內。

- 使用藍牙與滑鼠配對

1. 按住滑鼠背面的藍牙按鈕 2 秒可切換到藍牙模式，並進入初次配對程序。按住藍牙按鈕 5 秒將可再次啟動配對程序 (或與新裝置進行配對)。
2. LED 會開始閃爍藍燈，表示滑鼠正處於藍牙模式，並準備好配對。
3. 請在電腦上啟動藍牙配對精靈，並遵循指示完成程序。

注意

- 滑鼠配對成功後，下次使用時便不需要再進行配對。
- 如果滑鼠配對不成功，藍燈會在閃爍約 3 分鐘後進入睡眠模式。請重複上述 1-3 步驟，以便重新進行配對程序。

模式切換

按下藍牙按鈕 2 秒，即可讓滑鼠在無線和藍牙模式間切換。LED 閃爍藍燈 3 秒，表示滑鼠進入藍牙模式。LED 閃爍紅燈 3 秒，則表示滑鼠進入無線模式。

DPI 開關

重複按下藍牙按鈕 1 秒，即可循環切換 DPI 選項。有三個選項供選取：
800/1600/3200。

低電量通知 當電池電量不足，在使用滑鼠時會持續閃爍紅燈。不使用滑鼠時，LED 在閃爍紅燈 10 秒後便會停止。

注意

進入睡眠模式後，滑鼠會維持低耗電量。如果一段時間不使用滑鼠，建議您將電池取下。

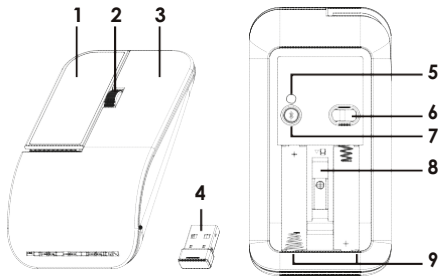

开启鼠标

1. 打开鼠标背面的电池仓盖。
2. 在电池仓里装入两节七号电池。
3. 将仓盖装回。
4. 鼠标将自动开启。

确认电池正负极按电池仓上的记号，并放置正确位置。

连接鼠标

- 使用Nano USB 接收器

将Nano USB 接收器插入电脑的USB Type-A 端口，即可使用鼠标。

注

此为“即插即用”，无需安装驱动程序。确保电脑和鼠标之间的距离在10米以内。

- 将鼠标与蓝牙配对

1. 按住鼠标背面的蓝牙按钮2秒可切换到蓝牙模式，并开始初始配对程序。按住蓝牙按钮5秒后，将再次开始配对程序（或与新设备配对）。
2. LED 开始闪蓝灯则表示鼠标处于蓝牙模式并准备配对。
3. 在电脑上启动蓝牙配对向导并按说明操作。

注

- 鼠标配对成功后，下次使用鼠标时则无需再对其进行配对。
- 如果配对失败，鼠标将在闪蓝灯约3分钟后进入睡眠模式。重复上述1-3步骤以重新开始配对程序。

模式切换

按蓝牙按钮2秒可在“无线”和“蓝牙”模式之间进行切换。LED闪蓝灯3秒表示鼠标处于蓝牙模式。LED闪红灯3秒则表示鼠标处于无线模式。

DPI切换

您可通过重复按蓝牙按钮1秒以在DPI选项中循环。有三个选项可供选择：
800/1600/3200。

低电量通知

当电量过低，在使用鼠标时将保持红灯闪烁，停用鼠标后，LED将开始闪红灯10秒，然后停止。

注

进入睡眠模式后，鼠标将保持低电流消耗。如果长时间不使用鼠标，建议取出电池。
