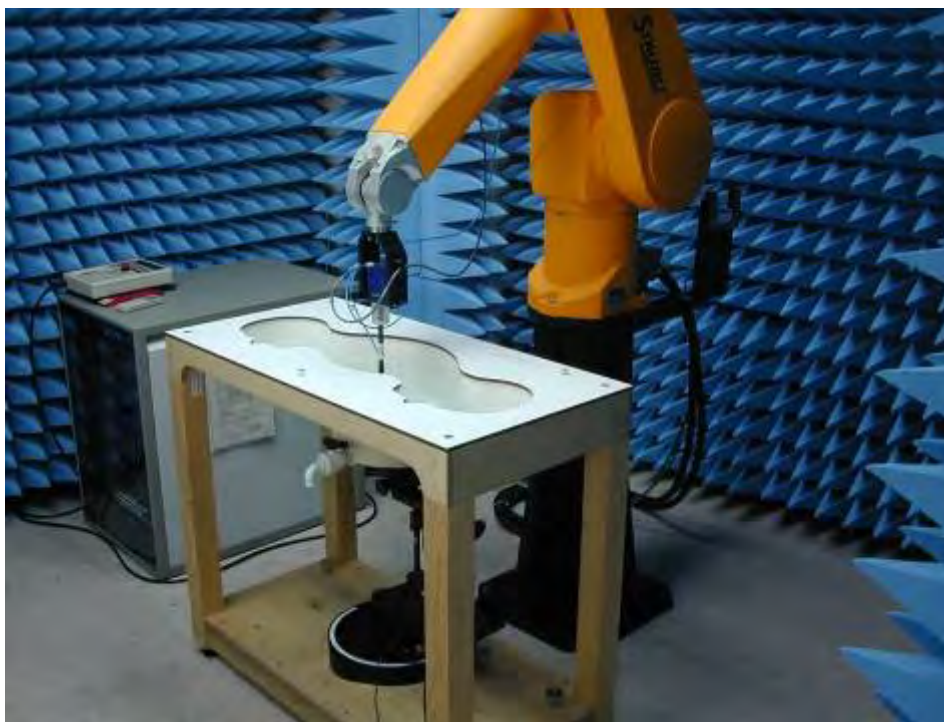


Fig.1 Photograph of the SAR Measurement System

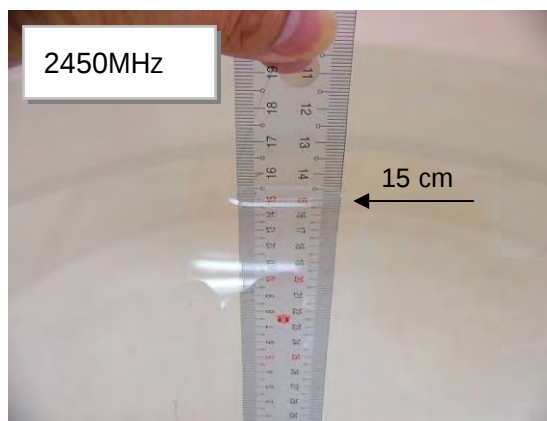


Fig.2 Flat (Body)

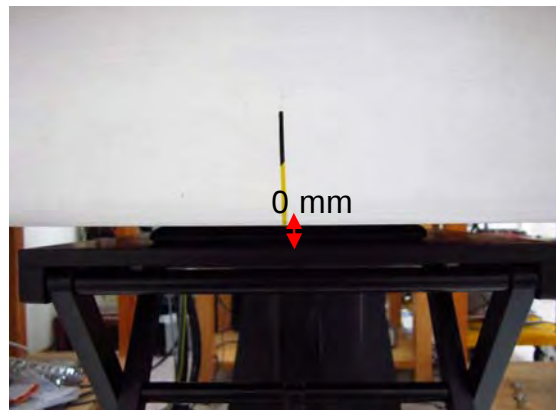


Fig.4 EUT Primary Portrait mode to flat phantom

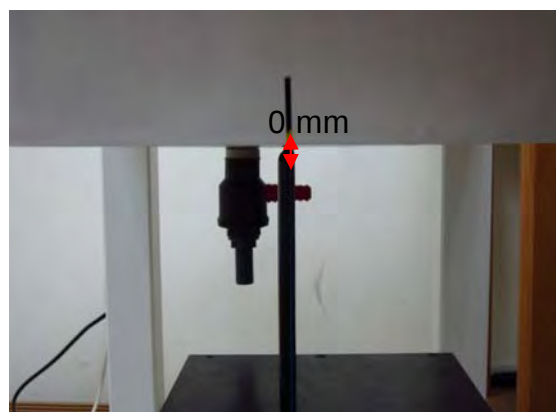


Fig.5 EUT Primary Landscape mode to flat phantom

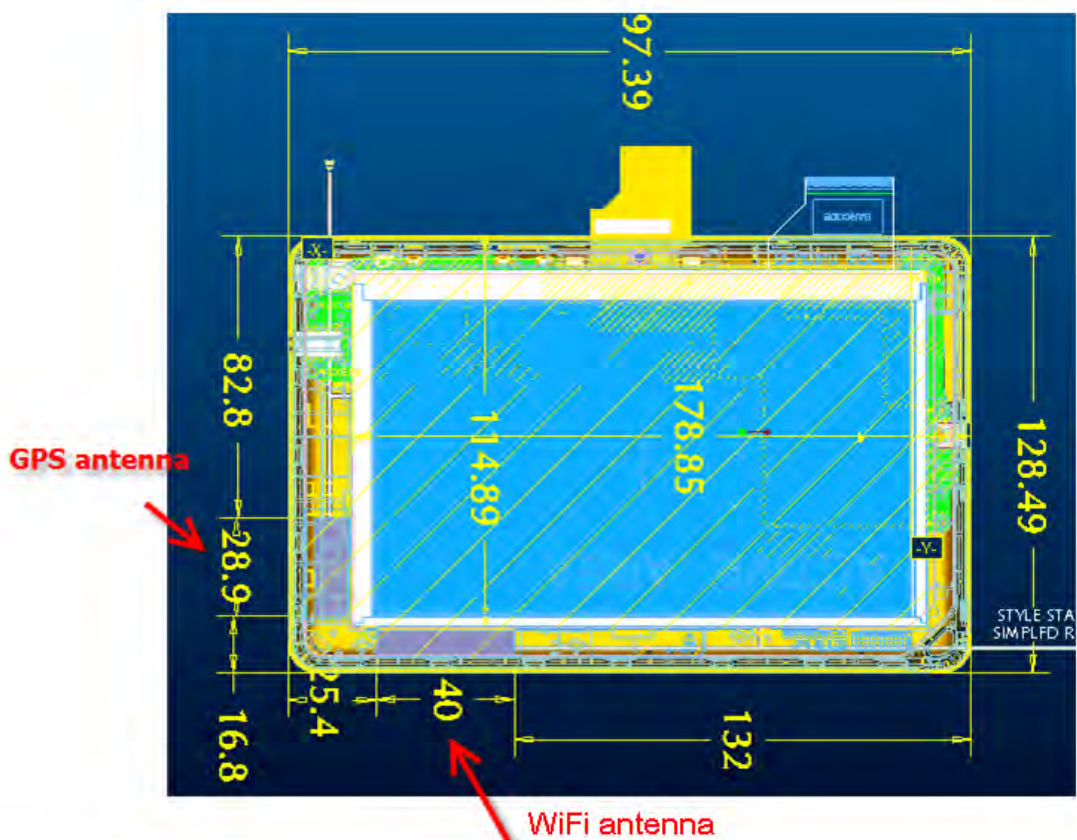


Fig.8 Antenna position of EUT
