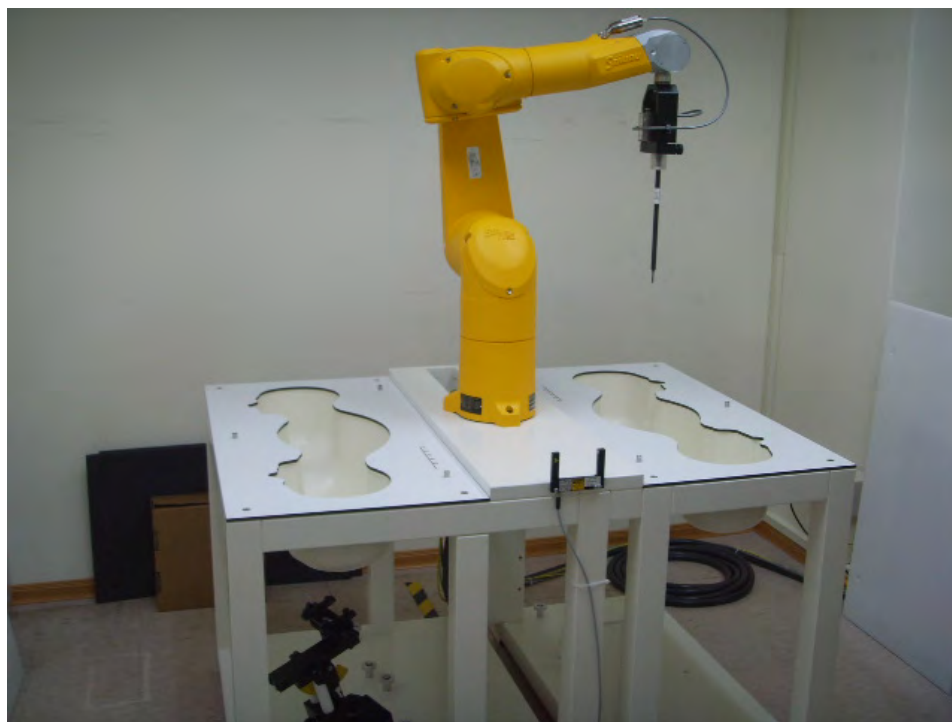


Fig.1 Photograph of the SAR measurement system

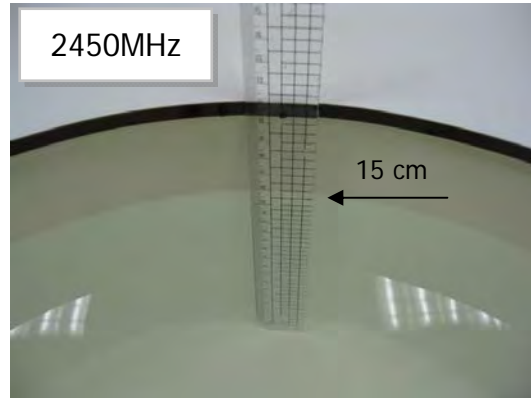

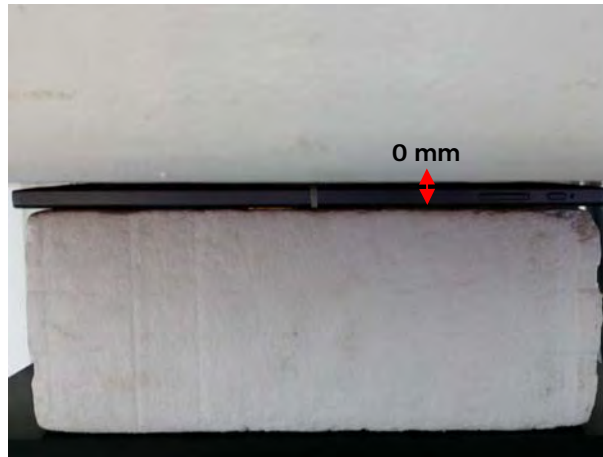


Fig.3 Lap-held to flat phantom

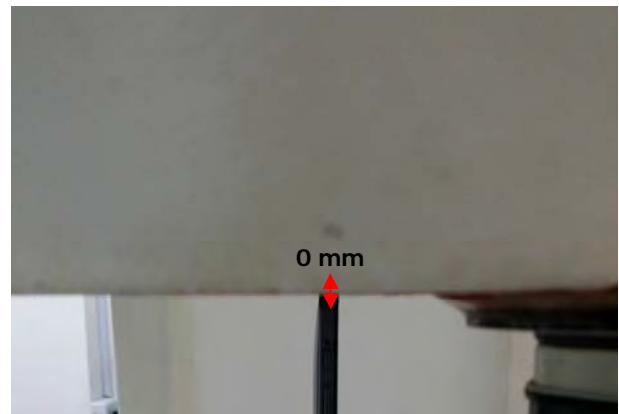
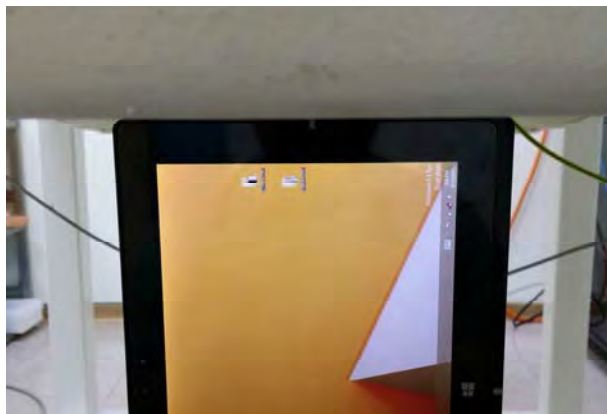


Fig.4 EUT Right side to flat phantom

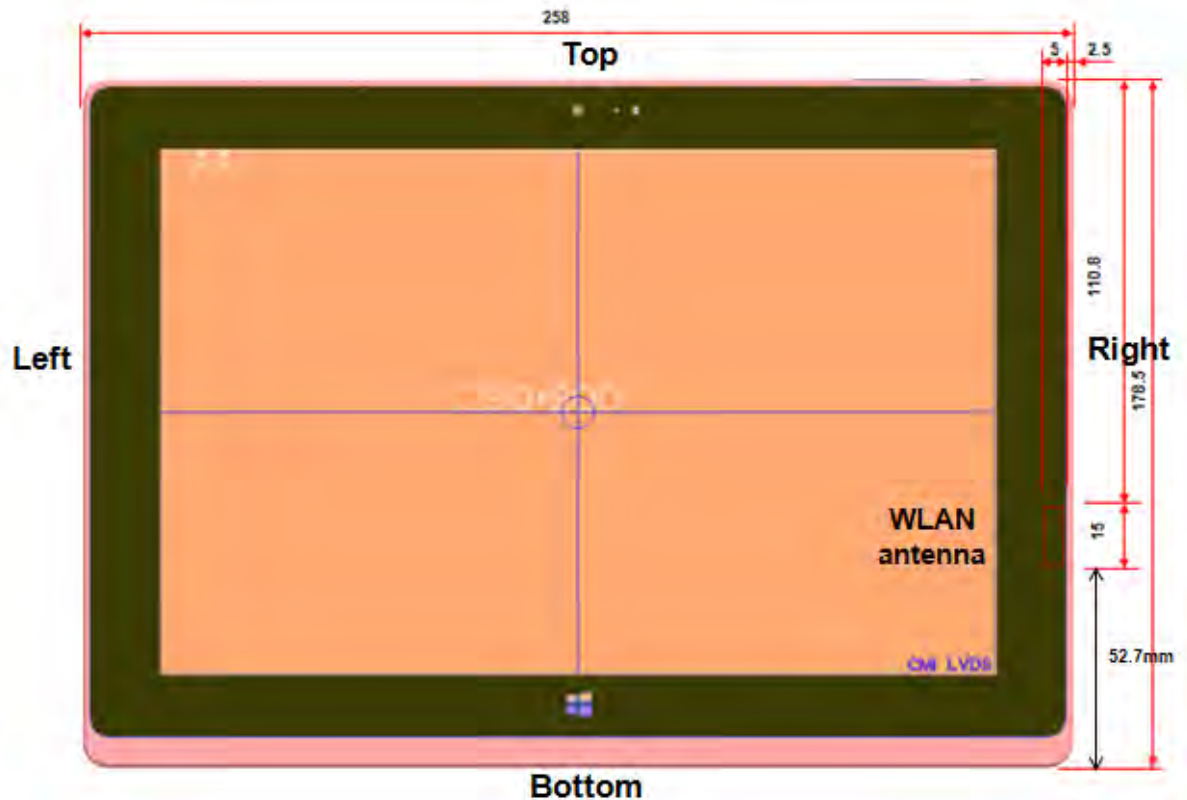


Fig.7 Antenna position (Front view)
