

# Appendix G - FCC 3G SAR Measurement Procedures

#### **Conducted Output Power:**

The PBA is fulfilled. The EUT was tested according to the requirements of the FCC 3G procedures and the TS 34.121. The EUT's WCDMA and HSDPA function is Release 5 version supporting HSDPA Category 8. A detailed analysis of the output power for all WCDMA and HSPDA modes is provided in the tables below. According to the FCC 3G procedures, handsets with both HSDPA should be tested according to Release 5 HSDPA test procedures, and the EUT does not support VOIP function over the HSDPA function. Device was tested according to procedure KDB941225 - section Release 5 HSDPA Data Devices as documented/evaluated in the following table.


