

## Summary

This report is an application for Certification of a radar detector operating pursuant to 47 CFR 15.109(h). This report is designed to demonstrate the compliance with the requirements outlined in Part 15 (using the methods outlined in Part 2) of 47 CFR.

We found that the product met the above requirements without modification. The test sample was received in good condition.

## Test Methodology

Radiated emissions testing was performed according to the procedures in ANSI C63.4 (2014). Testing was performed at a distance of 1 meter. Emissions from the device were measured in the 11.7-12.2GHz frequency range per 15.109(h). No emissions other than instrumentation noise floor were observed. Highest instrumentation noise floor was more than 10dB below the limit.

Models tested: Z-11R+, Z-15R+, Z-19R+, Z-31R+, CR68

Model CR73 was not tested since it is internally identical to Z-15R+ mentioned above.

Differences between the models are as described in the block diagram exhibit.

## Conditions Of Testing

By submitting a request for services to the Company, Client consents to the disclosure to accreditation bodies of those records of Client relevant to the accreditation body's assessment of the Company's competence and compliance with relevant accreditation criteria. The Company shall not be liable for any loss or damage whatsoever resulting from the failure of the Company to provide its services within any time period for completion estimated by the Company. If Client anticipates using the Test Report in any legal proceeding, arbitration, dispute resolution forum or other proceeding, it shall so notify the Company prior to submitting the Test Report in such proceeding. The Company has no obligation to provide a fact or expert witness at such proceeding unless the Company agrees in advance to do so for a separate and additional fee.
2. The Test Report will set forth the findings of the Company solely with respect to the test samples identified therein. Unless specifically and expressly indicated in the Test Report, the results set forth in such Test Report are not intended to be indicative or representative of the quality or characteristics of the lot from which a test sample is taken, and Client shall not rely upon the Test Report as being so indicative or representative of the lot or of the tested product in general. The Test Report will reflect the findings of the Company at the time of testing only, and the Company shall have no obligation to update the Test Report after its issuance. The names, service marks, trademarks and copyrights of the Company and its affiliates, including the names **"BUREAU VERITAS," "BUREAU VERITAS CONSUMER PRODUCTS SERVICES," "BVPCS," "MTL," "ACTS," "MTL-ACTS" and "CURTIS-STRAUS"** (collectively, the "Marks") are and shall remain the sole property of the Company or its affiliates and shall not be used by Client except solely to the extent that Client obtains the prior written approval of the Company and then only in the manner prescribed by the Company.
