# 2 RF EXPOSURE EVALUATION FOR PORTABLE CONDITIONS

### 2.1 KDB 447498 D01 4.3.1:

**Step a:** For 100 MHz to 6 GHz and test separation distances ≤ 50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)]  $\cdot$  [ $\forall$ f(GHz)]  $\leq$  3.0 for 1-g Head & Body SAR and  $\leq$  7.5 for 10-g extremity Hand SAR, where

- f(GHz) is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison
- The values 3.0 and 7.5 are referred to as numeric thresholds in step b) below
- **Step b:** For 100 MHz to 6 GHz and test separation distances > 50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following (also illustrated in Appendix B):
  - 1) {[Power allowed at numeric threshold for 50 mm in step a)] + [(test separation distance 50 mm)·(f(MHz)/150)]} mW, for 100 MHz to 1500 MHz
  - 2) {[Power allowed at numeric threshold for 50 mm in step a)] + [(test separation distance 50 mm)·10]} mW, for > 1500 MHz and ≤ 6 GHz
- **Step c:** For frequencies below 100 MHz, the following may be considered for SAR test exclusion (also illustrated in Appendix C):
  - 1) For test separation distances > 50 mm and < 200 mm, the power threshold at the corresponding test separation distance at 100 MHz in step b) is multiplied by [1 + log(100/f(MHz))]
  - 2) For test separation distances  $\leq$  50 mm, the power threshold determined by the equation in c) 1) for 50 mm and 100 MHz is multiplied by  $\frac{1}{2}$
  - 3) SAR measurement procedures are not established below 100 MHz

#### 2.3 Standalone test exclusion for EMR:

Based on KDB447498D01v06 4.3.1 c), SAR test exclusion threshold for EMR (0.5625MHz) shall be evaluated as below.

- a) For test separation distances ≤ 50 mm, the power threshold determined by the equation in 4.3.1 c) 1) for 50 mm and 100 MHz is multiplied by ½
- b) The power threshold at 50mm/100 MHz in 4.3.1 b) is multiplied by [1 + log(100/f(MHz))] where f is 0.5625MHz
- c) The power threshold in 4.3.1 b) is [Power allowed at numeric threshold for 50 mm in 4.3.1 a)] + [(test separation distance – 50 mm)-(f(MHz)/150)] mW, for 100 MHz to 1500 MHz where test separation distance is 50mm, frequency is 100MHz.
- d) Power allowed at numeric threshold for 50 mm in 4.3.1 a) is [3/√f(GHz)]-(test separation distance)

Hence, SAR test exclusion threshold is calculated in reverse sequence:

- d):  $[3/\sqrt{0.1}]\cdot 50 = 474.3416$ mW
- c):  $474.3416 + (50-50) \cdot (100/150) = 474.3416$ mW
- b): 474.3416-[1+log(100/0.5625)] = 1541.552mW
- a):  $1541.552 \cdot 0.5 = 770.776$ mW

So the SAR test exclusion power threshold for EMR(0.5625MHz) is 770.776mW(equal to 28.87dBm).

Also, the maximum power of EMR is -85.24dBm (converted from 9.92 dBuV/m at 3m) and it is far below the exclusion threshold (28.87dBm), so SAR test for EMR can be excluded.

Estimated SAR = 
$$\frac{\text{Max. tune up power (mW)}}{\text{Min. test separation distance(mm)}} \times \frac{\sqrt{\text{f(GHz)}}}{7.5}$$

If the minimum test separation distance is < 5mm, a distance of 5mm is used for estimated SAR calculation. When the test separation distance is >50mm, the 0.4W/kg is used for SAR-1g.

#### 3.3 **Estimated SAR for BLE and EMR**

Based on KDB447498D01v06 4.3.2 b), when an antenna qualifies for the standalone SAR test exclusion of 4.3.1 and also transmits simultaneously with other antennas, the standalone SAR value must be estimated according to the following to determine the simultaneous transmission SAR test exclusion criteria:

1) [(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]·[ $\sqrt{f(GHz)/x}$ ] W/kg, for test separation distances  $\leq$  50 mm, where x = 7.5 for 1-g SAR and x = 18.75 for 10-g SAR.
