
NOTE:

1. The measurement uncertainty is less than +/- 2.6dB, which is calculated as per the NAMAS document NIS81.

2. The calibration interval of the above test instruments is 12 months and the calibrations are traceable to NML/ROC and NIST/USA.

3. TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 kHz bandwidth from band edge. The band edges was measured and recorded.




5. EUT OPERATING CONDITIONS




