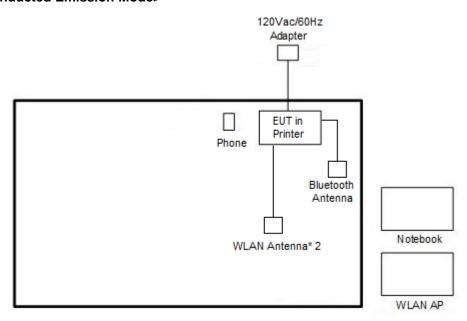

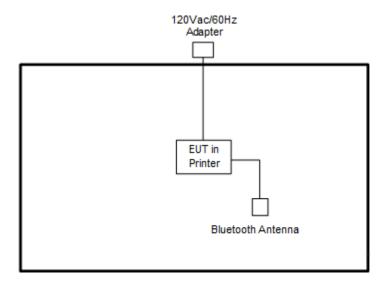

2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10 dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 4.2 + 10 = 14.2 (dB)

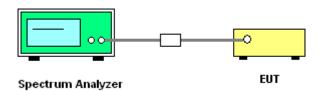

- 2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.

- 3. Set the maximum power setting and enable the EUT to transmit continuously.
- 4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. Set the Video bandwidth (VBW) = 300 kHz. In order to make an accurate measurement. The 6dB bandwidth must be greater than 500 kHz.
- For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set1-5% of the emission bandwidth and set the Video bandwidth (VBW) ≥ 3 * RBW.

3.2 Output Power Measurement

3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5 MHz, the limit for output power is 30 dBm. If transmitting antenna of directional gain greater than 6 dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

- 2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
- 3. Set the maximum power setting and enable the EUT to transmit continuously.
- 4. Set RBW = 100 kHz, VBW = 300 kHz, Peak Detector. Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

For radiated test below 30MHz

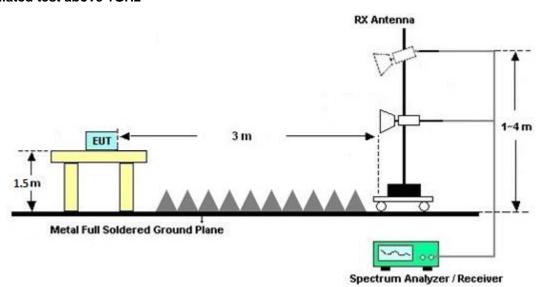

BLE (Harmonic @ 3m)

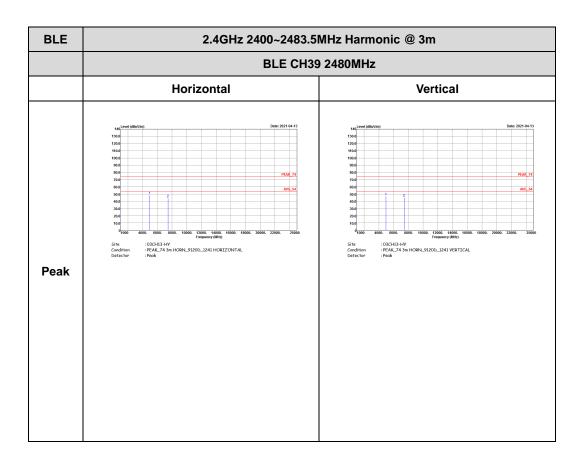

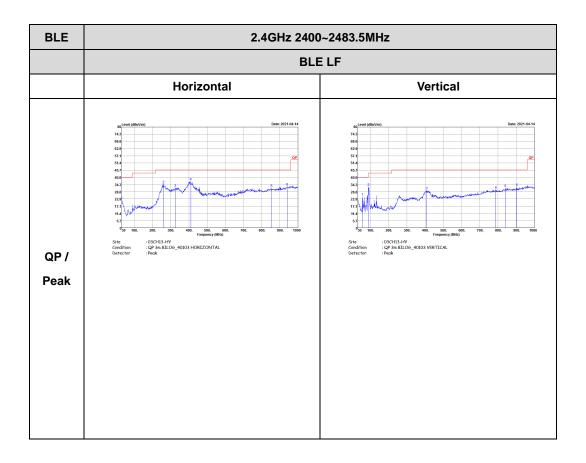

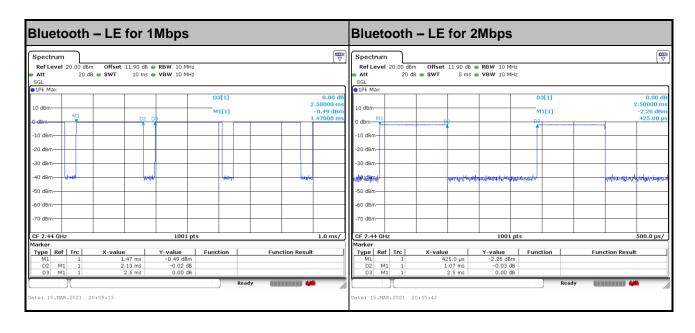
