




1. INTRODUCTION

 - For power spectral density (PSD) measurements on all devices,
 Array Gain = 10 log (N_{ANT}/ N_{SS}) dB;
 - For power measurements on IEEE 802.11 devices,

Array Gain = 0 dB for $N_{ANT} \le 4$;


- 2. The EUT also supports Beam Forming mode, and the Beam Forming support 802.11ac/ax, not include 802.11a/b/g/n. BF Directional gain = G_{ANT} + 10 log (N_{ANT}). For beamforming operation, manufacturer automatically backs power down based on a 10log(N) factor based on CDD power.
- 3. All messages of antenna were declared by manufacturer.

Calculation Formula: $Pd = (Pout*G)/(4*pi*r^2)$

Where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

r = distance between observation point and center of the radiator in cm

Pd is the limit of MPE, 1mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

CONCLUSION:

WLAN 2.4GHz Band and WLAN 5GHz can transmit simultaneously.

The max Power Density at R (20 cm) = 0.1111mW/cm² + 0.2476mW/cm² = 0.3587mW/cm² < 1mW/cm².

So the compliance distance is 20cm for device installed without any other radio equipment.
