 $Pd = (Pout*G) / (4*pi*r^2)$

where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

CONCULSION:

Only 2.4 and 5GHz can transmit simultaneously. The formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 +etc. < 1

CPD = Calculation power density

LPD = Limit of power density

1. WLAN 2.4G + WLAN 5.0G = 0.287 + 0.629 = 0.916

Therefore, the maximum calculation of this situation is 0.916, which is less than the "1" limit.
