2 MPE EVALUATION OF MOBILE DEVICES

MPE Evaluation of Simultaneous Transmission

2.4 and 5GHz can transmit at the same time, MPE evaluation is as below formula

PD1 / Limit1 + PD2 / Limit 2 + < 1, PD = Power density

Non-beamforming mode

MPE Evaluation = Maximum MPE of 2.4GHz + Maximum MPE of 5 GHz = 0.134 / 1 + 0.325 / 1 = 0.459 < 1

Beamforming mode

MPE Evaluation = Maximum MPE of 2.4GHz + Maximum MPE of 5 GHz = 0.250 / 1 + 0.685 / 1 = 0.935 < 1
