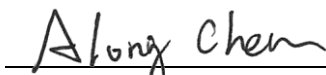

1 MPE EVALUATION OF MOBILE DEVICES

Human exposure to RF emissions from mobile devices (47 CFR §2.1091) may be evaluated based on the MPE limits adopted by the FCC for electric and magnetic field strength and/or power density, as appropriate, since exposures are assumed to occur at distances of 20 cm or more from persons.

1.1 LIMITS FOR GENERAL POPULATION/UNCONTROLLED EXPOSURE

Frequency Range (MHz)	Power Density (mW /cm ²)	Averaging Time (minutes)
300~1500	F/1500	30
1500~100000	1.0	30

1.2 MPE EVALUATION FORMULA

$$Pd = \frac{Pt}{4 * Pi * R^2}$$

Where

Pd= Power density in mW/cm²

Pt= EIRP in mW

Pi= 3.1416

R= Measurement distance

1.3 MPE EVALUATION RESULTS

MPE Evaluation of Single Transmission

Non-beamforming mode

Frequency Range (MHz)	Maximum Conducted Power (dBm)	Antenna Gain (dBi)	Distance (cm)	Power Density (mW/cm ²)	Limit (mW/cm ²)
2412~2462	23.61	4.71	20	0.135	1
5180~5240	17.61	3.43	20	0.025	1
5745~5825	17.26	3.43	20	0.023	1

Beamforming mode

Frequency Range (MHz)	Maximum Conducted Power (dBm)	Antenna Gain (dBi)	Distance (cm)	Power Density (mW/cm ²)	Limit (mW/cm ²)
2412~2462	22.17	6.83	20	0.158	1

Note:

- For 2412~2462 MHz band
Directional gain = $10 * \log((10^{4.70836/20} + 10^{2.82/20})^2 / 2) = 6.83$ dBi

MPE Evaluation of Simultaneous Transmission

2.4 and 5GHz can transmit at the same time, MPE evaluation is as below formula

$PD1 / \text{Limit}1 + PD2 / \text{Limit} 2 + \dots < 1$, PD = Power density

Non-beamforming mode

MPE Evaluation = Maximum MPE of 2.4GHz + Maximum MPE of 5 GHz = $0.135 / 1 + 0.025 / 1 = 0.160 < 1$

Beamforming mode

MPE Evaluation = Maximum MPE of 2.4GHz + Maximum MPE of 5 GHz = $0.158 / 1 + 0.025 / 1 = 0.183 < 1$

Conclusion

MPE evaluations of single and simultaneous transmission meet the requirement of standard.
