Measurement Result

The predicted power density level at 20 cm is 0.00061 mW/cm². This is below the uncontrolled exposure limit of 1 mW/cm² at 2402MHz.

Note: In comparison with BDR, and EDR, BDR results highest emission of power, and further produces higher value of Maximum Permissible Exposure at 20cm. Hence, only the derivation of MPR on the basis of BDR mode is present in this given test report.

Simultaneous MPE:

As per KDB 447498 D01, Simultaneous transmission MPE test exclusion applies when the sum of the MPE ratios for all simultaneous transmitting antennas incorporated in a host device, based on calculated or measured field strengths or power density, is ≤ 1.0 .

MPE 1 as obtains in 5.8GHz module transmission: $0.0044281 \text{ mW/cm}^2$, where derivation of the power density can be referred EF/2012/C0010

MPE 2 as obtains in Bluetooth transmission: $0.0006144 \text{ mW/cm}^2$

$\Sigma \text{ MPE ratio} = \text{MPE1/MPE Limit} + \text{MPE2/MPE Limit} = 0.0044281/1 + 0.0006144/1 = 0.0050425$
