Simultaneous MPE:

As per KDB 447498 D01, Simultaneous transmission MPE test exclusion applies when the sum of the MPE ratios for all simultaneous transmitting antennas incorporated in a host device, based on calculated or measured field strengths or power density, is ≤ 1.0 .

MPE 1 as obtains in 5.8GHz module transmission: 0.0044281mW/cm² MPE 2 as obtains in Bluetooth transmission: 0.0006144 mW/cm², where derivation of the power density can be referred EF/2012/C0011

 Σ MPE ratio = MPE1/MPE Limit + MPE2/MPE Limit = 0.0044281/1 + 0.0006144/1 = 0.0050425 0.0050425 < 1.0,

Therefore, simultaneous transmission MPE test can be excluded.
