2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). 



For BLE function, the engineering test program was provided and enabled to make EUT continuous transmit.

2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 5.6 dB and 10dB attenuator







6 dB Bandwidth Plot on Channel 19





6 dB Bandwidth Plot on Channel 39







3.2 Output Power Measurement

If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. 



- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.







PSD 100kHz Plot on Channel 39







PSD 100kHz Plot on Channel 19







PSD 3kHz Plot on Channel 39






For radiated emissions below 30MHz






