2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (X plane) were recorded in this report.
- b. AC power line Conducted Emission was tested under maximum output power.





2.5 EUT Operation Test Setup

For BLE function, the engineering test program was provided and enabled to make EUT continuous transmit.

For AC power line conducted emissions, the EUT was set to connect with the WLAN AP under large package sizes transmission.

2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 2.39 dB and 10dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 2.39 + 10 = 12.39 (dB)



- 5. For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set 1% to 5% of the 99% OBW and the VBW is set to 3 times of the RBW.

3.2 Output Power Measurement

3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.



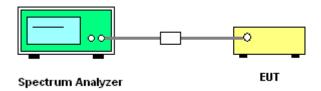

- 5. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
- 6. Measure and record the results in the test report.
- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.



Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

3.5 Radiated Band Edges and Spurious Emission Measurement

3.5.1 Limit of Radiated Band Edges and Spurious Emission

In any 100 kHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. If the output power of this device was measured by spectrum analyzer, the attenuation under this paragraph shall be 30 dB instead of 20 dB. 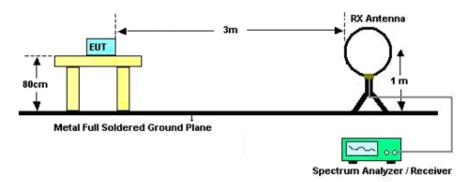
- 1. The testing follows ANSI C63.10-2013 clause 11.11 & 11.12
- 2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
- 3. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- The EUT was set 3 meters from the interference receiving antenna, which was mounted on the 4. top of a variable height antenna tower.
- 5. Corrected Reading: Antenna Factor + Cable Loss + Read Level - Preamp Factor = Level
- 6. For testing below 1GHz, if the emission level of the EUT in peak mode was 3 dB lower than the limit specified, then peak values of EUT will be reported, otherwise, the emissions will be repeated one by one using the CISPR quasi-peak method and reported.
- For testing above 1GHz, the emission level of the EUT in peak mode was 20dB lower than 7. peak limit (that means the emission level in average mode also complies with the limit in average mode), then peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
- 8. Use the following spectrum analyzer settings:
 - (1) Span shall wide enough to fully capture the emission being measured;
 - (2) Set RBW=100 kHz for f < 1 GHz; VBW ≥ RBW; Sweep = auto; Detector function = peak; Trace = max hold;
 - (3) Set RBW = 1 MHz, VBW= 3MHz for $f \ge 1$ GHz for peak measurement. For average measurement:
 - VBW = 10 Hz, when duty cycle is no less than 98 percent.
 - VBW ≥ 1/T, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.




For radiated emissions below 30MHz



3.7 Antenna Requirements

3.7.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the rule.


