2.2 Descriptions of Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction (150 kHz to 30 MHz), radiation (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). Pre-scanned tests, the worst mode of radiated spurious emissions is Bluetooth 1Mbps mode, and recorded in this report.
- b. AC power line Conducted Emission was tested under maximum output power.

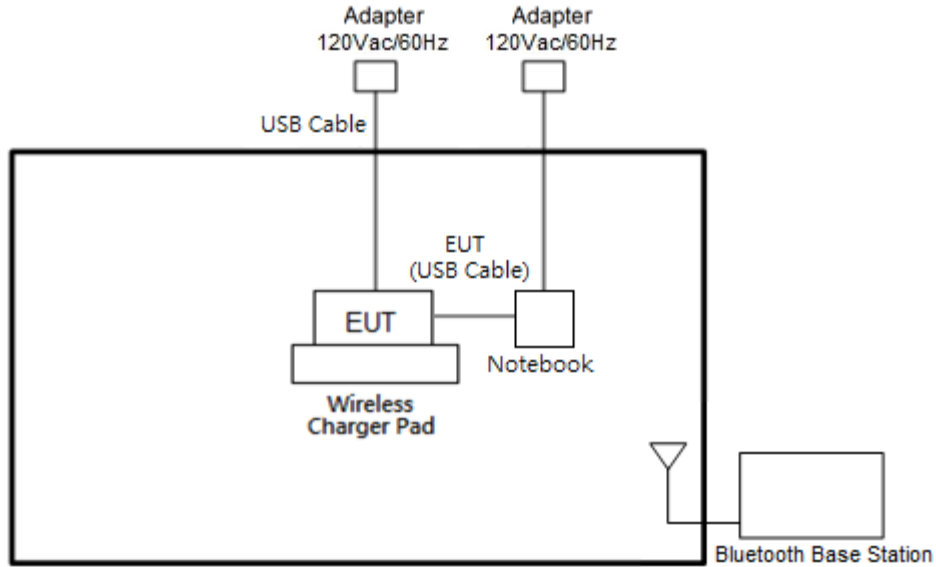

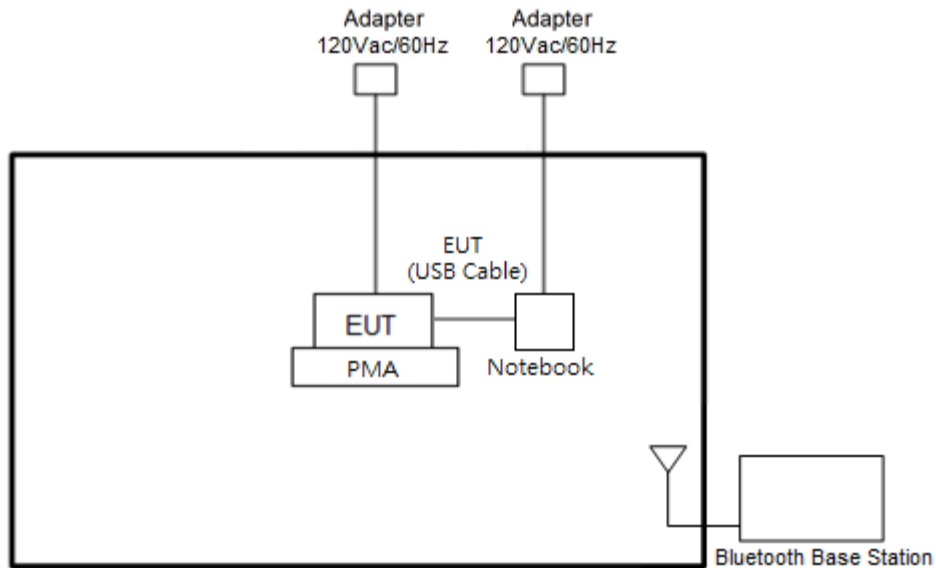

Remark:	
1. For radiated test cases, the worst mode data rate 1Mbps was reported only, because this data rate has the highest RF output power at preliminary tests, and the conducted spurious emissions and conducted band edge measurement for each data rate are no worse than 1Mbps, and no other significantly frequencies found in conducted spurious emission.	
2. The worst case of conducted emission is mode 2; only the test data of it was reported.

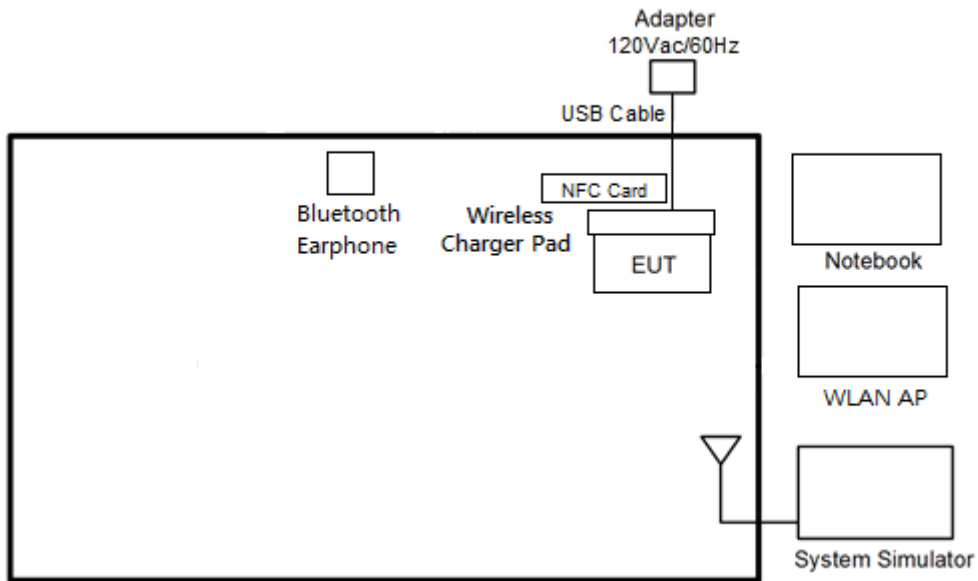
<Bluetooth Tx with WPC Charging Mode>



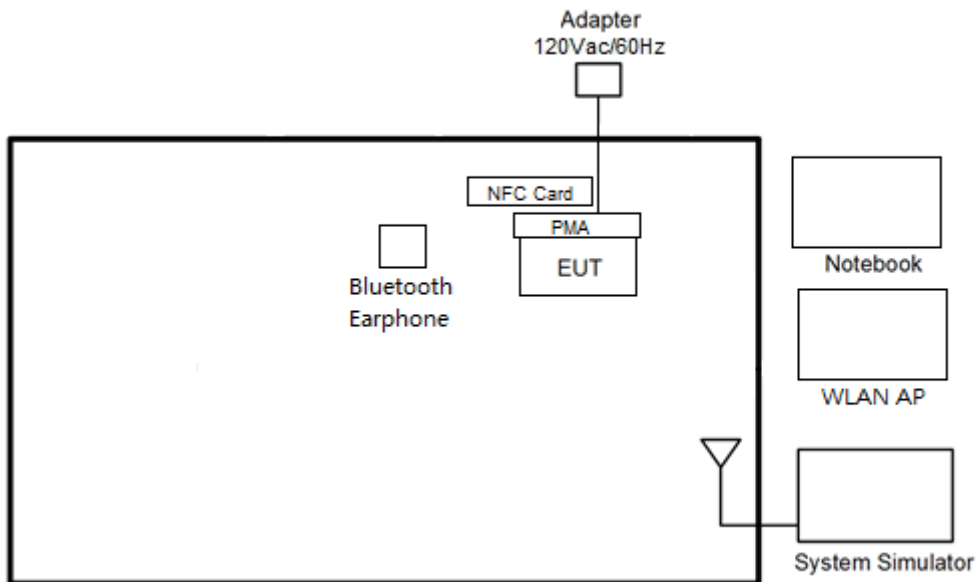
<Bluetooth Tx with PMA Charging Mode>

3 Test Result

3.1 Radiated Band Edges and Spurious Emission Measurement

3.1.1 Limit of Radiated Band Edges and Spurious Emission

In any 100 kHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. In addition, radiated emissions which fall in the restricted bands must also comply with the FCC section 15.209 limits as below.

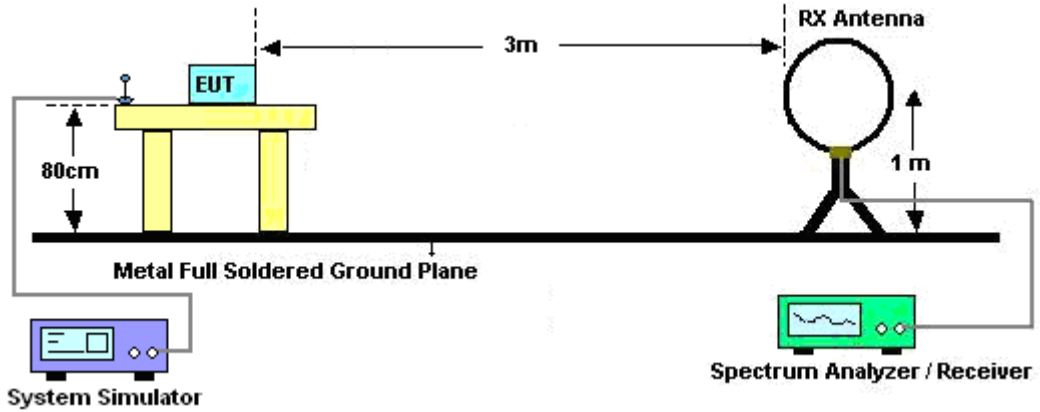
3.1.3 Test Procedures

1. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
1. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
2. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
3. Set to the maximum power setting and enable the EUT transmit continuously.
4. Use the following spectrum analyzer settings:
 - (1) Span shall wide enough to fully capture the emission being measured;
 - (2) Set RBW=100 kHz for $f < 1 \text{ GHz}$, RBW=1MHz for $f > 1\text{GHz}$; VBW \geq RBW; Sweep = auto; Detector function = peak; Trace = max hold for peak
 - (3) For average measurement: use duty cycle correction factor method per 15.35(c).
Duty cycle = On time/100 milliseconds
On time = $N_1 * L_1 + N_2 * L_2 + \dots + N_{n-1} * L_{n-1} + N_n * L_n$
Where N_1 is number of type 1 pulses, L_1 is length of type 1 pulses, etc.
Average Emission Level = Peak Emission Level + $20 * \log(\text{Duty cycle})$
5. Corrected Reading: Antenna Factor + Cable Loss + Read Level - Preamp Factor = Level

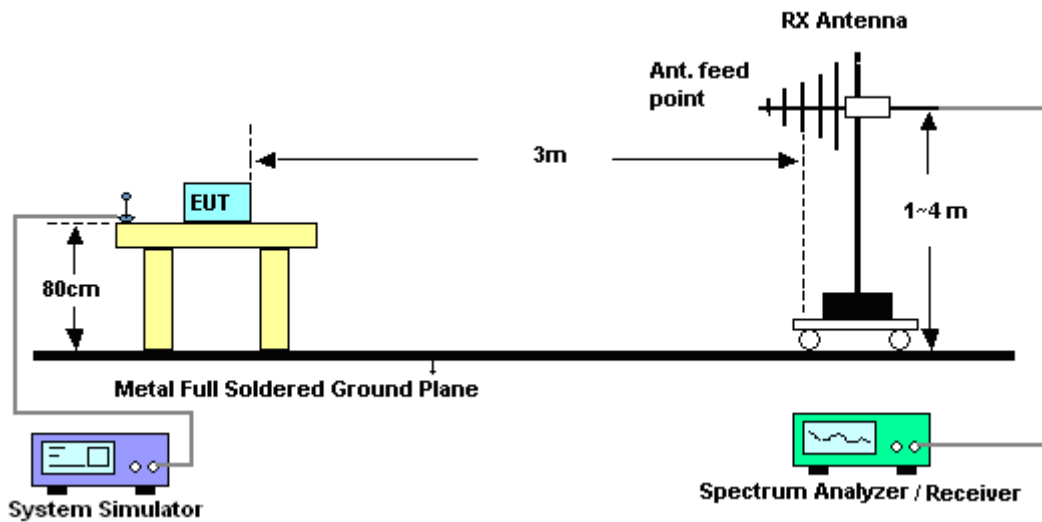
Note: The average levels were calculated from the peak level corrected with duty cycle correction factor (24.76dB) derived from $20 \log (\text{dwell time}/100\text{ms})$. This correction is only for signals that hop with the fundamental signal, such as band-edge and harmonic. Other spurious signals that are independent of the hopping signal would not use this correction.

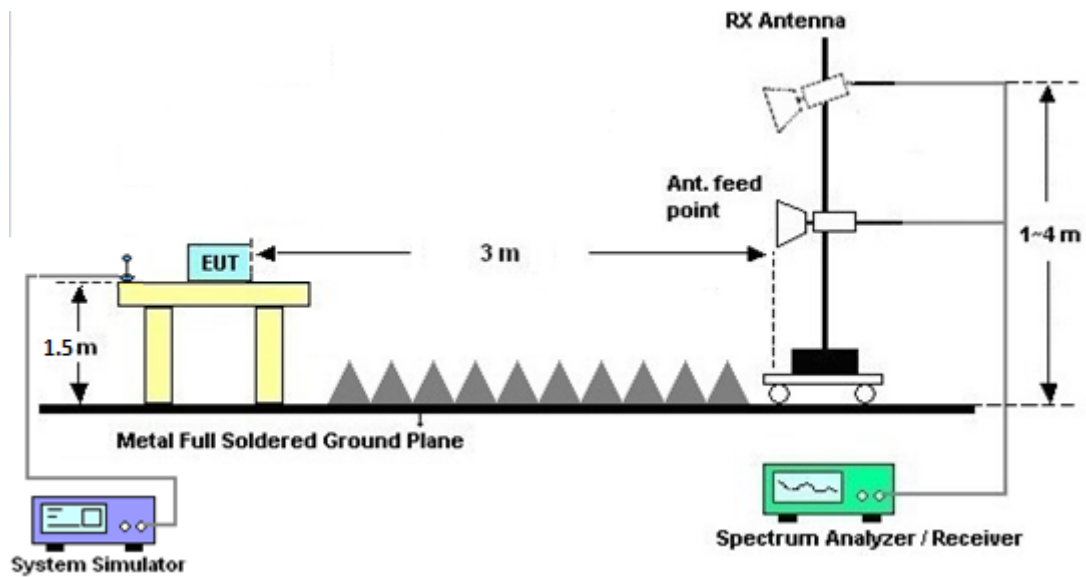
For radiated emissions below 30MHz

3.1.5 Test Results of Radiated Spurious Emissions (9 kHz ~ 30 MHz)

The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line per 15.31(o) was not reported.

3.2 AC Conducted Emission Measurement

3.2.1 Limit of AC Conducted Emission

For equipment that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table.

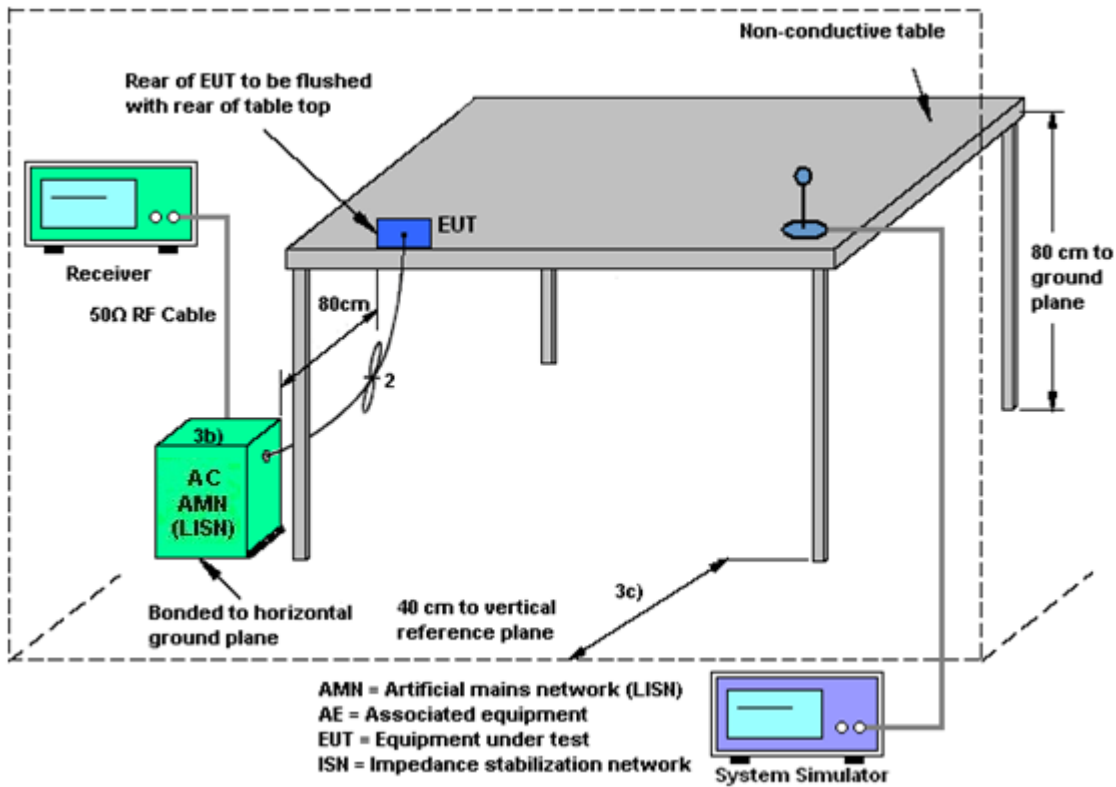
3.2.2 Measuring Instruments

The measuring equipment is listed in the section 4 of this test report.

3.2.3 Test Procedures

1. The EUT was placed 0.4 meter from the conducting wall of the shielding room was kept at least 80 centimeters from any other grounded conducting surface.
2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
3. All the support units are connecting to the other LISN.
4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
5. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
6. Both sides of AC line were checked for maximum conducted interference.
7. The frequency range from 150 kHz to 30 MHz was searched.
8. Set the test-receiver system to Peak Detect Function and specified bandwidth (IF Bandwidth = 9kHz) with Maximum Hold Mode. Then measurement is also conducted by Average Detector and Quasi-Peak Detector Function respectively.

Duty Cycle Correction Factor Consideration for AFH mode:

Bluetooth normal hopping rate is 1600Hz and reduced to 800Hz in AFH mode; due to the reduced number of hopping frequencies, with the same packet configuration the dwell time in each channel frequency within 100msec period is longer in AFH mode than normal mode.

In AFH mode, the minimum hopping frequencies are 20, to get the longest dwell time DH5 packet is observed; the period to have DH5 packet completing one hopping sequence is

$$2.87 \text{ ms} \times 20 \text{ channels} = 57.4 \text{ ms}$$

There cannot be 2 complete hopping sequences within 100ms period, considering the random hopping behavior, maximum 2 hops can be possibly observed within the period. $[100\text{ms} / 57.6\text{ms}] = 2$ hops

Thus, the maximum possible ON time:

$$2.87 \text{ ms} \times 2 = 5.74 \text{ ms}$$

Worst case Duty Cycle Correction factor, which is derived from the maximum possible ON time,

$$20 \times \log(5.74 \text{ ms}/100\text{ms}) = -24.82 \text{ dB}$$
