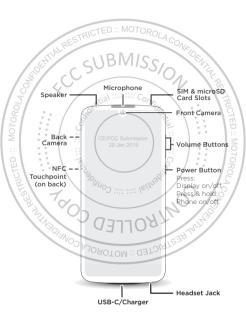

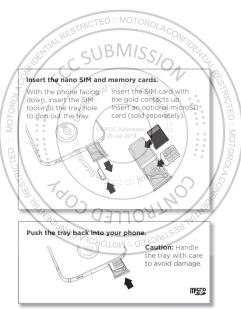

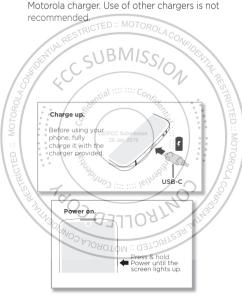




Finish up
