Exposure to RF energy & device operation

Your mobile device contains a transmitter and receiver of RF energy. It is designed to comply with regulatory requirements concerning human RF exposure.

For optimal device performance, and to stay within the RF exposure guidelines:

- Hold your mobile device normally at your ear when talking on it.
- When using the mobile device next to your body (other than in your hand or against your head), maintain a distance of 5 mm from your body to be consistent with how the mobile device is tested for compliance with RF exposure requirements.
- If you use your mobile device with a case or holder, make sure it maintains the required separation distance and has no metallic parts.

Specific absorption rate (SAR) is a measure of the rate at which a human body absorbs energy when exposed to a radio frequency (RF) electromagnetic field. The radio transmitter and receiver in your mobile device are designed to not exceed the SAR limits adopted by regulatory agencies. These SAR limits include a substantial safety margin designed to assure the safety of all persons, regardless of age and health.

Your mobile device meets the SAR limit established by the following regulatory agencies:

Regulatory agency	SAR limit
Federal Communications Commission (FCC)	1.6W/kg
Industry Canada (IC)	1.6W/kg
Ministry of Communication (India)	1.6W/kg
ICNIRP *	2W/kg

* ICNIRP tests are carried out in accordance with standards CENELEC EN50360 and IEC PT62209-1.
