2.2 Test Mode

Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. 





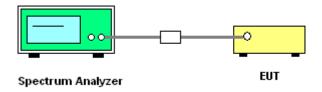





Channel Separation Plot on Channel 39 - 40






Channel Separation Plot on Channel 77 - 78

Hopping Mode High Band Edge Plot







Hopping Mode High Band Edge Plot





CSE Plot on Ch 39 between 30MHz ~ 3 GHz







CSE Plot on Ch 00 between 2 GHz ~ 25 GHz





CSE Plot on Ch 39 between 30MHz ~ 3 GHz






For radiated emissions below 30MHz

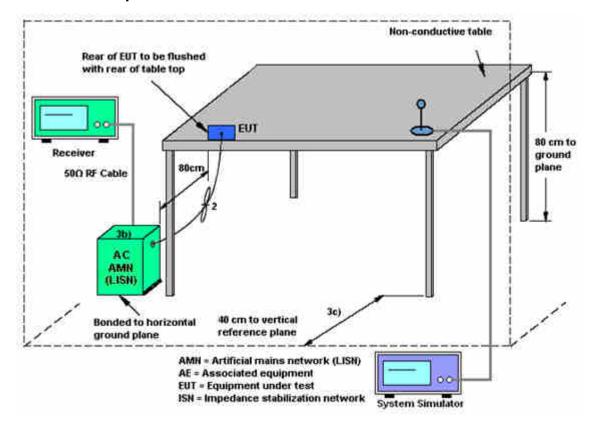

3.10 Antenna Requirements

3.10.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the rule.

The antenna peak gain of EUT is less than 6 dBi. Therefore, it is not necessary to reduce maximum peak output power limit.




