

3 Test Result

3.1 Maximum Conducted Output Power Measurement

3.1.1 Limit of Maximum Conducted Output Power

For the band 5.725–5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W.

If transmitting antennas of directional gain greater than 6 dBi are used, the peak output power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.


3.1.3 Test Procedures

Method PM (Measurement using an RF average power meter):

- 1. Measurement is performed using a wideband RF power meter.
- 2. The EUT is configured to transmit continuously with a consistent duty cycle at its maximum power control level.
- 3. Measure the average power of the transmitter, and the average power is corrected with duty factor, $10 \log(1/x)$, where x is the duty cycle.

3.2.1 Limit of Unwanted Emissions

- (1) For transmitters operating in the 5.725-5.85 GHz band: 15.407(b)(4)(i) All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.

 - (1) Procedure for Unwanted Emissions Measurements Below 1000MHz
 - RBW = 120 kHz
 - VBW = 300 kHz
 - Detector = Peak
 - Trace mode = max hold
 - (2) Procedure for Peak Unwanted Emissions Measurements Above 1000 MHz
 - RBW = 1 MHz
 - VBW ≥ 3 MHz
 - Detector = Peak
 - Sweep time = auto
 - Trace mode = max hold
 - (3) Procedures for Average Unwanted Emissions Measurements Above 1000MHz
 - RBW = 1 MHz
 - VBW = 10 Hz, when duty cycle is no less than 98 percent.
 - VBW ≥ 1/T, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.
- 2. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 3. The EUT was set 3 meters from the interference receiving antenna which was mounted on the top of a variable height antenna tower.
- 4. The antenna is a broadband antenna and its height is adjusted between one meter and four meters above ground to find the maximum value of the field strength for both horizontal polarization and vertical polarization of the antenna.
- 5. For each suspected emission, the EUT was arranged to its worst case and then adjust the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading.
- For testing below 1GHz, if the emission level of the EUT in peak mode was 3 dB lower than the limit specified, then peak values of EUT will be reported, otherwise, the emissions will be repeated one by one using the CISPR quasi-peak method and reported.
- 7. For testing above 1GHz, the emission level of the EUT in peak mode was 20dB lower than average limit (that means the emission level in average mode also complies with the limit in average mode), then peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.





For radiated emissions from 30MHz to 1GHz



The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line was not reported.

There is a comparison data of both open-field test site and semi-Anechoic chamber, and the result came out very similar.

3.3 Automatically Discontinue Transmission

3.3.1 Limit of Automatically Discontinue Transmission

The device shall automatically discontinue transmission in case of either absence of information to transmit or operational failure. These provisions are not intended to preclude the transmission of control or signaling information or the use of repetitive codes used by certain digital technologies to complete frame or burst intervals. Applicants shall include in their application for equipment authorization to describe how this requirement is met.




