2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Z plane) were recorded in this report.






6 dB Bandwidth Plot on Channel 19

3.2 Output Power Measurement

3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. 

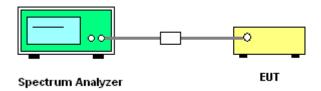



3.3.6 Test Result of Power Spectral Density Plots (100kHz)


PSD 100kHz Plot on Channel 00

PSD 100kHz Plot on Channel 19





PSD 100kHz Plot on Channel 39






PSD 3kHz Plot on Channel 00

PSD 3kHz Plot on Channel 19







Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.




Low Band Edge Plot on Channel 00




Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00




Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 19




Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 39



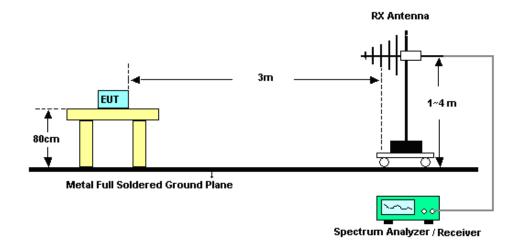

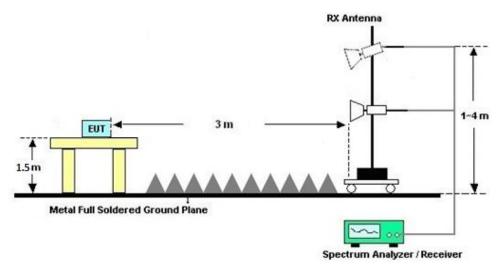
For radiated emissions below 30MHz
