2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). 

If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. 

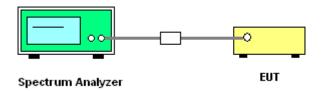

- 4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 3 kHz. Video bandwidth VBW = 10 kHz In order to make an accurate measurement, set the span to 1.5 times DTS Channel Bandwidth. (6dB BW)
- 5. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
- 6. Measure and record the results in the test report.
- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.






PSD 100kHz Plot on Channel 39

PSD 100kHz Plot on Channel 00






PSD 3kHz Plot on Channel 39




For radiated emissions below 30MHz


Bluetooth LE 1Mbps
