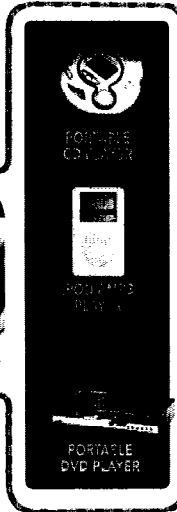
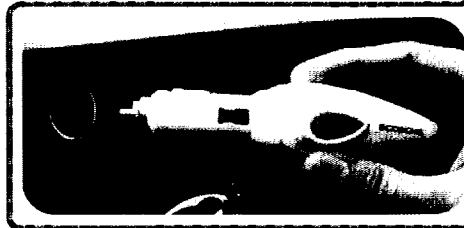


FMTRNS01

INSTALLATION AND OPERATING INSTRUCTIONS:

1. Plug in the FMTRNS01 into the cigarette lighter or 12V DC power socket in your dash.
 2. Plug in the 3.5 mm mini jack to the portable audio device (i.e. MP3 player, CD player, DVD player, etc.).
- NOTE:** Some devices have a LINE OUT and HEADPHONE JACK audio output. The HEADPHONE JACK output is recommended because the audio volume can be adjusted.
3. Once all connections are made, turn on radio and tune to either 88.1 MHz, 88.3 MHz, 88.5 MHz or 88.7 MHz as selected by the switch on the top of the FMTRNS01 unit. For future use, set the selected FM station as a "preset" on your stereo.
 4. Power up and play your auxiliary device. You should hear the audio from your auxiliary device playing through your car stereo speakers.



INSTRUCCIONES DE INSTALACIÓN Y OPERACIÓN.

1. Enchufe el FMTRNS01 en el encendedor de cigarrillos o en el enchufe de 12V CC de su tablero.
 2. Conecte la miniclavija de 3,5mm al aparato de audio portátil (como reproductor de MP3, CDs, DVDs, etc.).
- NOTA:** Algunos equipos tienen una salida de audio de LÍNEA ("LINE OUT") y de AURICULARES ("HEADPHONE"). Se recomienda usar la salida de AURICULARES ya que permite el ajuste del volumen de audio.
3. Una vez realizadas todas las conexiones, encienda la radio y sintonice en 88.1MHz, 88.3MHz, 88.5MHz u 88.7MHz de acuerdo a la selección de la llave en la parte de arriba del FMTRNS01. Para el futuro, programe la estación de FM seleccionada en una de las "memorias" de su estéreo.
 4. Encienda y haga funcionar su dispositivo auxiliar. Deberá escuchar el audio de su dispositivo auxiliar a través de los parlantes de su estéreo.
