## 5.4. EXPOSURE OF HUMANS TO RF FIELD [[§§ 1.1310 & 2.1091]

The criteria listed in the following table shall be used to evaluate the environmental impact of human exposure to radio-frequency (RF) radiation.

NOTE 1 TO TABLE 1: Occupational/controlled limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. Limits for occupational/controlled exposure also apply in situations when an individual is transient through a location where occupational/controlled limits apply provided he or she is made aware of the potential for exposure.

NOTE 2 TO TABLE 1: General population/uncontrolled exposures apply in situations in which the general public may be exposed, or in which persons that are exposed as a consequence of their employment may not be fully aware of the potential for exposure or can not exercise control over their exposure.

# 5.4.1. Method of Measurements

In order to demonstrate compliance with MPE requirements, the following information is typically needed:

- (1) Calculation that estimates the minimum separation distance (20 cm or more) between an antenna and persons required to satisfy power density limits defined for free space.
- (2) Antenna installation and device operating instructions for installers (professional/unskilled users), and the parties responsible for ensuring compliance with the RF exposure requirement
- (3) Any caution statements and/or warning labels that are necessary in order to comply with the exposure limits
- (4) Any other RF exposure related issues that may affect MPE compliance

## **Calculation Method of RF Safety Distance:**

$$S = \frac{P \cdot G}{4 \cdot \pi \cdot r^2} = \frac{EIRP}{4 \cdot \pi \cdot r^2}$$

Where: P: power input to the antenna in mW

EIRP: Equivalent (effective) isotropic radiated power

S: power density mW/cm<sup>2</sup>

G: numeric gain of antenna relative to isotropic radiator

r: distance to centre of radiation in cm

P = 2.884 W, 34.60 dBm

G = 3 dBi (Maximum antenna gain to be used with this device as declared by the manufacturer)
