To begin with we want to thank you for including the excerpt from the FCC text, because it makes it clear to us that you have a serious worry. However, from it we can not establish unambiguously whether or not we comply, because as you already stated the definition of what is standard is not unambiguous. We can say, with regard to the MC-card connector series, that it is a proprietary Radiall design. It is not in any way standardized and it is our experience that the type of application it is intended for, nearly always requires specialized designs, which would mean that it is not in our interest to pursue normalization.

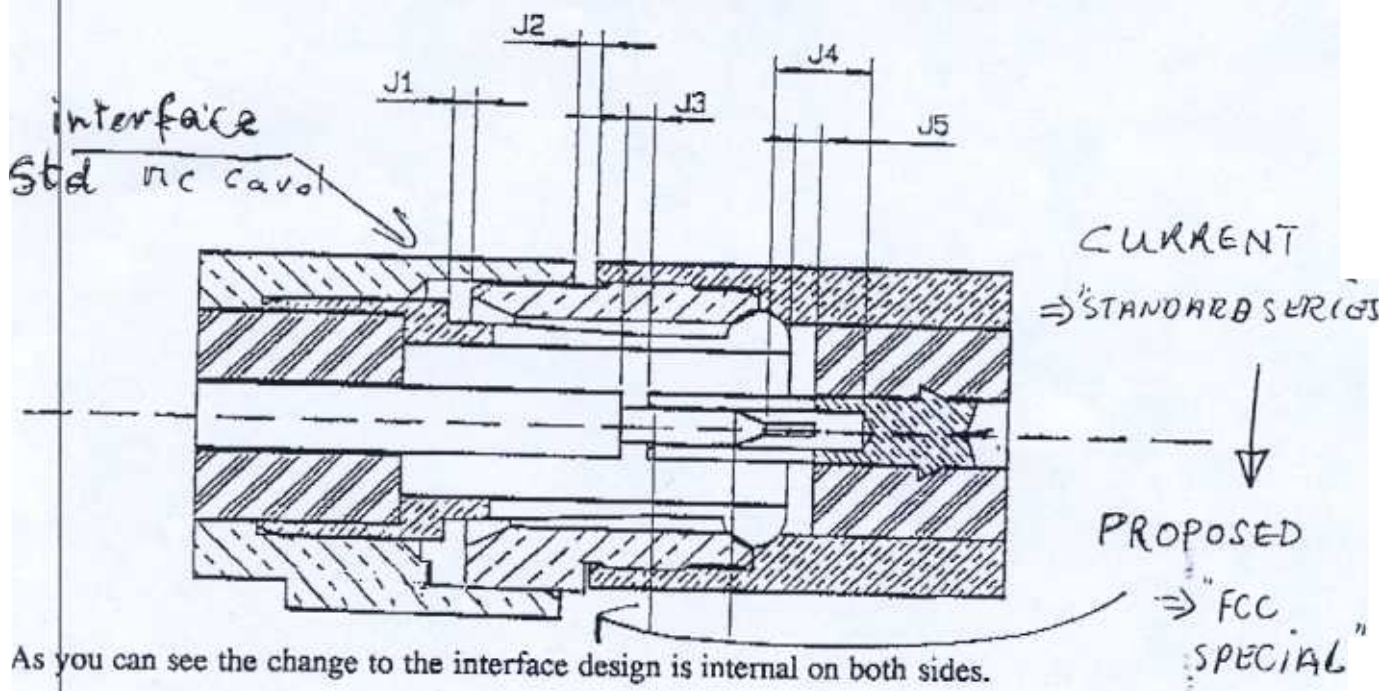
