Equipment Function and Configuration

The EUT is a GPS mapping display and interface system providing interface options as presented in configuration diagrams. The circuitry is provided in alternate configurations offering reduced functionality. Preliminary testing was performed and final emissions testing performed on worst-case configuration. The completed system offers end user ability to utilize GPS information for display of location and navigational aid. The EUT incorporates a low power transmitter with operation capability in the 2402-2480 MHz frequency band (CFR 47 15.249 and RSS-210). The design utilizes internal fixed antenna system and offers no provision for antenna replacement or modification. Two samples were provided for testing, one production design and the other modified for testing purposes replacing integral antenna with RF connection port. Both samples were provided with test software enabling testing personnel ability to enable transmitter function on defined channels. The antenna modification offered testing facility ability to connect transmitter antenna port to test equipment for antenna port conducted emissions testing. The EUT was arranged as typical user equipment configurations for testing purposes. The transmitter offers no other interface connections than those in the configuration diagrams shown below. The unit operates from power received from the supporting equipment and system. For testing purposes, the EUT received powered from external DC supply powering supporting equipment and was configured to transmit in available data modes. As requested by the manufacturer and required by regulations, the equipment was tested for emissions compliance using the available configurations with the worst-case data presented. Test results in this report relate only to the products described in this report.

Applicable Standards & Test Procedures

In accordance with the Federal Communications Code of Federal Regulations, dated October 1, 2012, Part 2, Subpart J, Paragraphs 2.907, 2.911, 2.913, 2.925, 2.926, 2.1031 through 2.1057, and applicable parts of paragraph 15, Part 15C Paragraph 15.249, and RSS-210 the following information is submitted. Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.4-2009 and ANSI C63.10-2009. Testing for the AC line-conducted emissions were performed as defined in sections 7 and 13.1.3, testing of the radiated emissions was performed as defined in sections 8 and 13.1.4 of ANSI C63.4-2009. Testing of the radiated emissions was performed as required including procedures in section 13 of ANSI C63.4-2009.

Equipment Testing Procedures

AC Line Conducted Emission Test Procedure

The EUT operates solely from direct current power and offers no provision for connection to utility AC power systems. Therefore, no AC power line conducted emissions test was required or performed. If required, the manufacturer supplied AC connection would be used to power the EUT. Testing for the AC line-conducted emissions testing would be performed as defined in sections 7 and 13.1.3 of ANSI C63.4-2009. The test setup including the EUT would be arranged in typical equipment configurations and placed on a 1 x 1.5-meter wooden bench, 0.8 meters high located in a screen room. The power lines of the system would be isolated from the power source using a standard LISN with a 50-µHy choke. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor internal to the LISN. The LISN would be positioned on the floor beneath the wooden bench supporting the EUT. The power lines and cables would be draped over the back edge of the table. Refer to diagram 1 showing typical test arrangement and photographs in the test setup exhibits for specific EUT placement during testing.



- 1. Interconnecting cables that hang closer than 40 cm to the ground plane were folded back and forth in the center forming a bundle 30 cm to 40 cm long.
- 2. Input/output (I/O) cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- 3. EUT connected to one LISN. Unused LISN measuring port connectors are terminated into 50 Ω loads. LISN is placed on top of and bonded to reference ground plane.
- 3.1 All other equipment powered from additional LISN(s).
- 3.2 Multiple outlet strips can be used for multiple power cords of non-EUT equipment.
- 3.3 LISN is positioned at least 80 cm from nearest part of EUT chassis.
- 4. Cables of hand-operated devices, such as keyboards, mice, and so on, shall be placed as for normal use.
- 5. Non-EUT components of EUT system being tested.
- 6. Rear of EUT, including peripherals, shall all be aligned and flush with rear of tabletop.

Radiated Emission Test Procedure

The EUT was placed on a rotating 1 x 1.5-meter wooden platform, 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. Radiated emissions testing was performed as required in CFR47 15, RSS-210 and specified in sections 8 and 13.1.4 of ANSI C63.4-2009. EMI energy was maximized by equipment placement, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. The frequency spectrum from 9 kHz to 25,000 MHz was searched for during preliminary investigation. Refer to diagrams 2 and 3 showing typical test arrangement and photographs in the test setup exhibits for specific EUT placement during testing.



- 3. If LISNs are kept in the test setup for radiated emissions, it is preferred that they be installed under the ground plane with the receptacle flush with the ground plane.
- 4. Cables of hand-operated devices, such as keyboards, mice, and so on, shall be placed as for normal use.
- 5. Non-EUT components of EUT system being tested.
- 6. Rear of EUT, including peripherals, shall all be aligned and flush with rear of tabletop (possibly center of table for transmitter equipment).
- 7. No vertical conducting plane used.
- 8. Power cords drape to the floor and are routed over to receptacle.

Intentional Radiators

As per CFR47, Subpart C, paragraph 15.249 and RSS-210 the following information is submitted.

Antenna Requirements

The EUT incorporates integral antenna system and offers no provision for connection to alternate system. The antenna connection point complies with the unique antenna connection requirements. The unique antenna connection requirements are fulfilled. There are no deviations or exceptions to the specification.

Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.4-2009 paragraphs 13.1 and 8.3.1.2 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values take into account the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available modes with worst-case data recorded. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated emissions measurements were performed. 


Figure 1 Plot of Transmitter Emissions (Output in Operational Band)




Figure 2 Plot of Transmitter Emissions (Occupied Bandwidth)

Figure 3 Plot of Transmitter Emissions (Low Band Edge)




Figure 4 Plot of Low Band Edge (High Band Edge)
