

Equipment Function and Configuration

The EUT is a transceiver providing communication with compatible equipment operating in the 2402-2480 MHz frequency band. The design offers interface capabilities wirelessly with compliant equipment and operates from direct current power received from installation vehicle only. The design utilizes an internal fixed antenna system and offers no provision for antenna replacement or modification. Two samples were provided for testing, one representative of production design and the other modified for testing purposes, replacing the integral antenna with an RF connection port. Both samples were provided with test software enabling testing personnel the ability to enable transmitter function on defined channels. The antenna modification offered testing facility the ability to connect test equipment to the temporary antenna port for antenna port conducted emission testing. The EUT provides several wired serial interface connections, which are used to interface with installed aircraft equipment. The wireless connectivity is used to connect to compliant portable equipment. The EUT provides wireless connectivity to electronics allowing portable electronics to stream data to and from installed equipment. The EUT was arranged as described by the manufacturer for testing purposes. This configuration required interface with a laptop computer, which provided control of the transmitter for testing purposes. The EUT offers no other interface connections than those as described above as presented by the manufacturer. For testing purposes, the EUT received power from an external bench DC power supply, configured to operate in available modes. As requested by the manufacturer and required by regulations, the equipment was tested for emissions compliance using the available configurations with the worst-case data presented. Test results in this report relate only to the products described in this report.

Testing of the radiated emissions was performed as defined in sections 6 and 7 of ANSI C63.10-2009.

Equipment Testing Procedures


AC Line Conducted Emission Test Procedure

The device operates from direct current power only and offers no provision for connection to utility AC power systems. Therefore, no AC line conducted emissions testing was required or performed.

Radiated Emission Test Procedure

The EUT was placed on a rotating 1 x 1.5-meter wooden platform, 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. Radiated emissions testing was performed as required in CFR47 15, RSS-210 and specified in sections 6 and 7 of ANSI C63.10-2009. EMI energy was maximized by equipment placement, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. The frequency spectrum from 9 kHz to 25,000 MHz was searched for during preliminary investigation. Refer to diagrams 1 and 2 showing typical test arrangement and photographs in the test setup exhibits for specific EUT placement during testing.



Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.10-2009 paragraph 6 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values take into account the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

Summary of Results for Radiated Emissions in Restricted Bands

The EUT demonstrated compliance with the radiated emissions requirements of CFR 47 Part 15C and RSS-210 Intentional Radiators. The EUT demonstrated a worst-case minimum margin of -16.0 dB below the emissions requirements in restricted frequency bands. Peak, Quasi-peak, and average amplitudes were checked for compliance with the regulations. Worst-case emissions are reported with other emissions found in the restricted frequency bands at least 20 dB below the requirements.

General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available modes with worst-case data recorded. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated emissions measurements were performed. Final data was taken with the EUT located at the OATS at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. 




Figure 1 Plot of Transmitter Emissions (In 2402-2480 MHz Band)


Figure 2 Plot of Transmitter Emissions (99% Occupied Bandwidth) (GFSK)


Figure 4 Plot of Transmitter Emissions (99% Occupied Bandwidth) (8-DPSK)
