#### **Equipment Function**

The EUT is a portable GPS enabled digital recording device with incorporated wireless transmitters. The device provides ability for recording and position information and incorporates interface options as presented below in configuration diagrams. A completed system offers end user ability to utilize received GPS information for tracking location and recording for personal use while providing wireless connectivity. The EUT incorporates low power transmitter with operation capability in the 2402-2480 MHz band and Wi-Fi capability across the 2412-2462 MHz frequency band. The design provides wireless communications in one of the supported modes providing wireless interface capabilities with compliant equipment. The product operates from internal rechargeable battery only. Recharge of internal battery is provided using the USB interface while connected to compatible AC or DC adapter or standard USB interface port. The design utilizes internal fixed antenna systems and offers no provision for antenna replacement or modification. Two samples were provided for testing, one representative of production hardware design, and the other modified for testing purposes replacing integral antenna with RF connection port. The test samples were provided with test software enabling testing personnel the ability to enable transmitter functions on defined channels and modes. The antenna modification offered testing facility the ability to connect test equipment to the temporary antenna port for antenna port conducted emission testing. The EUT was arranged as described by the manufacturer emulating typical user configurations for testing purposes. The EUT offers no other interface connections than those in the configuration options as presented and described by the manufacturer. For testing purposes, the EUT received powered from freshly charged internal battery and /or while interfaced with compatible charging interfaces and configured to operate in available modes. As requested by the manufacturer and required by regulations, the equipment was tested for emissions compliance using the available configurations with the worst-case data presented. Test results in this report relate only to the products described in this report.






1. A03125 operating off internal Li-Ion Battery.




2. A03125 internal battery charged by PC through USB cable.






5. A03125 internal battery charged by CLA through USB cable.

#### **Applicable Standards & Test Procedures**

In accordance with the Federal Communications Code of Federal Regulations, dated October 31, 2016: Part 2, Subpart J, Paragraphs 2.907, 2.911, 2.913, 2.925, 2.926, 2.1031 through 2.1057, and applicable parts of paragraph 15, Part 15C Paragraph 15.249, Industry Canada RSS-210 issue 9, and RSS-GEN issue 4 operation in the 2400 – 2483.5 MHz Frequency band. Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.10-2013.

#### **Equipment Testing Procedures**

#### AC Line Conducted Emission Test Procedure

Testing for the AC line-conducted emissions was performed as required in CFR47 15C, RSS-210 and specified in ANSI C63.10-2013. The test setup, including the EUT, was arranged in the test configurations as presented during testing. The test configuration was placed on a 1 x 1.5-meter bench, 0.8 meters high located in a screen room. The power lines of the system were isolated from the power source using a standard LISN with a 50-µHy choke. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor internal to the LISN. The LISN was positioned on the floor beneath the wooden bench supporting the EUT. The power lines and cables were draped over the back edge of the table. Refer to diagram one showing typical test arrangement and photographs in exhibits for EUT placement used during testing.

#### Radiated Emission Test Procedure

The EUT was placed on a rotating 0.9 x 1.2-meter platform, elevated as required above the ground plane at a distance of 3 meters from the FSM antenna. Radiated emissions testing was performed as required in the regulations and specified in ANSI C63.10-2013. EMI energy was maximized by equipment placement permitting orientation in three orthogonal axes, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken and recorded. The frequency spectrum from 9 kHz to 25,000 MHz was searched for emissions during preliminary investigation. Refer to diagrams two and three showing typical test setup. Refer to photographs in the test setup exhibits for specific EUT placement during testing.



- 1. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 cm to 40 cm long see (see 6.2.3.1).






Diagram 3 Test arrangement for radiated emissions tested on Open Area Test Site (OATS)

#### Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.10-2013 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values take into account the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

#### Summary of Results for Radiated Emissions in Restricted Bands

The EUT demonstrated compliance with the radiated emissions requirements of 47CFR Part 15C and RSS-210 Intentional Radiator requirements. The EUT demonstrated a worst-case minimum margin of -16.9 dB below the emissions requirements in restricted frequency bands. Peak, Quasi-peak, and average amplitudes were checked for compliance with the regulations. #### **AC Line Conducted Emissions Procedure**

The EUT was arranged in typical equipment configurations operating from AC power. Testing was performed with the EUT placed on a 1 x 1.5-meter wooden bench 80 cm above the conducting ground plane, floor of a screen room. The bench was positioned 40 cm away from the wall of the screen room. The LISN was positioned on the floor of the screen room 80-cm from the rear of the EUT. Testing for the line-conducted emissions were the procedures of ANSI C63.10-2013 paragraph 6. The EUT was connected to the laptop computer with its AC adapter connected to the LISN for line-conducted emissions testing. A second LISN was positioned on the floor of the screen room 80-cm from the rear of the supporting equipment of the EUT. All power cords except the E were then powered from the second LISN. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor, internal to the LISN. Power line conducted emissions testing was carried out individually for each current carrying conductor of the EUT. The excess length of lead between the system and the LISN receptacle was folded back and forth to form a bundle not exceeding 40 cm in length. The screen room, conducting ground plane, analyzer, and LISN were bonded together to the protective earth ground. Preliminary testing was performed to identify the frequencies of each of the emissions, which demonstrated the highest amplitudes. The cables were repositioned to obtain maximum amplitude of measured EMI level. Once the worst-case configuration was identified, plots were made of the EMI from 0.15 MHz to 30 MHz then data was recorded with maximum conducted emissions levels.




Figure 1 AC Line Conducted emissions of EUT line 1 (#2, EUT - CPU)




Figure 2 AC Line Conducted emissions of EUT line 2 (#2, EUT - CPU)




Figure 3 AC Line Conducted emissions of EUT line 1 (#3, EUT - AC Adapter)




Figure 4 AC Line Conducted emissions of EUT line 2 (#3, EUT – AC Adapter)

#### General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available mode during testing. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated emissions measurements were performed. Final data was taken with the EUT located at the OATS at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Loop from 9 kHz to 30 MHz, Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers above 1 GHz, notch filters and appropriate amplifiers and external mixers were utilized.

#### Summary of Results for General Radiated Emissions

The EUT demonstrated compliance with the radiated emissions requirements of CFR47 Part 15C paragraph 15.209 and RSS-210 and RSS-GEN Intentional Radiators. The EUT demonstrated a minimum margin of -11.4 dB below the requirements. Other emissions were present with amplitudes at least 20 dB below the Limits.

#### Operation in the Band 2400 – 2483.5 MHz

The transmitter output power; harmonic and general emissions were measured on an open area test site @ 3 meters. The EUT was placed on a turntable elevated as required above the ground plane and at a distance of 3 meters from the FSM antenna. The peak and quasi-peak amplitude of frequencies below 1000 MHz were measured using a spectrum analyzer. The peak and average amplitude of frequencies above 1000 MHz were measured using a spectrum analyzer. The amplitude of each emission was then recorded from the analyzer display. Emissions radiated outside of the specified bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits, whichever is the lesser attenuation. Plots were taken of transmitter performance for reference in this and other documentation using test samples #2. The amplitude of each radiated emission was measured on the OATS at a distance of 3 meters from the FSM antenna testing was performed on sample representative of production with integral antenna (samples #1) with worse case data provided. The amplitude of each radiated emission was maximized by equipment placement, raising, and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable by varying the FSM antenna height, polarization, and by rotating the turntable. A Loop antenna was used for measuring emissions from 0.009 to 30 MHz, Biconilog Antenna for 30 to 1000 MHz, Double-Ridge, and/or Pyramidal Horn Antennas from 1 GHz to 25 GHz. Emissions were measured in  $dB\mu V/m$  @ 3 meters.




Figure 5 Plot of Transmitter Emissions (Operation in 2402-2479 MHz, ANT)




Figure 6 Plot of Transmitter Emissions (99% Occupied Bandwidth, ANT)




Figure 9 Plot of Transmitter Emissions (Low Band Edge, ANT)




Figure 10 Plot of Transmitter Emissions (High Band Edge, ANT)




Figure 11 Plot of Transmitter Emissions (Operation in 2402-2480 MHz, BT EDR2)




Figure 12 Plot of Transmitter Emissions (99% Occupied Bandwidth, BT EDR2)




Figure 13 Plot of Transmitter Emissions (Low Band Edge, BT EDR2)




Figure 14 Plot of Transmitter Emissions (High Band Edge, BT EDR2)




Figure 15 Plot of Transmitter Emissions (Operation in 2402-2480 MHz, BT EDR3)




Figure 16 Plot of Transmitter Emissions (99% Occupied Bandwidth, BT EDR3)




Figure 17 Plot of Transmitter Emissions (Low Band Edge, BT EDR3)




Figure 18 Plot of Transmitter Emissions (High Band Edge, BT EDR3)
