

Equipment Function

The EUT is a portable digital device. The device incorporates sensors to log movement and other physical functions and includes digital transmitters for communication with compatible equipment. The design offers no other interface options as described by the manufacture and presented below in the configuration diagrams. The low power transmitters provide operation capability in the 2402-2480 MHz frequency band and the Wi-Fi transmitter operates in the 2412-2462 MHz band. The design offers wireless communication in one of four modulation modes (mode 1 ANT, mode 2 BT GFSK, mode 3 BLE, and mode 4 802.11b,g,n) providing wireless interface with compatible equipment. The product operates from internal rechargeable battery only and offers no other provision for alternate power sources as documented. The design utilizes internal fixed antenna system and offers no provision for antenna replacement or modification. Two samples were provided for testing, one representative of production design, and the other modified for testing purposes replacing the integral antennas with 50-ohm RF connection port. The test samples were provided with test software enabling testing personnel ability to enable transmitter function on defined channels. The antenna modification offered testing facility the ability to connect test equipment to the temporary antenna port for antenna port conducted emission testing. The EUT was arranged as described by the manufacturer emulating typical user configurations for testing purposes. For testing purposes, the EUT received powered from freshly charged internal battery and/or external power and configured to operate in available modes. As requested by the manufacturer and required by regulations, the equipment was tested for emissions compliance using the available configurations with the worst-case data presented. The test software enabled extremely high duty cycles approaching 100% transmission for testing purposes. The production product will not operate at these high duty cycles. This report documents compliance testing and results for applicable product modes of operation. Test results in this report relate only to the products described in this report.






1) Unit operating off internal battery




2) Unit connected to (and powered by) AC adapter through USB cable (GPN: 320-01069-20)

Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.10-2013.

Testing Procedures

AC Line Conducted Emission Test Procedure


Testing for the AC line-conducted emissions was performed as required in 47CFR 15C, RSS-247 and specified in ANSI C63.10-2013. The test setup, including the EUT, was arranged in the test configurations as presented during testing. The test configuration was placed on a 1 x 1.5-meter bench, 0.8 meters high located in a screen room. The power lines of the system were isolated from the power source using a standard LISN with a 50- μ Hy choke. EMI was coupled to the spectrum analyzer through a 0.1 μ F capacitor internal to the LISN. The LISN was positioned on the floor beneath the wooden bench supporting the EUT. The power lines and cables were draped over the back edge of the table. Refer to diagram one showing typical test arrangement and photographs in exhibits for EUT placement used during testing.

Radiated Emission Test Procedure

Radiated emissions testing was performed as required in CFR47 15, RSS-247 and specified in ANSI C63.10-2013. The EUT was placed on a rotating 0.9 x 1.2-meter platform, elevated as required above the ground plane at a distance of 3 meters from the FSM antenna. EMI energy was maximized by equipment placement permitting orientation in three orthogonal axes, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. The frequency spectrum from 9 kHz to 25,000 MHz was searched for during preliminary investigation. Refer to diagrams two and three showing typical test arrangement and photographs in the test setup exhibits for specific EUT placement during testing.



- 1. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 cm to 40 cm long see (see 6.2.3.1).
- 2. I/O cables that are not connected to an accessory shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m (see 6.2.2).



Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.10-2013 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values consider the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

Summary of Results for Radiated Emissions in Restricted Bands

The EUT demonstrated compliance with the radiated emissions requirements of 47CFR Part 15C RSS-Gen, and RSS-247 Intentional Radiators. The EUT worst-case ANT mode 1 demonstrated a minimum radiated emission margin of -10.9 dB below the requirements in restricted frequency bands. The EUT worst-case BT mode 2 demonstrated a minimum radiated emission margin of - 8.1 dB below the requirements in restricted frequency bands. The EUT worst-case BLE mode 3 demonstrated a minimum radiated emission margin of -8.0 dB below the requirements in restricted frequency bands. The EUT worst-case 802.11 mode 4 demonstrated a minimum radiated emission margin of -16.9 dB below the requirements in restricted frequency bands. Peak, Quasi-peak, and average amplitudes were checked for compliance with the regulations. Worst-case emissions are reported with other emissions found in the restricted frequency bands at least 20 dB below the requirements.

AC Line Conducted Emissions Procedure

The EUT was arranged in typical equipment configurations operating from AC power adapter. Testing was performed with the EUT placed on a 1 x 1.5-meter wooden bench 80 cm above the conducting ground plane, floor of a screen room. The bench was positioned 40 cm away from the wall of the screen room. The LISN was positioned on the floor of the screen room 80-cm from the rear of the EUT. Testing for the line-conducted emissions were the procedures of ANSI C63.10-2013 paragraph 6. The AC adapter for the EUT was connected to the LISN for lineconducted emissions testing. A second LISN was positioned on the floor of the screen room 80cm from the rear of the supporting equipment of the EUT. All power cords except the EUT were then powered from the second LISN. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor, internal to the LISN. Power line conducted emissions testing was carried out individually for each current carrying conductor of the EUT. The excess length of lead between the system and the LISN receptacle was folded back and forth to form a bundle not exceeding 40 cm in length. The screen room, conducting ground plane, analyzer, and LISN were bonded together to the protective earth ground. Preliminary testing was performed to identify the frequencies of each of the emissions, which demonstrated the highest amplitudes. The cables were repositioned to obtain maximum amplitude of measured EMI level. Once the worst-case configuration was identified, plots were made of the EMI from 0.15 MHz to 30 MHz then data was recorded with maximum conducted emissions levels.




Figure 1 AC Line Conducted emissions of EUT line 1 (#2, EUT – 362-00091-00)




Figure 2 AC Line Conducted emissions of EUT line 2 (#2, EUT – 362-00091-00)




Figure 3 AC Line Conducted emissions of EUT line 1 (#3, EUT – Computer)




Figure 4 AC Line Conducted emissions of EUT line 2 (#3, EUT – Computer)

General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available mode during testing. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated measurements were performed. Final data was taken with the EUT located on the OATS at 3 meters distance between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Loop from 9 kHz to 30 MHz, Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers above 1 GHz, notch filters and appropriate amplifiers and external mixers were utilized.

Summary of Results for General Radiated Emissions

The EUT demonstrated compliance with the radiated emissions requirements of CFR47 Part 15C paragraph 15.209, RSS-247 and RSS-GEN Intentional Radiators. The EUT demonstrated a minimum margin of -11.6 dB below the requirements. Other emissions were present with amplitudes at least 20 dB below the Limits.

Operation in the Band 2400 – 2483.5 MHz

Test procedures of ANSI C63.10-2013 paragraph 6, and KDB 558074 v04 were used during transmitter testing. The peak output power of modes 1 through 3 were measured at the antenna port using a spectrum analyzer as described in KDB 558074 (9.1.1). The mode 4 wideband transmitter average power was measured at the antenna port using a wideband RF power meter as described in KDB 558074 (9.2.3). The peak Power Spectral Density (PKPSD) of all modes were measured as defined in KDB 558074 (10.2). DTS Emission bandwidth was measured as described in KDB 558074 paragraph 8, and C63.10-2013. The amplitude of each harmonic and general radiated emission was measured on the OATS at distance of 3 meters from the FSM antenna (testing was performed on sample 1 representative of production equipment with integral antenna). The EUT was positioned on supporting turntable elevated as required above the ground plane, at a distance of 3 meters from the FSM antenna. Radiated emission investigations were performed from 9 kHz to 25,000 MHz. Each radiated emission was maximized by varying the FSM antenna height and polarization, and by rotating the turntable. The worst-case amplitude of each emission was then recorded from the analyzer display. The peak and quasipeak amplitude of frequencies below 1000 MHz were measured using a spectrum analyzer. The peak and average amplitude of frequencies above 1000 MHZ were measured using a spectrum analyzer. A Loop antenna was used for measuring emissions from 0.009 to 30 MHz, Biconilog Antenna for 30 to 1000 MHz, Double-Ridge, and/or Pyramidal Horn Antennas from 1 GHz to 25 GHz. Radiated Emissions were measured in dBµV/m @ 3 meters. Test sample #2 was provided for testing antenna port conducted emissions. This sample was modified by replacing the internal antenna with a 50-ohm antenna port connector for testing purposes. Plots were taken of transmitter performance (using sample #2) for reference in this and other documentation.




Figure 5 Plot of Transmitter Emissions in Operational Frequency (ANT-Mode 1)




Figure 6 Plot of Transmitter Emissions in Operational Frequency (BT GFSK-Mode 2)




Figure 7 Plot of Transmitter Emissions in Operational Frequency (BLE-Mode 3)




Figure 8 Plot of Transmitter Emissions in Operational Frequency (802.11 b-Mode 4)




Figure 9 Plot of Transmitter Emissions in Operational Frequency (802.11 g-Mode 4)




Figure 10 Plot of Transmitter Emissions in Operational Frequency (802.11 n-Mode 4)




Figure 11 Plot of Lower Band Edge (ANT-Mode 1)




Figure 12 Plot of Lower Band Edge (BT GFSK-Mode 2)




Figure 13 Plot of Lower Band Edge (BLE-Mode 3)




Figure 14 Plot of Lower Band Edge (802.11 b-mode)




Figure 15 Plot of Lower Band Edge (802.11 g-mode)




Figure 16 Plot of Lower Band Edge (802.11 n-mode)




Figure 17 Plot of Upper Band Edge (ANT-Mode 1)




Figure 18 Plot of Upper Band Edge (BT GFSK-Mode 2)




Figure 19 Plot of Upper Band Edge (BLE-Mode 3)




Figure 20 Plot of Upper Band Edge (802.11 b-mode)




Figure 21 Plot of Upper Band Edge (802.11 g-mode)




Figure 22 Plot of Upper Band Edge (802.11 n-mode)




Figure 24 Plot of Transmitter 99% Occupied Bandwidth (ANT-Mode 1)




Figure 25 Plot of Transmitter 6-dB Occupied Bandwidth (BT GFSK-Mode 2)




Figure 26 Plot of Transmitter 99% Occupied Bandwidth (BT GFSK-Mode 2)

Figure 27 Plot of Transmitter 6-dB Occupied Bandwidth (BLE-Mode 3)




Figure 28 Plot of Transmitter 99% Occupied Bandwidth (BLE-Mode 3)




Figure 29 Plot of Transmitter 6-dB Occupied Bandwidth (802.11 b-mode)




Figure 30 Plot of Transmitter 99% Occupied Bandwidth (802.11 b-mode)




Figure 31 Plot of Transmitter 6-dB Occupied Bandwidth (802.11 g-mode)




Figure 32 Plot of Transmitter 99% Occupied Bandwidth (802.11 g-mode)




Figure 33 Plot of Transmitter 6-dB Occupied Bandwidth (802.11 n-mode)




Figure 34 Plot of Transmitter 99% Occupied Bandwidth (802.11 n-mode)




Figure 35 Plot of Transmitter Power Spectral Density (ANT-Mode 1)




Figure 36 Plot of Transmitter Power Spectral Density (BT GFSK-Mode 2)




Figure 37 Plot of Transmitter Power Spectral Density (BLE-Mode 3)




Figure 38 Plot of Transmitter Power Spectral Density (802.11 b-mode)





Figure 39 Plot of Transmitter Power Spectral Density (802.11 g-mode)
