1 MPE EVALUATION OF MOBILE DEVICES

MPE evaluation is as below formula

Wi-Fi 2.4GHz + ANT

MPE Evaluation = 0.02 / 1 + 0.00000002 / 1 = 0.02

Bluetooth + ANT

MPE Evaluation = 0.008 / 1 + 0.00000002 / 1 = 0.008
