Equipment Function and Configuration

The EUT is a marine mounted GPS enabled display for use in the maritime environment. The design incorporates transmitters with operation capability across the 2402-2480 MHz frequency band. This design provides communications operation in two modes across the 2402-2480 MHz band. The unit provides low power transmitter function across the 2402-2480 MHz band as well as higher power Digital Transmission System (DTS) operating across reduced frequency band of 2412-2462 MHz. The DTS system provides peak output power of 49 mW (16.9 dBm) into the antenna system. The design provides wireless communications interface capabilities with compatible equipment. The design is offered in multiple display sizes utilizing electrically identical transmitter circuity. The product operates from external direct current power only and offers no provision to interface with utility power systems. The design utilizes internal fixed antenna systems and offers no provision for antenna replacement or modification. Two samples were provided for testing, one representative of production design with integral antenna, and the other modified replacing the integral antenna with RF connection port for testing purposes. Test samples were provided with test software(version icb_fw: ver 1.10) enabling testing personnel the ability to enable transmitter functions on defined channels and operational modes. The antenna modification offered testing facility ability to connect test equipment to the temporary antenna port for antenna port conducted emission testing. The EUT was arranged as described by the manufacturer for testing purposes. The design provides interface options including connection to transducers providing below surface depth and other information, marine network interfaces, NMEA network interface, micro USB, audio, composite and HDMI video interfaces, and power. The EUT offers no other interface connections than those in the configuration option shown below as described by the manufacturer. For testing purposes, the EUT received power from a bench DC power supply and configured to operate in available modes. As requested by the manufacturer and required by regulations, the equipment was tested for emissions compliance using the available configurations with the worst-case data presented. Test results in this report relate only to the products described in this report.



Applicable Standards & Test Procedures

In accordance with the e-CFR Code of Federal Regulations Title 47, dated September 4, 2018: Part 2, Subpart J, Paragraphs 2.907, 2.911, 2.913, 2.925, 2.926, 2.1031 through 2.1057, and applicable parts of paragraph 15, Part 15C Paragraph 15.249, Industry Canada RSS-210 Issue 9, and RSS-GEN Issue 5 operation in the 2400 – 2483.5 MHz Frequency band. Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.10-2013.

Testing Procedures

AC Line Conducted Emission Test Procedure

The EUT operates on direct current power only provided by the vehicle installation. Therefore, no AC line conducted emission testing was required or performed.

Radiated Emission Test Procedure

Radiated emissions testing was performed as required in 47 CFR 15C, RSS-210 and specified in ANSI C63.10-2013. The EUT was placed on a rotating 0.9 x 1.2-meter platform, elevated as required above the ground plane at a distance of 3 meters from the FSM antenna. EMI energy was maximized by equipment placement permitting orientation in three orthogonal axes, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken and recorded. The frequency spectrum from 9 kHz to 25,000 MHz was searched for emissions during preliminary investigation. Refer to diagrams one and two showing typical test setup. Refer to photographs in the test setup exhibits for specific EUT placement during testing.




- 1—A LISN is optional for radiated measurements between 30 MHz and 1000 MHz but not allowed for measurements below 30 MHz and above 1000 MHz (see 6.3.1). If used, then connect EUT to one LISN. Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.10-2013 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values take into account the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

General Radiated Emissions Procedure

The EUT was arranged in typical equipment configurations and operated through available modes during testing. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated measurements were performed. Final data was taken with the EUT located at the OATS at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Loop from 9 kHz to 30 MHz, Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers above 1 GHz, notch filters and appropriate amplifiers and external mixers were utilized.

Operation in the Band 2400 – 2483.5 MHz

The transmitter output power; harmonic and general emissions were measured on an open area test site @ 3 meters. The EUT was placed on a turntable elevated as required above the ground plane and at a distance of 3 meters from the FSM antenna. The peak and quasi-peak amplitude of frequencies below 1000 MHz were measured using a spectrum analyzer. The peak and average amplitude of frequencies above 1000 MHz were measured using a spectrum analyzer. The amplitude of each emission was then recorded from the analyzer display. Emissions radiated outside of the specified bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits, whichever is the lesser attenuation. 


Figure 1 Plot of Transmitter Emissions Operation in 2402-2480 MHz (GFSK)




Figure 2 Plot of Transmitter Emissions Operation in 2402-2480 MHz (GMSK)




Figure 3 Plot of Transmitter Emissions 99% Occupied Bandwidth (GFSK)




Figure 4 Plot of Transmitter Emissions 99% Occupied Bandwidth (GMSK)




Figure 5 Plot of Transmitter Emissions Low Band Edge (GFSK)




Figure 6 Plot of Transmitter Emissions Low Band Edge (GMSK)




Figure 7 Plot of Transmitter Emissions High Band Edge (GFSK)




Figure 8 Plot of Transmitter Emissions High Band Edge (GMSK)
