#### **Equipment Function**

The EUT is a marine mounted GPS enabled device for use in the maritime environment. The design incorporates interface ports for use with wired devices as well as transmitters providing operation capability across the 2402-2480 MHz frequency band. This design provides communications operation in two modes across the 2402-2480 MHz band. The unit provides transmitter function across the 2402-2480 MHz band in mode 1 utilizing GFSK and GMSK modulations. The design also provides transmitter function across the 2412-2462 MHz band in mode 2 using 802.11b/g/n modulations. Operations of the design comply with Digital Transmission System requirements (DTS). The DTS system provides peak output power of 44 mW (16.45 dBm) into the antenna system. The design requires external display to provide user display. The product operates from external direct current power only and offers no provision to interface with utility power systems. The design utilizes internal fixed antenna systems and offers no provision for antenna replacement or modification. Two samples were provided for testing, one representative of production design with integral antenna, and the other modified replacing the integral antenna with RF connection ports for testing purposes. Test samples were provided with test software (icb\_fw: ver 2.50) enabling testing personnel the ability to enable transmitter functions on defined channels and operational modes. The antenna modification offered testing facility ability to connect test equipment to the temporary antenna port for antenna port conducted emission testing. The EUT was arranged as described by the manufacturer for testing purposes. The design provides interface options including connection to marine network interfaces, NMEA 0183, NMEA 2000, J1939 interface, micro USB, CVBS input, HDMI video in/out interfaces, and power. Garmin Remote Interface Devices (GRID) were attached to the marine Network ports. The EUT offers no other interface connections than those in the configuration option shown below as described by the manufacturer. For testing purposes, the EUT received power from a bench DC power supply and configured to operate in available modes. As requested by the manufacturer and required by regulations, the equipment was tested for emissions compliance using the available configurations with the worst-case data presented. Test results in this report relate only to the products described in this report.



#### **Applicable Standards & Test Procedures**

The following information is submitted in accordance with the eCFR Federal Communications Code of Federal Regulations, dated September 5, 2018, Part 2, Subpart J, Paragraphs 2.907, 2.911, 2.913, 2.925, 2.926, 2.1031 through 2.1057, and applicable parts of paragraph 15, Part 15C Paragraph 15.247, and Industry Canada RSS-GEN Issue 5, and RSS-247 Issue 2. Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.10-2013. This report documents compliance for the EUT operations as Digital Transmission system equipment.

#### **Testing Procedures**

#### AC Line Conducted Emission Test Procedure

The EUT operates on direct current power only provided by the vehicle installation. Therefore, no AC line conducted emission testing was required or performed.

#### Radiated Emission Test Procedure

Radiated emissions testing was performed as required in 47 CFR 15, RSS-247 and specified in ANSI C63.10-2013. The EUT was placed on a rotating 0.9 x 1.2-meter platform, elevated as required above the ground plane at a distance of 3 meters from the FSM antenna. EMI energy was maximized by equipment placement permitting orientation in three orthogonal axes, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. The frequency spectrum from 9 kHz to 25,000 MHz was searched for during preliminary investigation. Refer to diagrams one and two showing typical test arrangement and photographs in the test setup exhibits for specific EUT placement during testing.

#### Antenna Port Conducted Emission Test Procedure

The EUT was assembled as required for operation placed on a benchtop. This configuration provided the ability to connect test equipment to the provided test antenna port. Antenna Port conducted emissions testing was performed presented in the regulations and specified in ANSI C63. 26-2015. Testing was completed on a laboratory bench in a shielded room. The active antenna port of the device was connected to appropriate attenuation and the spectrum analyzer. Refer to diagram three showing typical test arrangement and photographs in the test setup exhibits for specific EUT placement during testing.



- 1—A LISN is optional for radiated measurements between 30 MHz and 1000 MHz but not allowed for measurements below 30 MHz and above 1000 MHz (see 6.3.1). If used, then connect EUT to one LISN. Unused LISN measuring port connectors shall be terminated in 50  $\Omega$  loads. The LISN may be placed on top of, or immediately beneath, the reference ground plane (see 6.2.2 and 6.2.3.2).
- 1.1—LISN spaced at least 80 cm from the nearest part of the EUT chassis.


#### Diagram 1 Test arrangement for radiated emissions of tabletop equipment

#### Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.10-2013 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values consider the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

#### **Summary of Results for Radiated Emissions in Restricted Bands**

The EUT worst-case operation mode demonstrated a minimum radiated emission margin of -0.4 dB below the requirements in restricted frequency bands. Peak, Quasi-peak, and average amplitudes were checked for compliance with the regulations. #### General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available mode during testing. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated measurements were performed. Final data was taken with the EUT located on the OATS at 3 meters distance between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Loop from 9 kHz to 30 MHz, Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers above 1 GHz, notch filters and appropriate amplifiers and external mixers were utilized.

#### Operation in the Band 2400 - 2483.5 MHz

Test procedures of ANSI C63.10-2013 and KDB 558074 v05 were used during transmitter testing. Test sample #2 was provided for testing antenna port conducted emissions. This sample was modified by replacing the internal antenna with a 50-ohm antenna port connector and attenuator for testing purposes. The transmitter peak and average power was measured at the antenna port using a wideband RF power meter as described in KDB 558074 and C63.10-2013. The peak Power Spectral Density (PKPSD) was measured as defined in KDB 558074 and C63.10-2013. DTS Emission bandwidth was measured as described in KDB 558074 and C63.10-2013. The amplitude of each harmonic and general radiated emission was measured on the OATS at distance of 3 meters from the FSM antenna (radiated emission testing was performed on sample #1 representative of production equipment with integral antenna). The EUT was positioned on supporting turntable elevated as required above the ground plane, at a distance of 3 meters from the FSM antenna. Radiated emission investigations were performed from 9 kHz to 25,000 MHz. Each radiated emission was maximized by varying the FSM antenna height and polarization, and by rotating the turntable. The worst-case amplitude of each emission was then recorded from the analyzer display. The peak and quasi-peak amplitude of frequencies below 1000 MHz were measured using a spectrum analyzer. The peak and average amplitude of frequencies above 1000 MHZ were measured using a spectrum analyzer. A Loop antenna was used for measuring emissions from 0.009 to 30 MHz, Biconilog Antenna for 30 to 1000 MHz, Double-Ridge, and/or Pyramidal Horn Antennas from 1 GHz to 25 GHz. Radiated Emissions were measured in dBµV/m @ 3 meters. Plots were taken of transmitter performance (using sample #2) for reference in this and other documentation.




Figure 1 Plot of Transmitter Emissions Operation in 2402-2480 MHz (GFSK)




Figure 2 Plot of Transmitter Emissions Operation in 2402-2480 MHz (GMSK)




Figure 3 Plot of Transmitter Emissions in Operational Frequency (802.11 b-Mode)




Figure 4 Plot of Transmitter Emissions in Operational Frequency (802.11 g-Mode)




Figure 5 Plot of Transmitter Emissions in Operational Frequency (802.11 n-Mode)




Figure 6 Plot of Transmitter Emissions Low Band Edge (GFSK)




Figure 7 Plot of Transmitter Emissions Low Band Edge (GMSK)




Figure 9 Plot of Lower Band Edge (802.11 g-mode)




Figure 10 Plot of Lower Band Edge (802.11 n-mode)




Figure 11 Plot of Transmitter Emissions High Band Edge (GFSK)




Figure 12 Plot of Transmitter Emissions High Band Edge (GMSK)




Figure 13 Plot of Upper Band Edge (802.11 b-mode)




Figure 14 Plot of Upper Band Edge (802.11 g-mode)




Figure 15 Plot of Upper Band Edge (802.11 n-mode)




Figure 16 Plot of Transmitter Emissions 6-dB Occupied Bandwidth (GFSK)




Figure 17 Plot of Transmitter Emissions 99% Occupied Bandwidth (GFSK)




Figure 18 Plot of Transmitter Emissions 6-dB Occupied Bandwidth (GMSK)

Figure 19 Plot of Transmitter Emissions 99% Occupied Bandwidth (GMSK)




Figure 20 Plot of Transmitter 6-dB Occupied Bandwidth (802.11 b-mode)




Figure 21 Plot of Transmitter 99% Occupied Bandwidth (802.11 b-mode)




Figure 22 Plot of Transmitter 6-dB Occupied Bandwidth (802.11 g-mode)




Figure 23 Plot of Transmitter 99% Occupied Bandwidth (802.11 g-mode)




Figure 24 Plot of Transmitter 6-dB Occupied Bandwidth (802.11 n-mode)




Figure 25 Plot of Transmitter 99% Occupied Bandwidth (802.11 n-mode)




Figure 26 Plot of Transmitter Power Spectral Density (GFSK)




Figure 27 Plot of Transmitter Power Spectral Density (GMSK)




Figure 28 Plot of Transmitter Power Spectral Density (802.11 b-mode)




Figure 29 Plot of Transmitter Power Spectral Density (802.11 g-mode)




Figure 30 Plot of Transmitter Power Spectral Density (802.11 n-mode)

#### **Summary of Results for Transmitter Radiated Emissions of Intentional Radiator**
