






Figure 1 - Peak Output Power Measurements Test Setup




Figure 2 – Output Power, Low Channel, BT BR (GFSK)




Figure 3 – Output Power, Mid Channel, BT BR (GFSK)




Figure 4 – Output Power, High Channel, BT BR (GFSK)




Figure 5 - Output Power, Low Channel, BT EDR 2MB




Figure 6 - Output Power, Mid Channel, BT EDR 2MB




Figure 7 - Output Power, High Channel, BT EDR 2MB




Figure 8 – Output Power, Low Channel, BT EDR 3MB




Figure 9 - Output Power, Mid Channel, BT EDR 3MB





Figure 10 – Output Power, High Channel, BT EDR 3MB

4.3 **BANDWIDTH**

Test Method: ANSI C63.10,

1. Section(s) 11.8.1 "DTS Bandwidth, Option 1"

Limits of bandwidth measurements:

The 99% occupied bandwidth is displayed.

The 6dB bandwidth of the signal must be greater than 500 kHz.

Test procedures:

The EUT was connected to the spectrum analyzer directly with a low-loss shielded coaxial cable. The bandwidth of the fundamental frequency was measured by spectrum analyzer with 100 kHz RBW and 300 kHz VBW.

The 99% occupied is defined as the bandwidth at which 99% of the signal power is found. This corresponds to 20dB down from the maximum power level. The maximum power was measured with the largest resolution bandwidth possible (10MHz) and this value was recorded. The signal was then captured with a 1 MHz resolution bandwidth and the frequencies where the measurements were 20dB below the maximum power were marked. The bandwidth between these frequencies was recorded as the 99% occupied bandwidth.

The 6 dB bandwidth is defined as the bandwidth of which is higher than peak power minus 6dB.

For peak output power measurements, the EUT was connected to the spectrum analyzer directly with a low-loss shielded coaxial cable with 3 MHz RBW and 10 MHz VBW.




Figure 11 - Peak Output Power Measurements Test Setup




Figure 12 – Occupied Bandwidth, Low Channel, BT BR (GFSK)





Figure 13 - Occupied Bandwidth, Mid Channel, BT BR (GFSK)




Figure 14 - Occupied Bandwidth, High Channel, BT BR (GFSK)




Figure 15 - Occupied Bandwidth, Low Channel, BT EDR 2MB





Figure 16 - Occupied Bandwidth, Mid Channel, BT EDR 2MB




Figure 17 - Occupied Bandwidth, High Channel, BT EDR 2MB




Figure 18 - Occupied Bandwidth, Low Channel, BT EDR 3MB





Figure 19 - Occupied Bandwidth, Mid Channel, BT EDR 3MB




Figure 20 - Occupied Bandwidth, High Channel, BT EDR 3MB




Figure 21 – 6dB Bandwidth, Low Channel, BT BR (GFSK)





Figure 22 – 6dB Bandwidth, Mid Channel, BT BR (GFSK)




Figure 23 – 6dB Bandwidth, High Channel, BT BR (GFSK)





Figure 24 – 6dB Bandwidth, Low Channel, BT EDR 2MB




Figure 25 – 6dB Bandwidth, Mid Channel, BT EDR 2MB




Figure 26 - 6dB Bandwidth, High Channel, BT EDR 2MB




Figure 27 – 6dB Bandwidth, Low Channel, BT EDR 3MB




Figure 28 – 6dB Bandwidth, Mid Channel, BT EDR 3MB




Figure 29 - 6dB Bandwidth, High Channel, BT EDR 3MB

4.4 RADIATED EMISSIONS

Test Method: ANSI C63.10:2013:

- 1. Section 6.5, "Radiated emissions from unlicensed wireless devices in the frequency range of 30 MHz to 1000 MHz"
- 2. Section 6.6, "Radiated emissions from unlicensed wireless devices above 1 GHz"
- 3. Section 11.11, "Measurement in nonrestricted frequency bands"
- 4. Section 11.12, "Emissions in restricted bands"

Limits for radiated emissions measurements:

Emissions radiated outside of the specified bands shall be applied to the limits in 15.209 as followed:

Note about requirement from FCC Part 15.247(d) and RSS-247, Section 5.5:

In addition to the limits shown above, all emissions were also required to be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power. All measurements were performed with a 1 MHz bandwidth, but the bandwidth conversion from 1 MHz to 100 kHz would be equally applied to the highest emission and the spurious emissions, so it would not effect the delta measurement.

Since the fundamental emissions was at least 20 dB over the spurious emissions limtis from 15.209 and all spurious emissions were below the 15.209 limit, this requirement was met.

NOTE:

- 1. The lower limit shall apply at the transition frequencies.
- 2. Emission level (dBuV/m) = 20 * log * Emission level (μ V/m).
- 3. As shown in 15.35(b), for frequencies above 1000MHz, the field strength limits are based on average detector, however, the peak field strength of any emission shall not exceed the maximum permitted average limits by more than 20dB under any condition of modulation.

Test procedures:

- a. The EUT was placed on the top of a rotating table above the ground plane in a 10 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation. The table was 0.8m high for measurements form 30MHz-1Ghz and 1.5m for measurements from 1GHz and higher.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna was a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are used to make the measurement.
- d. For each suspected emission, the EUT was arranged to maximize its emissions and then the antenna height was varied from 1 meter to 4 meters and the rotating table was turned from 0 degrees to 360 degrees to find the maximum emission reading.
- e. The test-receiver system was set to use a peak detector with a specified resolution bandwidth. For spectrum analyzer measurements, the composite maximum of several analyzer sweeps was used for final measurements.
- f. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- g. The EUT was maximized in all 3 orthogonal positions. The results are presented for the axis that had the highest emissions.
- h. Intermodulation products were investigated by measuring spurious emissions with all three transmitters continuously transmitting. No intermodulation products were found above the labs system sensitivity.




Figure 30 - Radiated Emissions Test Setup




Figure 31 - Radiated Emissions Plot, Receive




Figure 32 - Radiated Emissions Plot, BT BR (GFSK)






Figure 33 - Radiated Emissions Plot, BT EDR 2MB






Figure 34 - Radiated Emissions Plot, BT EDR 3MB




Figure 35 - Power Spectral Density, Low Channel, BT BR (GFSK)




Figure 36 - Power Spectral Density, Mid Channel, BT BR (GFSK)





Figure 37 - Power Spectral Density, High Channel, BT BR (GFSK)





Figure 38 - Power Spectral Density, Low Channel, BT EDR 2MB




Figure 39 - Power Spectral Density, Mid Channel, BT EDR 2MB




Figure 40 - Power Spectral Density, High Channel, BT EDR 2MB




Figure 41 - Power Spectral Density, Low Channel, BT EDR 3MB





Figure 42 - Power Spectral Density, Mid Channel, BT EDR 3MB




Figure 43 - Power Spectral Density, High Channel, BT EDR 3MB

4.6 BAND EDGES

Test Method: ANSI C63.10-2013, Section(s) 6.10.5

Limits of bandedge measurements:

For emissions outside of the allowed band of operation, the emission level needs to be 20dB under the maximum fundamental field strength. However, if the emissions fall within one of the restricted bands from 15.205 the field strength levels need to be under that of the limits in 15.209.

Test procedures:

Measurements were performed by connecting the output of the transmitter directly into a spectrum analyzer using an impedance matched cable and connector soldered to the EUT in place of the antenna. The resolution bandwidth was set to 100kHz and the EMI receiver was used to scan from the bandedge to the fundamental frequency with a peak detector. The highest emissions level beyond the bandedge was measured and recorded. All band edge measurements were evaluated to the general limits in Part 15.209.

To calculate the level at the bandedge frequencies, the difference between the peak and the band edge level was subtracted from the peak radiated value at the fundamental. This value was compared to the 15.209 radiated limits for compliance.

No deviation.

The field strength was measured by connecting the EUT directly to the spectrum analyzer.




Figure 44 - Band-edge Measurement, Low Channel, Restricted Frequency, Peak





Figure 45 - Band-edge Measurement, Low Channel, Fundamental, Peak




Figure 46 - Band-edge Measurement, High Channel, Restricted Frequency, Peak




Figure 47 - Band-edge Measurement, High Channel, Fundamental, Peak






Figure 48 - Band-edge Measurement, Low Channel, Restricted Frequency, Peak





Figure 49 - Band-edge Measurement, Low Channel, Fundamental, Peak





Figure 50 - Band-edge Measurement, High Channel, Restricted Frequency, Peak




Figure 51 - Band-edge Measurement, High Channel, Fundamental, Peak






Figure 52 - Band-edge Measurement, Low Channel, Restricted Frequency, Peak





Figure 53 - Band-edge Measurement, Low Channel, Fundamental, Peak





Figure 54 - Band-edge Measurement, High Channel, Restricted Frequency, Peak




Figure 55 - Band-edge Measurement, High Channel, Fundamental, Peak






Figure 57 - Conducted Emissions Plot, Neutral

APPENDIX A: SAMPLE CALCULATION

Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF - (-CF + AG) + AV$$

where FS = Field Strength

RA = Receiver Amplitude

AF = Antenna Factor

CF = Cable Attenuation Factor

AG = Amplifier Gain

AV = Averaging Factor (if applicable)

Assume a receiver reading of 55 dB μ V is obtained. The Antenna Factor of 12 and a Cable Factor of 1.1 is added. The Amplifier Gain of 20 dB is subtracted, giving a field strength of 48.1 dB μ V/m.

$$FS = 55 + 12 - (-1.1 + 20) + 0 = 48.1 \text{ dB}\mu\text{V/m}$$

The 48.1 dB_μV/m value can be mathematically converted to its corresponding level in μV/m.

Level in $\mu V/m = Common Antilogarithm [(48.1 dB<math>\mu V/m)/20] = 254.1 \mu V/m$

AV is calculated by the taking the $20*log(T_{on}/100)$ where T_{on} is the maximum transmission time in any 100ms window.
